That § 22.1-279.3:1 of the Code of Virginia is amended and reenacted as follows: § 22.1-279.3:1. Reports of certain acts to school authorities. 11 12 A. Reports shall be made to the principal or his designee on all incidents involving (i) the assault or 13 assault and battery, without bodily injury, of any person on a school bus, on school property, or at a school-sponsored activity; (ii) the assault and battery which results in bodily injury, sexual assault, 14 15 death, shooting, stabbing, cutting, or wounding of any person on a school bus, on school property, or at 16 a school-sponsored activity; (iii) any conduct involving alcohol, marijuana, a controlled substance, imitation controlled substance, or an anabolic steroid on a school bus, on school property, or at a 17 18 school-sponsored activity, including the theft or attempted theft of student prescription medications; (iv) 19 any threats against [school personnel any person] while on a school bus, on school property or at a 20 school-sponsored activity; (v) the illegal carrying of a firearm, as defined in § 22.1-277.07, onto school 21 property; (vi) any illegal conduct involving firebombs, explosive materials or devices, or hoax explosive 22 devices, as defined in § 18.2-85, or explosive or incendiary devices, as defined in § 18.2-433.1, or chemical bombs, as described in § 18.2-87.1, on a school bus, on school property, or at a 23 school-sponsored activity; or (vii) any threats or false threats to bomb, as described in § 18.2-83, made 24 25 against school personnel or involving school property or school buses. B. Notwithstanding the provisions of Article 12 (§ 16.1-299 et seq.) of Chapter 11 of Title 16.1, 26 27 local law-enforcement authorities may report, and the principal or his designee may receive such reports, 28 on offenses, wherever committed, by students enrolled at the school if the offense would be a felony if 29 committed by an adult or would be a violation of the Drug Control Act (§ 54.1-3400 et seq.) and 30 occurred on a school bus, on school property, or at a school-sponsored activity, or would be an adult 31 misdemeanor involving any incidents described in clauses (i) through (v) of subsection A. 32 C. The principal or his designee shall submit a report of all incidents required or authorized to be 33 reported pursuant to this section to the superintendent of the school division. The division superintendent shall annually report all such incidents to the Department of Education for the purpose of recording the 34 35 frequency of such incidents on forms that shall be provided by the Department and shall make such 36 information available to the public. A division superintendent who knowingly fails to comply or secure 37 compliance with the reporting requirements of this subsection shall be subject to the sanctions authorized 38 in § 22.1-65. A principal who knowingly fails to comply or secure compliance with the reporting 39 requirements of this section shall be subject to sanctions prescribed by the local school board, which may include, but need not be limited to, demotion or dismissal. 40 41 The principal or his designee shall also notify the parent of any student involved in an incident required by subsection A or authorized by subsection B to be reported, regardless of whether 42 disciplinary action is taken against such student or the nature of the disciplinary action. Such notice shall 43 44 relate to only the relevant student's involvement and shall not include information concerning other students. 46 Whenever any student commits any reportable incident as set forth in this section, such student shall 47 be required to participate in such prevention and intervention activities as deemed appropriate by the 48 superintendent or his designee. Prevention and intervention activities shall be identified in the local 49 school division's drug and violence prevention plans developed pursuant to the federal Improving 50 America's Schools Act of 1994 (Title IV - Safe and Drug-Free Schools and Communities Act).

51 D. Except as may otherwise be required by federal law, regulation, or jurisprudence, the principal 52 shall immediately report to the local law-enforcement agency any act enumerated in clauses (ii) through 53 (vii) of subsection A that may constitute a criminal offense and may report to the local law-enforcement agency any incident described in clause (i) of subsection A. 54

55 E. A statement providing a procedure and the purpose for the requirements of this section shall be included in the policy manual of all school divisions. 56

The Board of Education shall promulgate regulations to implement this section, including, but not 57 58 limited to, establishing reporting dates and report formats.

F. For the purposes of this section, "parent" or "parents" means any parent, guardian or other person 59 60

having control or charge of a child. G. This section shall not be construed to diminish the authority of the Board of Education or to diminish the Governor's authority to coordinate and provide policy direction on official communications between the Commonwealth and the United States government. 61 62 63
