70 whole number, the presiding officers of each house shall appoint a committee of four, which together
71 shall constitute the joint committee to count the vote of each house in each case and report the results to
72 their respective houses. The joint order may be suspended by the presiding officer of either house at any
73 time but for no longer than 24 hours to receive the report of the joint committee.
