12 **Be it enacted by the General Assembly of Virginia:**13 **1. That Chapter 323 of the Acts of Assembly of 1950 is amended by adding a section numbered**
14 **5.02.1 as follows:**15 *§ 5.02.1. Powers with respect to city personnel.*

16 *Except for the city attorney, city clerk and their employees, the city manager may appoint or employ*
17 *and may remove or discharge city officers, employees and assistants as may be necessary to carry on*
18 *the work in those departments and offices of the City as deemed necessary by the city manager. The city*
19 *manager shall have the authority to manage, organize and reorganize all city employees under the*
20 *control of the city manager. Whenever the interests of the City require, irrespective of any other*
21 *provisions of this charter, the city manager shall have the power and authority to assign employees of*
22 *any city department, bureau, office or agency under the control of the city manager, to the temporary*
23 *performance of duties in another city department, bureau, office or agency. The city manager may not*
24 *remove or discharge city council appointive officers. The salaries and conditions of employment of*
25 *employees and assistants shall be recommended by the city manager subject to the approval of the city*
26 *council and as provided by the general law. The city manager's actions in all respects shall be subject*
27 *to review by the city council and shall be accountable to city council.*
