9	Be it enacted by the General Assembly of Virginia:
10	1. That §§ 24.2-701 and 24.2-706 of the Code of Virginia are amended and reenacted as follows:
11	§ 24.2-701. Application for absentee ballot.
12	A. The State Board shall furnish each general registrar with a sufficient number of applications for
13	official absentee ballots. The registrars shall furnish applications to persons requesting them.
14	Beginning with the general election in November 1999, the The State Board shall implement a
15	system that enables eligible persons to request and receive an absentee ballot application electronically
16	through the global information system known as the Internet. Electronic absentee ballot applications
17	shall be in a form approved by the State Board.
18	Except as provided in § 24.2-703, a separate application shall be completed for each election in
19	which the applicant offers to vote. An application for an absentee ballot may be accepted the later of (i)
20	12 months before an election, or (ii) the day following any election held in the twelfth month prior to
20 21	the election in which the applicant is applying to vote.
²¹ 22	
	Any application received before the ballots are printed shall be held and processed as soon as the
23	printed ballots for the election are available.
24	For the purposes of this chapter, the general registrar's office shall be open a minimum of eight
25	hours between the hours of 8:00 a.m. and 5:00 p.m. on the first and second Saturday immediately
26	preceding all general elections, except May general elections held in towns, and on the Saturday
27	immediately preceding any primary election, May general election held in a town, or special election.
28	Unless physically disabled, all applications for absentee ballots shall be signed by the applicant who
29	shall state, subject to felony penalties for making false statements pursuant to § 24.2-1016, that to the
30	best of his knowledge and belief the facts contained in the application are true and correct and that he
31	has not and will not vote in the election at any other place in Virginia or in any other state. If the
32	applicant is unable to sign the application, a person assisting the applicant will note this fact on the
33	applicant signature line and provide his signature, name, and address.
34	B. Applications for absentee ballots shall be completed in the following manner:
35	1. An application completed in person shall be made not less than three days prior to the election in
36	which the applicant offers to vote and completed only in the office of the general registrar. The
37	applicant shall sign the application in the presence of a registrar or a member of the electoral board. The
38	applicant shall provide one of the forms of identification specified in subsection B of § 24.2-643, or if
39	he is unable to present one of the forms of identification spectric in that section, he shall sign a statement,
40	subject to felony penalties for making false statements pursuant to § 24.2-1016, that he is the named
41	
	registered voter who he claims to be. An applicant who requires assistance in voting by reason of
42	physical disability or inability to read or write may request assistance pursuant to § 24.2-649 and be
43	assisted in preparation of this statement in accordance with that section. The provisions of § 24.2-649
44	regarding persons who are unable to sign shall be followed when assisting an applicant in completing
45	this statement.
46	2. Any other application may be made by mail, electronic or telephonic transmission to a facsimile
47	device if one is available to the office of the general registrar or the office of the State Board if a
48	device is not available locally, or other means. The application shall be on a form furnished by the
49	registrar or, if made under subdivision 2 of § 24.2-700, may be on a Federal Post Card Application
50	prescribed pursuant to 42 U.S.C. § 1973ff (b) (2). The Federal Post Card Application may be accepted
51	the later of (i) 12 months before an election, or (ii) the day following any election held in the twelfth
52	month prior to the election in which the applicant is applying to vote. The application shall be made to
53	the appropriate registrar not less than five days prior to the election in which the applicant offers to
54	vote.

56 online tool allowing submission of absentee ballot applications to local registrars. Upon completion of 57 the form available on the official State Board website and based on the county or city of residence as 58 declared by the applicant, the information shall be automatically, electronically transmitted directly to 59 the indicated local registrar by e-mail. The online application shall contain all the fields of information 60 required by law for an absentee ballot application except for the signature requirement. The online 61 application shall include a mandatory field for the e-mail address of the person submitting the 62 application. In lieu of the signature requirement, the online application shall include a field for the applicant to indicate (i) that to the best of his knowledge and belief the facts contained in the 63 application are true and correct, (ii) that the applicant has not and will not vote in the election at any 64 other place in Virginia or any other jurisdiction, (iii) that the person completing the absentee ballot 65 application is the applicant for whom it is being completed unless the assisted voter section of the 66 application is completed, and (iv) that the applicant has provided the facts and information on the 67 68 application subject to felony penalties for making false statements pursuant to § 24.2-1016. The application shall be made through the State Board website directly to the appropriate registrar not less 69 than five days prior to the election in which the applicant offers to vote. Upon submission of the 70 completed online application to the registrar, the State Board website shall automatically generate an 71 72 e-mail to the applicant confirming the receipt of the application and the fact that it has been submitted 73 to the appropriate local registrar. The State Board shall not store nor retain the application information 74 in any manner [except as required to complete the submission process].

C. Applications for absentee ballots shall contain the following information:

1. The applicant's printed name and the reason the applicant will be absent or cannot vote at hispolling place on the day of the election;

2. A statement that he is registered in the county or city in which he offers to vote and his residence address in such county or city. Any person temporarily residing outside the United States shall provide the last date of residency at his Virginia residence address, if that residence is no longer available to him. Any person who makes application under subdivision 2 of § 24.2-700 who is not a registered voter may file the applications to register and for a ballot simultaneously, *unless the application for an absentee ballot is made pursuant to subdivision B 3 of this section*;

3. The complete address to which the ballot is to be sent directly to the applicant, unless the application is made in person at a time when the printed ballots for the election are available and the applicant chooses to vote in person at the time of completing his application. The address given shall be either the address of the applicant on file in the registration records or the address at which he will be located while absent from his county or city. No ballot shall be sent to, or in care of, any other person; and

4. In the case of a person, or the spouse or dependent of a person, who is on active service as a
member of the armed forces of the United States or a member of the merchant marine of the United
States, the branch of service to which he or the spouse belongs, and his or the spouse's rank, grade, or
rate, and service identification number; or

5. In the case of a student, or the spouse of a student, who is attending a school or institution of learning, the name and address of the school or institution of learning; or

6. In the case of a person who is unable to go in person to the polls on the day of the electionbecause of a physical disability or physical illness, the nature of the illness or disability; or

7. In the case of a person who is confined awaiting trial or for having been convicted of a misdemeanor, the name and address of the institution of confinement; or

8. In the case of a person who will be absent on election day for business reasons, the name of hisemployer or business; or

9. In the case of a person who will be absent on election day for personal business or vacationreasons, the name of the county or city in Virginia or the state or country to which he is traveling; or

104 10. In the case of a person who is unable to go to the polls on the day of election because he is 105 primarily and personally responsible for the care of an ill or disabled family member who is confined at 106 home, the name of the family member and the nature of his illness or disability; or

107 11. In the case of a person who is unable to go to the polls on the day of election because of an108 obligation occasioned by his religion, his religion and the nature of the obligation; or

109 12. In the case of a person who, in the regular and orderly course of his business, profession, or 110 occupation, will be at his place of work and commuting to and from his home to his place of work for 111 11 or more hours of the 13 hours that the polls are open pursuant to § 24.2-603, the name of his 112 business or employer, address of his place of work, and hours he will be at the workplace and 113 commuting on election day.

\$ 24.2-706. Duty of general registrar and electoral board on receipt of application; statement of voter.
On receipt of an application for an absentee ballot, the general registrar shall enroll the name and address of each registered applicant on an absentee voter applicant list that shall be maintained in the office of the general registrar with a file of the applications of the listed applicants. The list and the

applications shall be available for inspection and copying by any registered voter during regular officehours.

No list or application containing an individual's social security number shall be made available for
 inspection or copying by anyone. The State Board of Elections shall prescribe procedures for local
 electoral boards and general registrars to make the information in the lists and applications available in a
 manner that does not reveal social security numbers.

124 The completion and timely delivery of an application for an absentee ballot shall be construed to be 125 an offer by the applicant to vote in the election.

126 The general registrar shall note on each application received whether the applicant is or is not a 127 registered voter and notify the secretary of the electoral board. In reviewing the application for an 128 absentee ballot, the general registrar and electoral board shall not reject the application of any individual 129 because of an error or omission on any record or paper relating to the application, if such error or 130 omission is not material in determining whether such individual is qualified to vote absentee.

131 If the application has been properly completed and *either* signed *or submitted electronically to the* 132 State Board official website pursuant subdivision B 3 of § 24.2-701 and the applicant is a registered 133 voter of the precinct in which he offers to vote, the electoral board shall immediately send to the 134 applicant by mail, obtaining a certificate of mailing, or deliver to him in person in the office of the 135 secretary or registrar, the following items and nothing else:

136 1. An envelope containing the folded ballot, sealed and marked "Ballot within. Do not open except137 in presence of a witness."

138 2. An envelope, with printing only on the flap side, for resealing the marked ballot, on which139 envelope is printed the following:

140 "Statement of Voter."

141 "I do hereby state, subject to felony penalties for making false statements 142 pursuant to § 24.2-1016, that my FULL NAME is (last, first, 143 middle); that I am now or have been at some time since last November's general 144 election a legal resident of (STATE YOUR LEGAL RESIDENCE IN 145 VIRGINIA including the house number, street name or rural route address, city, 146 zip code); that I received the enclosed ballot(s) upon application to the 147 registrar of such county or city; that I opened the envelope marked 'ballot 148 within' and marked the ballot(s) in the presence of the witness, without 149 assistance or knowledge on the part of anyone as to the manner in which I 150 marked it (or I am returning the form required to report how I was assisted); 151 that I then sealed the ballot(s) in this envelope; and that I have not voted 152 and will not vote in this election at any other time or place. 153

157 3. A properly addressed envelope for the return of the ballot to the electoral board by mail or by the 158 applicant in person.

4. Printed instructions for completing the ballot and statement on the envelope and returning the ballot.

161 The envelopes and instructions shall be in the form prescribed by the State Board.

162 If the applicant makes his application to vote in person under § 24.2-701 at a time when the printed 163 ballots for the election are available, the general registrar or the secretary of the electoral board, on the 164 determination of the qualifications of the applicant to vote, shall provide to the applicant the items set 165 forth in subdivisions 1 through 4, and no item shall be removed by the applicant from the office of the general registrar or the secretary of the electoral board. On the request of the applicant, made at least 166 five days prior to the election in which the applicant offers to vote, the general registrar or the secretary 167 168 may send the items set forth in subdivisions 1 through 4 to the applicant by mail, obtaining a certificate 169 of mailing.

170 If the applicant states as the reason for his absence on election day any of the reasons set forth in 171 subdivision 2 of § 24.2-700, the electoral board shall mail or deliver in person to the applicant in the 172 office of the secretary or general registrar, the items as set forth in subdivisions 1 through 4 and, if 173 necessary, an application for registration. [However, the applications for registration and an absentee 174 ballot shall not be mailed simultaneously if the applicant states as the reason for his absence on election day any of the reasons set forth in subdivision 2 of § 24.2-700 and he files his application for 175 176 an absentee ballot electronically pusuant to subdivision B 3 of § 24.2-701.] A certificate of mailing 177 shall not be required.

When the statement prescribed in subdivision 2 has been properly completed and signed by the registered voter and witnessed, his ballot shall not be subject to challenge pursuant to § 24.2-651.
