11	Be it enacted by the General Assembly of Virginia:
12	1. That § 51.1-124.3 of the Code of Virginia is amended and reenacted as follows:
13	§ 51.1-124.3. Definitions.
14 15	As used in this chapter, unless the context requires a different meaning:
15 16	"Abolished system" means the Virginia Retirement Act, §§ 51-30 through 51-111, repealed by Chapter 1 of the Acts of Assembly of 1952.
17	"Accumulated contributions" means the sum of all amounts deducted from the compensation of a
18	member and credited to his individual account in the member's contribution account, all amounts the
19	member may contribute to purchase creditable service, all member contributions contributed by the
20	employer on behalf of the employee, on or after July 1, 1990, except those amounts contributed on
21	behalf of members of the General Assembly who are otherwise retired under the provisions of this
22	chapter, and all interest accruing to these funds. If a member is retired for disability from a cause which
23 24	is compensable under the Virginia Workers' Compensation Act (§ 65.2-100 et seq.), dies in service prior to retirement, or requests a refund of contributions in accordance with § 51.1-161, "accumulated
25	contributions" shall include all member contributions paid by the employer on behalf of the member on
26	and after July 1, 1980, and all interest which would have accrued to these funds.
27	"Actuarial equivalent" means a benefit of equal value when computed upon the basis of actuarial
28	tables adopted by the Board.
29 30	"Average final compensation" means the average annual creditable compensation of a member during his 36 highest consecutive months of creditable service or during the entire period of his creditable
30 31	service if less than 36 months. If a member ceased employment prior to July 1, 1974, "average final
32	compensation" means the average annual creditable compensation during the five highest consecutive
33	years of creditable service.
34	"Beneficiary" means any person entitled to receive benefits under this chapter.
35	"Board" means the Board of Trustees of the Virginia Retirement System.
36 37	"Creditable compensation" means the full compensation payable annually to an employee working full time in his covered position. Remuneration received by members of the General Assembly not
38	otherwise retired under the provisions of this chapter pursuant to §§ 30-19.11 and 30-19.12 shall be
	deemed creditable compensation. In addition, for any member of the General Assembly, creditable
40	compensation shall include the full amount of salaries payable to such member for working in covered
41	positions, regardless of whether a contractual salary is reduced and not paid to such member because of
42	service in the General Assembly. Creditable compensation shall also include the overtime compensation
43 44	paid to any law-enforcement officer employed full time at an airport, as such term is defined in § 5.1-1, of this Commonwealth. Creditable compensation shall include only the overtime compensation paid to
45	such officers that relates to service in a covered position.
46	"Creditable service" means prior service as set forth in § 51.1-142.2 plus membership service for
47	which credit is allowable.
48	"Employee" means any teacher, state employee, officer, or employee of a locality participating in the
49 50	Retirement System. "Employer" means the Commonwealth in the case of a state employee, the local public school board
50 51	in the case of a teacher, or the political subdivision participating in the Retirement System.
52	"Joint Rules Committee" means those members of the House of Delegates and the Senate designated
53	by the Speaker of the House and the Chairman of the Senate Committee on Rules, respectively, to meet
54	with each other and to act jointly on behalf of the Committee on Rules for each house.
55 54	"Local officer" means the treasurer, commissioner of the revenue, attorney for the Commonwealth,
56 57	clerk of a circuit court, or sheriff of any county or city, or deputy or employee of any such officer. "Medical Board" means the board of physicians as provided by this chapter.
57 58	"Member" means any person included in the membership of the Retirement System.

59 "Membership service" means service as an employee rendered while a contributing member of the 60 Retirement System except as provided in this chapter.

61 "Normal retirement date" means a member's sixty-fifth birthday.

62 "Political subdivision" means any county, city, or town, any political entity, subdivision, branch, or unit of the Commonwealth, or any commission, public authority, or body corporate created by or under 63 an act of the General Assembly specifying the powers, privileges, or authority capable of exercise by the 64 65 commission, public authority, or body corporate.

"Primary social security benefit" means, with respect to any member, the primary insurance amount 66 67 to which the member is entitled, for old age or disability, as the case may be, pursuant to the provisions of the federal Social Security Act as in effect at his date of retirement, under the provisions of this 68 69 chapter except as otherwise specifically provided. 70

Prior service" means service rendered prior to becoming a member of the Retirement System.

"Purchase of service contract" means a contract entered into by the member and the Retirement 71 72 System for the purchase of service credit by the member as provided in § 51.1-142.2.

"Retirement allowance" means the retirement payments to which a member is entitled. 73

74 "Retirement System" means the Virginia Retirement System.

75 "Service" means service as an employee.

76 "State employee" means any person who is regularly employed full time on a salaried basis, whose 77 tenure is not restricted as to temporary or provisional appointment, in the service of, and whose compensation is payable, no more often than biweekly, in whole or in part, by the Commonwealth or 78 79 any department, institution, or agency thereof. "State employee" shall include the Governor, Lieutenant Governor, Attorney General, and members of the General Assembly but shall not include (i) any local 80 officer, (ii) any employee of a political subdivision of the Commonwealth, (iii) individuals employed by 81 the Department for the Blind and Vision Impaired pursuant to § 51.5-72, (iv) any member of the State 82 Police Officers' Retirement System, (v) any member of the Judicial Retirement System, or (vi) any member of the Virginia Law Officers' Retirement System. 83 84

"Teacher" means any person who is regularly employed full time on a salaried basis as a professional 85 or clerical employee of a county, city, or other local public school board. 86

2. That the provisions of this act including in creditable compensation the overtime compensation 87 of law-enforcement officers employed full time at an airport shall apply only to overtime 88 89 compensation for hours worked on or after July 1, 2004.
