10	Be it enacted by the General Assembly of Virginia:
11 12	1. That the Code of Virginia is amended by adding a section numbered 53.1-151.1 as follows: § 53.1-151.1. Eligibility for additional Reading for Good Time credits; application.
13	A. Beginning July 1, 2004, and notwithstanding any other provision of law, every person who has
14	been convicted of a felony and every person convicted of a misdemeanor and to whom the provisions of
15	§§ 53.1-151, 53.1-152, or § 53.1-153 apply may be entitled to earn additional good conduct allowance
16	not to exceed the amount set forth below. Such good conduct allowance shall be applied to reduce the
17	person's maximum term of confinement while he is confined in any state correctional facility.
18 19	Any person who, on or after July 1, 1993, has been sentenced upon a conviction of murder in the first degree, rape in violation of § 18.2-61, forcible sodomy, animate or inanimate object sexual
19 20	penetration or aggravated sexual battery, and any person who has been sentenced to a term of life
20 21	imprisonment or two or more life sentences shall be classified within the system established by
22	§ 53.1-201. Such person shall be eligible for no more than five days good conduct credit for each 30
23	days served. Additional good conduct credits may be approved by the Board of Corrections for such
24	persons in accordance with § 53.1-191.
25	B. Regulations approved by the Board shall govern the earning of additional credits for reading. The
26 27	regulations shall require, as a condition for earning the credits, that a prisoner who is serving a term of imprisonment as outlined above may receive credit toward the service of the prisoner's sentence, beyond
28	the time served and in addition to any other credit or allowance earned, of up to 10 days at the end of
29	each year of the prisoner's term of imprisonment, beginning at the end of the first year of the term,
30	subject to determination by the Department of Corrections that, during that year, the prisoner has
31	displayed compliance with institutional disciplinary regulations and has satisfactorily completed the
32	requirements of the Reading for Good Time program. In awarding credit under this section, the
33 34	Department of Corrections shall consider whether the prisoner, during the relevant period, has
34 35	satisfactorily participated in the Reading for Good Time program by completely reading and passing a comprehension test on approved novels or literature as determined by the Department of Correctional
36	Education. Credit that has not been earned may not later be granted. Credit awarded under this section
37	shall vest on the last day of each calendar year.
38	C. Credits under the Reading for Good Time program shall be awarded on the basis of one day's
39	credit for every one thousand pages read of approved novels or compilations of literature scored under
40 41	the program. Scoring is determined by the Department of Correctional Education based upon the
41 42	completion of reading the approved novels or literature and passing comprehension testing with a score of 70 percent for the approved material.
4 3	D. The Secretary of Public Safety shall direct the Department of Corrections and the Department of
44	Correctional Education to have in effect a Reading for Good Time program with appropriate testing
45	materials and criteria in each state correctional institution by July 1, 2005.
