1	Title	Distribution of "Four for Life" Funds

5. Summary/Purpose:

HB 1002, as enrolled, would revise the formula for distribution of the \$4 per year that is charged and collected for registration of motor vehicles. The changes and the programs they affect are described in the attachment.

In addition, the bill would expand the State Department of Health's support activities to include:

- Emergency medical services system development initiatives
- Priorities based on needs identified by the State Emergency Medical Services Advisory Board
- Local, regional, and statewide performance contracts for emergency medical services to meet certain objectives set out in statutory law
- Technology and radio communication enhancements
- Improved emergency preparedness and response.

A second enactment clause provides that this bill will take effect on July 1, 2004, or when the revenues from the increase in the fee from \$2 to \$4 are all allocated in compliance with the applicable *Code of Virginia* provision (subdivision A13 of \$46.2-694 as revised by HB 1002), that is, no changes in the formula will be applied to the allocations until there are no longer any Appropriation Act overrides to the *Code*.

6. No fiscal impact:

HB 1002 would require no net budget change, but would require a technical amendment shifting funds from one subprogram to another (see Item 8 for details.)

7. Budget amendment necessary: *Technical amendment only*. See Item 8, below.

8. Fiscal implications:

HB 1002 would not affect the total amount of funds collected or spent. The shift in spending from one subprogram to another requires only technical budget amendments, as follows, whenever the bill takes effect (see Item 11, below, for timing):

^{*}Note: The current Emergency Medical Services appropriation in HB30 (Item #307) includes general fund money for the Poison Control Centers (\$1,649,216) and a federal appropriation for EMS grant programs (\$100,000). These appropriation amounts are not included in the table above, as this bill does not impact them.

9. Specific agency or political subdivisions affected:

Local volunteer rescue squads; local governments; Virginia Department of Health (VDH)

10. Technical amendment necessary: No

11. Other comments: HB 1002 does not address the proposed funding of the State Police aviation "med-flight" operations ("Medevac") from this "Four for Life" funding source. HB 30 proposed that, instead of funding Medevac from the general fund, for FY 2005 and FY 2006, the \$1,045,375 in Medevac funding would come from "Four for Life" collections, with the remainder of the revenue allocated as specified in the *Code of Virginia*.
