

**Impact Analysis on Proposed Legislation**

**Topic:** <u>Killing of a fetus</u>

## **Proposed Change:**

The proposal adds § 18.2-32.2 to the *Code of Virginia* to specify that any person who maliciously, willfully, deliberately, and unlawfully kills the fetus of another is guilty of a Class 2 felony.

Under subsection A of § 18.2-51.2, the malicious wounding of any person with the intent to maim, disfigure, disable or kill is punishable as a Class 2 felony if the victim is severely injured and suffers permanent and significant physical impairment. However, a fetus is not specifically designated a potential victim of this crime. Under subsection B of § 18.2-51.2, the malicious wounding of a pregnant woman with the intent to maim, disfigure, disable or kill her or to cause the involuntary termination of her pregnancy is also a Class 2 felony.

## **Data Analysis:**

Based on fiscal year (FY) 2000 and FY2001 Pre/Post-Sentence Investigation (PSI) data, there were no convictions for violations of subsection B of § 18.2-51.2 either as the primary (most serious) offense or an additional offense in a sentencing event. There were 118 convictions for violations of subsection A of § 18.2-51.2 as the primary offense in a sentencing event. Of these, 109 (92%) received state-responsible (prison) terms with a median effective sentence of fifteen years.

## **Impact of Proposed Legislation:**

The proposed legislation establishes a new crime that is not specifically defined in the current *Code*. The proposed legislation may have an impact on the bed space needs of the Commonwealth. However, the databases available to the Commission are insufficient to provide information on the number of incidences that may be affected by the proposed legislation.

Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation cannot be determined for periods of imprisonment in state adult correctional facilities and is \$0 for periods of commitment to the custody of the Department of Juvenile Justice.
