2 An Act to amend and reenact § 58.1-2259 of the Code of Virginia, relating to refunds of the motor fuels 3 tax.

Be it enacted by the General Assembly of Virginia:

8 1. That § 58.1-2259 of the Code of Virginia is amended and reenacted as follows: 9

§ 58.1-2259. Fuel uses eligible for refund.

10 A. A refund of the tax paid for the purchase of fuel in quantities of five gallons or more at any time shall be granted in accordance with the provisions of § 58.1-2261 to any person who establishes to the 11 12 satisfaction of the Commissioner that such person has paid the tax levied pursuant to this chapter upon 13 any fuel: 14

1. Sold and delivered to a governmental entity for its exclusive use;

15 2. Used by a governmental entity, provided persons operating under contract with a governmental entity shall not be eligible for such refund; 16

3. Sold and delivered to an organization described in subdivision 2 of § 58.1-2226 or subdivision 2 17 18 of § 58.1-2250 for its exclusive use in the operation of an aircraft;

19 4. Used by an organization described in subdivision 2 of § 58.1-2226 or subdivision 2 of § 58.1-2250 20 for its exclusive use in the operation of an aircraft, provided persons operating under contract with such an organization shall not be eligible for such refund; 21

22 5. Purchased by a licensed exporter and subsequently transported and delivered by such licensed 23 exporter to another state for sales or use outside the boundaries of the Commonwealth if the tax 24 applicable in the destination state has been paid, provided a refund shall not be granted pursuant to this 25 section on any fuel which is transported and delivered outside of the Commonwealth in the fuel supply 26 tank of a highway vehicle or an aircraft;

27 6. Used by any person performing transportation under contract or lease with any transportation district for use in a highway vehicle controlled by a transportation district created under the 28 29 Transportation District Act of 1964 (§ 15.2-4500 et seq.) and used in providing transit service by the 30 transportation district by contract or lease, provided the refund shall be paid to the person performing 31 such transportation;

7. Used by any private, nonprofit agency on aging, designated by the Department for the Aging, 32 33 providing transportation services to citizens in highway vehicles owned, operated or under contract with 34 such agency;

35 8. Used in operating or propelling highway vehicles owned by a nonprofit organization that provides specialized transportation to various locations for elderly or disabled individuals to secure essential 36 37 services and to participate in community life according to the individual's interest and abilities;

38 9. Used in operating or propelling buses owned and operated by a county or the school board thereof 39 while being used to transport children to and from public school or from school to and from educational 40 or athletic activities;

41 10. Used by buses owned or solely used by a private, nonprofit, nonsectarian school while being 42 used to transport children to and from such school or from such school to and from educational or 43 athletic activities;

44 11. Used by any county or city school board or any private, nonprofit, nonsectarian school 45 contracting with a private carrier to transport children to and from public schools or any private, 46 nonprofit, nonsectarian school, provided the tax shall be refunded to the private carrier performing such 47 transportation;

12. Used in operating or propelling the equipment of volunteer firefighting companies and of **48** 49 volunteer rescue squads within this Commonwealth used actually and necessarily for firefighting and 50 rescue purposes;

13. Used in operating or propelling motor equipment belonging to counties, cities and towns, if 51 52 actually used in public activities; 53

14. Used for a purpose other than in operating or propelling highway vehicles, watercraft or aircraft;

54 15. Used off-highway in self-propelled equipment manufactured for a specific off-road purpose, 55 which is used on a job site and the movement of which on any highway is incidental to the purpose for 56 which it was designed and manufactured;

57 16. Proven to be lost by accident, including the accidental mixing of (i) dyed diesel fuel with

tax-paid motor fuel, (ii) gasoline with diesel fuel, or (iii) undyed diesel fuel with dyed kerosene, but 58 59 excluding fuel lost through personal negligence or theft; 60

17. Used in operating or propelling vehicles used solely for racing other vehicles on a racetrack;

18. Used in operating or propelling unlicensed highway vehicles and other unlicensed equipment 61 62 used exclusively for agricultural or horticultural purposes on lands owned or leased by the owner or 63 lessee of such vehicles and not operated on or over any highway for any purpose other than to move it in the manner and for the purpose mentioned. The amount of refund shall be equal to the amount of the 64 taxes paid less one-half cent per gallon on such fuel so used which shall be paid by the Commissioner 65 66 into the state treasury to the credit of the Virginia Agricultural Foundation Fund;

67 19. Used in operating or propelling commercial watercraft. The amount of refund shall be equal to the amount of the taxes paid less one and one-half cents per gallon on such fuel so used which shall be 68 69 paid by the Commissioner into the state treasury to be credited as provided in subsection D of 70 § 58.1-2289. If any applicant so requests, the Commissioner shall pay into the state treasury, to the credit of the Game Protection Fund, the entire tax paid by such applicant for the purposes specified in 71 72 subsection D of § 58.1-2289. If any applicant who is an operator of commercial watercraft so requests, 73 the Commissioner shall pay into the state treasury, to the credit of the Marine Fishing Improvement 74 Fund, the entire tax paid by such applicant for the purposes specified in § 28.2-208;

75 20. Used in operating stationary engines, or pumping or mixing equipment on a highway vehicle if 76 the fuel used to operate such equipment is stored in an auxiliary tank separate from the fuel tank used to 77 propel the highway vehicle, and the highway vehicle is mechanically incapable of self-propulsion while 78 fuel is being used from the auxiliary tank; or 79

21. Used in operating or propelling recreational and pleasure watercraft.

80 B. Any person purchasing fuel for consumption in a solid waste compacting or ready-mix concrete highway vehicle, or a bulk feed delivery truck, where the vehicle's equipment is mechanically or 81 hydraulically driven by an internal combustion engine that propels the vehicle, is entitled to a refund in 82 an amount equal to 35 percent of the tax paid on such fuel. For purposes of this section, a "bulk feed 83 delivery truck" means bulk animal feed delivery trucks utilizing power take-off (PTO) driven auger or 84 85 air feed discharge systems for off-road deliveries of animal feed.

86 C. Any person purchasing any fuel on which tax imposed pursuant to this chapter has been paid may 87 apply for a refund of the tax if such fuel was consumed by a highway vehicle used in operating an 88 urban or suburban bus line or a taxicab service. This refund also applies to a common carrier of 89 passengers which has been issued a certificate of public convenience and necessity pursuant to 90 §§ 46.2-2005 and 58.1-2204 providing regular route service over the highways of the Commonwealth. 91 No refund shall be granted unless the majority of the passengers using such bus line, taxicab service or 92 common carrier of passengers do so for travel of a distance of not more than 40 miles, one way, in a 93 single day between their place of abode and their place of employment, shopping areas or schools.

94 If the applicant for a refund is a taxicab service, he shall hold a valid permit from the Department to 95 engage in the business of a taxicab service. No applicant shall be denied a refund by reason of the fee 96 arrangement between the holder of the permit and the driver or drivers, if all other conditions of this 97 section have been met.

98 Under no circumstances shall a refund be granted more than once for the same fuel. The amount of 99 refund under this subsection shall be equal to the amount of the taxes paid, except refunds granted on 100 the tax paid on fuel used by a taxicab service shall be in an amount equal to the tax paid less one cent 101 per gallon on the fuel used.

102 Any refunds made under this subsection shall be deducted from the urban highway funds allocated to 103 the highway construction district, pursuant to Article 1.1 (§ 33.1-23.01 et seq.) of Chapter 1 of Title 104 33.1, in which the recipient has its principal place of business.

105 Except as otherwise provided in this chapter, all provisions of law applicable to the refund of fuel 106 taxes by the Commissioner generally shall apply to the refunds authorized by this subsection. Any 107 county having withdrawn its roads from the secondary system of state highways under provisions of 108 § 11 Chapter 415 of the Acts of 1932 shall receive its proportionate share of such special funds as is 109 now provided by law with respect to other fuel tax receipts.

110 D. Any person purchasing fuel for consumption in a vehicle designed or permanently adapted solely and exclusively for bulk spreading or spraying of agricultural liming materials, chemicals, or fertilizer, 111 where the vehicle's equipment is mechanically or hydraulically driven by an internal combustion engine 112 113 that propels the vehicle, is entitled to a refund in an amount equal to 55 percent of the tax paid on such fuel. 114

115 E. Refunds resulting from any fuel shipments diverted from Virginia shall be based on the amount of tax paid for the fuel less discounts allowed by § 58.1-2233. 116

117 \mathbf{E} F. Any person who is required to be licensed under this chapter and is applying for a refund shall 118 not be eligible for such refund if the applicant was not licensed at the time the refundable transaction 119 was conducted.
