The purchase 24 price of such plates shall be as agreed between the Commissioner and the supplier or other entity, but 25 shall in no case exceed a total, one-time cost of \$15 for each set of license plates. In the event that a 26 race car number, color scheme, or both, change for a driver with a currently issued series, a new series 27

28 The provisions of subdivision 1 of subsection B 1 of § 46.2-725 shall not apply to license plates 29 issued under this subsection section.

30 C. The annual fee for plates issued pursuant to this section shall be \$25 in addition to the prescribed 31 fee for state license plates. For each such \$25 fee collected in excess of 1,000 registrations pursuant to 32 this section, \$15 shall be paid into the state treasury and credited to the special nonreverting fund known 33 as the Virginia Motor Sports Initiative Fund established within the Department of Accounts and paid 34 annually in equal amounts to the Virginia Economic Development Partnership Authority and the 35 Virginia Department of Business Assistance and used to support their programs related to the Virginia Motor Sports Initiative. 36

37 In calculating the amount to be paid into such fund each year, however, there shall be deducted an 38 amount equal to the amount paid in that year by the Department for the purchase of license plates for 39 which the additional \$25 fees have been collected for that year.

8 9 § 46.2-749.69:1. Special license plates bearing the names, numbers, and color schemes used by 10 professional stock car drivers; fees.
