That §§ 2.2-507 and 10.1-501 of the Code of Virginia are amended and reenacted as follows: § 2.2-507. Legal service in civil matters. 10 A. All legal service in civil matters for the Commonwealth, the Governor, and every state 11 department, institution, division, commission, board, bureau, agency, entity, official, court, or judge, 12 including the conduct of all civil litigation in which any of them are interested, shall be rendered and 13 performed by the Attorney General, except as provided in this chapter and except for any litigation 14 concerning a justice or judge initiated by the Judicial Inquiry and Review Commission. No regular 15 16 counsel shall be employed for or by the Governor or any state department, institution, division, 17 commission, board, bureau, agency, entity, or official. The Attorney General may represent personally or through one or more of his assistants any number of state departments, institutions, divisions, 18 19 commissions, boards, bureaus, agencies, entities, officials, courts, or judges that are parties to the same 20 transaction or that are parties in the same civil or administrative proceeding and may represent multiple 21 interests within the same department, institution, division, commission, board, bureau, agency, or entity. 22 Upon request of the local attorney for the Commonwealth, the Attorney General may provide legal 23 service in civil matters for soil and water conservation district directors or districts. 24 B. The Attorney General may represent personally or through one of his assistants any of the 25 following persons who are made defendant in any civil action for damages arising out of any matter connected with their official duties: 26 27 1. Members, agents or employees of the Alcoholic Beverage Control Board; 28 2. Agents inspecting or investigators appointed by the State Corporation Commission; 29 3. Agents, investigators, or auditors employed by the Department of Taxation; 30 4. Members, agents or employees of the State Mental Health, Mental Retardation and Substance Abuse Services Board, the Department of Mental Health, Mental Retardation and Substance Abuse 31 Services, the State Board of Health, the State Department of Health, the Department of General 32 Services, the State Board of Social Services, the Department of Social Services, the State Board of 33 34 Corrections, the Department of Corrections, the State Board of Juvenile Justice, the Department of 35 Juvenile Justice, the Virginia Parole Board, or the Department of Agriculture and Consumer Services; 36 5. Persons employed by the Commonwealth Transportation Board; 37 6. Persons employed by the Commissioner of Motor Vehicles; 38 7. Persons appointed by the Commissioner of Marine Resources; 39 8. Police officers appointed by the Superintendent of State Police; 40 9. Game wardens appointed by the Department of Game and Inland Fisheries; 41 10. Third impartial panel members appointed to hear a teacher's grievance pursuant to § 22.1-312; 42 11. Staff members or volunteers participating in a court-appointed special advocate program pursuant to Article 5 (§ 9.1-151 et seq.) of Chapter 1 of Title 9.1; or 43 12. Any emergency medical service agency that is a licensee of the Department of Health in any 44 civil matter and any guardian ad litem appointed by a court in a civil matter brought against him for 45 alleged errors or omissions in the discharge of his court-appointed duties. 46 Upon request of the affected individual, the Attorney General may represent personally or through 47 **48** one of his assistants any basic or advanced emergency medical care attendant or technician possessing a valid certificate issued by authority of the State Board of Health in any civil matter in which a defense 49 50 of immunity from liability is raised pursuant to § 8.01-225. 51 C. If, in the opinion of the Attorney General, it is impracticable or uneconomical for such legal service to be rendered by him or one of his assistants, he may employ special counsel for this purpose, 52 53 whose compensation shall be fixed by the Attorney General. The compensation for such special counsel 54 shall be paid out of the funds appropriated for the administration of the board, commission, division or 55 department whose members, officers, inspectors, investigators, or other employees are defended pursuant to this section. Notwithstanding any provision of this section to the contrary, the Supreme Court may 56 employ its own counsel in any matter arising out of its official duties in which it, or any justice, is a 57 58 party. 59
