1.	Title Creation of the Office of Learning Technology			

5. **Summary/Purpose:** Creates the Office of Learning Technology within the State Council of Higher Education (SCHEV) to facilitate and coordinate the voluntary participation of public and private institutions of higher education in the Commonwealth that are accredited by the Southern Association of Colleges and Schools in technology-enriched learning initiatives.

The Office shall (i) facilitate the development of innovative, cost-effective, technology-enriched teaching and learning initiatives, including distance and distributed learning initiatives, to address currently served populations and underserved constituencies in the Commonwealth; (ii) seek to improve cooperation among and between the institutions of higher education in the Commonwealth; (iii) improve efficiency and expand the availability of technologically-enriched courses; and (iv) facilitate the sharing of research and experience to improve student learning.

- 7. Budget amendment necessary: Yes, Item 165 for the State Council of Higher Education.
- **8. Fiscal implications:** The State Council of Higher Education estimates initial start-up costs for the new Office will require a total of \$372,100. Of this amount, \$122,100 represents the ongoing salary and benefit costs for a program director and a part-time staff position with the remaining \$250,000 for one-time program development costs. Given current staff shortages and existing workloads at SCHEV, the agency cannot absorb the additional costs associated with the proposed new office.

To fully address the goals of this legislation, the State Council of Higher Education in Virginia believes the additional \$250,000 will be sufficient for a one-time evaluation of programmatic needs and to provide seed funding for innovative and collaborative distance learning initiatives at institutions throughout Virginia.
