2 *An Act to amend and reenact § 46.2-833 of the Code of Virginia, relating to enforcement of traffic light*
3 *signals; use of wireless telecommunications devices.*

6 **Be it enacted by the General Assembly of Virginia:**

7 **1. That § 46.2-833 of the Code of Virginia is amended and reenacted as follows:**

8 § 46.2-833. Traffic lights; penalty.

9 A. Signals by traffic lights shall be as follows:

10 Steady red indicates that moving traffic shall stop and remain stopped as long as the red signal is
11 shown, except in the direction indicated by a lighted green arrow.

12 Green indicates the traffic shall move in the direction of the signal and remain in motion as long as
13 the green signal is given, except that such traffic shall yield to other vehicles and pedestrians lawfully
14 within the intersection.

15 Steady amber indicates that a change is about to be made in the direction of the moving of traffic.
16 When the amber signal is shown, traffic which has not already entered the intersection, including the
17 crosswalks, shall stop if it is not reasonably safe to continue, but traffic which has already entered the
18 intersection shall continue to move until the intersection has been cleared. The amber signal is a warning
19 that the steady red signal is imminent.

20 Flashing red indicates that traffic shall stop before entering an intersection.

21 Flashing amber indicates that traffic may proceed through the intersection or past such signal with
22 reasonable care under the circumstances.

23 B. If the traffic lights controlling an intersection are out of service because of a power failure or
24 other event that prevents the giving of signals by the traffic lights, the drivers of vehicles approaching
25 such an intersection shall proceed as though such intersection were controlled by a stop sign on all
26 approaches. The provisions of this subsection shall not apply to: intersections controlled by portable stop
27 signs, intersections with law-enforcement officers or other authorized persons directing traffic, or
28 intersections controlled by traffic lights displaying flashing red or flashing amber lights as provided in
29 subsection A.

30 C. The driver of any motor vehicle may be detained *or arrested* for a violation of this section if the
31 detaining law-enforcement officer is in uniform, displays his badge of authority, and (i) has observed the
32 violation or (ii) has received a ~~radio~~ message *by radio or other wireless telecommunication device* from
33 another law-enforcement officer who observed the violation. In the case of a person being detained *or*
34 *arrested* based on a radio message, the message shall be sent immediately after the violation is
35 observed, and the observing officer shall furnish the license number or other positive identification of
36 the vehicle to the detaining officer.

37 Violation of any provision of this section shall constitute a traffic infraction punishable by a fine of
38 no more than \$350.
