2 *An Act to amend and reenact § 54.1-1102 of the Code of Virginia, relating to Department of*
3 *Professional and Occupational Regulation; Board for Contractors; issuance of license.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 54.1-1102 of the Code of Virginia is amended and reenacted as follows:**

8 § 54.1-1102. Board for Contractors membership; offices; meetings; seal; record.

9 A. The Board for Contractors shall be composed of thirteen members as follows: one member shall
10 be a licensed Class A general contractor; the larger part of the business of one member shall be the
11 construction of utilities; the larger part of the business of one member shall be the construction of
12 commercial and industrial buildings; the larger part of the business of one member shall be the
13 construction of single-family residences; the larger part of the business of one member shall be the
14 construction of home improvements; one member shall be a subcontractor as generally regarded in the
15 construction industry; one member shall be in the business of sales of construction materials and
16 supplies; one member shall be a local building official; one member shall be a licensed plumbing
17 contractor; one member shall be a licensed electrical contractor; one member shall be a licensed heating,
18 ventilation and air conditioning contractor; and two members shall be citizen members. The terms of the
19 Board members shall be four years.

20 The Board shall meet at least four times each year, once in January, April, July and October, and at
21 such other times as may be deemed necessary. Annually, the Board shall elect from its membership a
22 chairman and a vice-chairman to serve for a one-year term. Seven members of the Board shall constitute
23 a quorum.

24 The Board shall promulgate regulations not inconsistent with statute necessary for the licensure of
25 contractors and tradesmen and the certification of backflow prevention device workers, and for the
26 relicensure of contractors and tradesmen and for the recertification of backflow prevention device
27 workers, after license or certificate suspension or revocation. *The Board shall include in its regulations a*
28 *requirement that as a condition for initial licensure as a contractor, the designated employee or a*
29 *member of the responsible management personnel of the contractor shall have successfully completed a*
30 *Board-approved basic business course, which shall not exceed eight hours of classroom instruction.*

31 The Board may adopt regulations requiring all Class A, B, and C residential contractors, excluding
32 subcontractors to the contracting parties and those who engage in routine maintenance or service
33 contracts, to use legible written contracts including the following terms and conditions:

- 34 1. General description of the work to be performed;
35 2. Fixed price or an estimate of the total cost of the work, the amounts and schedule of progress
36 payments, a listing of specific materials requested by the consumer and the amount of down payment;
37 3. Estimates of time of commencement and completion of the work; and
38 4. Contractor's name, address, office telephone number and license or certification number and class.

39 In transactions involving door-to-door solicitations, the Board may require that a statement of
40 protections be provided by the contractor to the homeowner, consumer or buyer, as the case may be.

41 The Board shall adopt a seal with the words "Board for Contractors, Commonwealth of Virginia."
42 The Director shall have charge, care and custody of the seal.

43 B. The Director shall maintain a record of the proceedings of the Board.

44 **2. That the Board shall promulgate regulations to implement the provisions of this act to be**
45 **effective within 280 days of its enactment.**
