Q Be it enacted by the General Assembly of Virginia: 1. That §§ 2.2-1403, 2.2-4310, and 15.2-965.1 of the Code of Virginia are amended and reenacted 10 11 as follows: § 2.2-1403. Powers of Director. 12 13 As deemed necessary or appropriate to better fulfill the duties of the Department, the Director may: 14 1. With the participation of other state departments and agencies, develop comprehensive plans and 15 specific program goals for the minority enterprise program; establish regular performance monitoring and reporting systems to assure that goals are being achieved; and evaluate the impact of federal and state 16 17 support in achieving objectives. 18 2. Employ the necessary personnel and/or subcontract according to his discretion, with localities to 19 supplement the functions of business development organizations. 20 3. Assure the coordinated review of all proposed state training and technical assistance activities in 21 direct support of the minority enterprise program to ensure consistency with program goals and to avoid 22 duplication. 23 4. Convene, for purposes of coordination, meetings of the heads of departments and agencies, or their 24 designees, whose programs and activities may affect or contribute to the purposes of this chapter. 25 5. Convene business leaders, educators, and other representatives of the private sector who are engaged in assisting the development of minority business enterprise or who could contribute to its 26 27 development, for the purpose of proposing, evaluating or coordinating governmental and private 28 activities in furtherance of the objectives of this chapter. 29 6. Provide the managerial and organizational framework through which joint undertakings with state 30 departments or agencies or private organizations can be planned and implemented. 31 7. Recommend appropriate legislative or executive actions. 32 8. Adopt reasonable regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) to implement a certification program programs for small, women, and minority business 33 enterprises. Such certification process shall include consideration of other states' laws that may deny like 34 35 certifications to Virginia-based *small*, women, or minority business enterprises and that may provide a preference for *small*, women, or minority business enterprises based in that state. The regulations shall 36 37 (i) establish minimum requirements for certification of small, women- and minority-owned businesses; 38 (ii) provide a process for evaluating existing local, state, private sector, and federal certification 39 programs that meet the minimum requirements; and (iii) mandate certification, without any additional 40 paperwork or fee, of any prospective state vendor that has obtained certification under any certification 41 program that is determined to meet the minimum requirements established in the regulations. 42 9. Establish an interdepartmental board in accordance with § 2.2-1404 to supply the Director with 43 information useful in promoting minority business activity. 44 § 2.2-4310. Discrimination prohibited; participation of small, women- and minority-owned business. 45 A. In the solicitation or awarding of contracts, no public body shall discriminate against a bidder or offeror because of race, religion, color, sex, national origin, age, disability, or any other basis prohibited 46 by state law relating to discrimination in employment. Whenever solicitations are made, each public 47 body shall include businesses selected from a list made available by the Department of Minority **48** 49 Business Enterprise. 50 B. All public bodies shall establish programs consistent with this chapter to facilitate the participation 51 of small businesses and businesses owned by women and minorities in procurement transactions. The programs established shall be in writing and shall include cooperation with the Department of Minority 52 53 Business Enterprise, the United States Small Business Administration, and other public or private 54 agencies. State agencies shall submit annual progress reports on small, women, and minority business 55 procurement to the Department of Minority Business Enterprise. C. Whenever there exists (i) a rational basis for small business enhancement or (ii) a persuasive 56

analysis that documents a statistically significant disparity between the availability and utilization of 57 women- and minority-owned businesses, the Governor is authorized and encouraged to require state 58 59 agencies to implement appropriate enhancement or remedial measures consistent with prevailing law. the purposes of this subsection, "state agency" means any authority, board, department, instrumentality,
institution, agency or other unit of state government. "State agency" shall not include any county, city or
town.

D. In the solicitation or awarding of contracts, no state agency, department or institution shall
 discriminate against a bidder or offeror because the bidder or offeror employs ex-offenders unless the
 state agency, department or institution has made a written determination that employing ex-offenders on
 the specific contract is not in its best interest.

67 § 15.2-965.1. Participation of small, women- and minority-owned businesses.

A. Any locality may enact an ordinance providing that whenever there exists (i) a rational basis for
small business enhancement, or (ii) a persuasive analysis that documents a statistically significant
disparity between the availability and utilization of women- and minority-owned businesses, the chief
executive of the local governing entity shall be authorized and encouraged to require implementation of
appropriate enhancement and remedial measures consistent with prevailing law.

B. A small, women- or minority-owned business that is certified by the Department of Minority
Business Enterprises pursuant to § 2.2-1403 shall not be required by any locality to obtain any
additional certification to participate in any program designed to enhance the participation of such
businesses as vendors or to remedy any documented disparity.
