11	Be it enacted by the General Assembly of Virginia:
12	1. That the Code of Virginia is amended by adding in Chapter 26 of Title 2.2 an article numbered
13	32, consisting of sections numbered 2.2-2698 through 2.2-2698.5, as follows:
14	Article 32.
15	Council on Governmental Accountability and Efficiency.
16	§ 2.2-2698. The Council on Governmental Accountability and Efficiency; purpose.
17	The Council on Governmental Accountability and Efficiency (the Council) is established as an
18	advisory council in the executive branch of state government.
19	The purpose of the Council is to systematically identify waste and inefficiency, report on ways to
20	streamline state government, and make government more accountable.
21	§ 2.2-2698.1. Membership; terms; quorum; meetings.
22	The Council shall have a total membership of 13 that shall consist of 12 nonlegislative citizen
23	members and one ex officio member. Nonlegislative citizen members shall be appointed as follows: five
24	nonlegislative citizen members to be appointed by the Speaker of the House of Delegates; three
25	nonlegislative citizen members to be appointed by the Senate Committee on Rules; and four
26	nonlegislative citizen members to be appointed by the Governor. The Secretary of Finance or his
27	designee shall serve ex officio with voting privileges. Nonlegislative citizen members of the Council shall
28	be citizens of the Commonwealth.
29	Ex officio members of the Council shall serve terms coincident with their terms of office.
30	Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms.
31	Vacancies shall be filled in the same manner as the original appointments. All members may be
32	reappointed.
33	The Council shall elect a chairman and vice chairman from among its membership. A majority of the
34	members shall constitute a quorum. The meetings of the Council shall be held at the call of the
35	chairman or whenever the majority of the members so request.
36	§ 2.2-2698.2. Compensation; expenses.
37	Members shall receive such compensation for the performance of their duties as provided in
38	§ 2.2-2813. All members shall be reimbursed for all reasonable and necessary expenses incurred in the
39	performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. However, all funding for expenses
40	and other costs of the Council shall come from privately funded sources.
41	§ 2.2-2698.3. Powers and duties of the Council.
42	The Council shall have the following powers and duties:
43	1. Review state government administration and spending practices.
44 45	2. Examine ways to streamline, consolidate, privatize, and make government programs more efficient. 3. Identify outdated government programs that can be terminated, consolidated, or reduced.
4 5 46	4. Determine which programs could be better carried out by the private sector.
40	5. Apply business principles to the state's programs to determine cost saving measures.
4 7 4 8	6. Submit an annual report to the Governor and the General Assembly for publication as a report
4 9	document as provided in the procedures of the Division of Legislative Automated Systems for the
50	processing of legislative documents and reports. The chairman shall submit to the Governor and the
50 51	General Assembly an annual executive summary of the interim activity and work of the Council no later
52	than the first day of each regular session of the General Assembly. The executive summary shall be

56	§ 2.2-2698.4. Staffing.
57	The agencies that report to the Secretary of Finance shall provide staff support to the Council. All
58	agencies of the Commonwealth shall also provide assistance to the Council, upon request.
