That §§ 2.2-4303 and 2.2-4308 of the Code of Virginia are amended and reenacted as follows: 10 § 2.2-4303. Methods of procurement. 11 A. All public contracts with nongovernmental contractors for the purchase or lease of goods, or for 12 13 the purchase of services, insurance, or construction, shall be awarded after competitive sealed bidding, or 14 competitive negotiation as provided in this section, unless otherwise authorized by law. 15 B. Professional services shall be procured by competitive negotiation. 16 C. Upon a determination made in advance by the public body and set forth in writing that competitive sealed bidding is either not practicable or not fiscally advantageous to the public, goods, 17 services, or insurance may be procured by competitive negotiation. The writing shall document the basis 18 19 for this determination. 20 Upon a written determination made in advance by (i) the Governor or his designee in the case of a 21 procurement by the Commonwealth or by a department, agency or institution thereof or (ii) the local governing body in the case of a procurement by a political subdivision of the Commonwealth, that 22 23 competitive negotiation is either not practicable or not fiscally advantageous, insurance may be procured 24 through a licensed agent or broker selected in the manner provided for the procurement of things other 25 than professional services in subdivision 3 b of the definition of "competitive negotiation" in § 2.2-4301. The basis for this determination shall be documented in writing. 26 27 D. Construction may be procured only by competitive sealed bidding, except that competitive 28 negotiation may be used in the following instances upon a determination made in advance by the public 29 body and set forth in writing that competitive sealed bidding is either not practicable or not fiscally 30 advantageous to the public, which writing shall document the basis for this determination: 1. By (i) the Commonwealth, its departments, agencies and institutions and (ii) any local governing 31 body when the contract is not expected to cost more than [\$2 \$1] million, on a fixed price 32 33 design-build basis or construction management basis under § 2.2-4306; 34 2. By any public body for the construction, alteration, repair, renovation or demolition of buildings 35 when the contract is not expected to cost more than \$1 million; 3. By any public body for the construction of highways and any draining, dredging, excavation, 36 37 grading or similar work upon real property; or 38 4. As otherwise provided in § 2.2-4308. 39 E. Upon a determination in writing that there is only one source practicably available for that which 40 is to be procured, a contract may be negotiated and awarded to that source without competitive sealed bidding or competitive negotiation. The writing shall document the basis for this determination. The 41 public body shall issue a written notice stating that only one source was determined to be practicably 42 available, and identifying that which is being procured, the contractor selected, and the date on which 43 44 the contract was or will be awarded. This notice shall be posted in a designated public area or published in a newspaper of general circulation on the day the public body awards or announces its decision to 45 46 award the contract, whichever occurs first. Public notice may also be published on the Department of 47 General Services' central electronic procurement website and other appropriate websites. F. In case of emergency, a contract may be awarded without competitive sealed bidding or 48 49 competitive negotiation; however, such procurement shall be made with such competition as is practicable under the circumstances. A written determination of the basis for the emergency and for the 50 51 selection of the particular contractor shall be included in the contract file. The public body shall issue a 52 written notice stating that the contract is being awarded on an emergency basis, and identifying that 53 which is being procured, the contractor selected, and the date on which the contract was or will be awarded. This notice shall be posted in a designated public area or published in a newspaper of general 54 55 circulation on the day the public body awards or announces its decision to award the contract, whichever occurs first, or as soon thereafter as is practicable. Public notice may also be published on the 56 57 Department of General Services' central electronic procurement website and other appropriate websites. 58 G. A public body may establish purchase procedures, if adopted in writing, not requiring competitive

59 sealed bids or competitive negotiation for single or term contracts for goods and services other than professional services if the aggregate or the sum of all phases is not expected to exceed \$50,000; however, such small purchase procedures shall provide for competition wherever practicable. Purchases under this subsection that are expected to exceed \$30,000 shall require the written informal solicitation of a minimum of four bidders or offerors.

H. A public body may establish purchase procedures, if adopted in writing, not requiring competitive negotiation for single or term contracts for professional services if the aggregate or the sum of all phases is not expected to exceed \$30,000; however such small purchase procedures shall provide for competition wherever practicable.

68 I. Upon a determination made in advance by a public body and set forth in writing that the purchase 69 of goods, products or commodities from a public auction sale is in the best interests of the public, such 70 items may be purchased at the auction, including online public auctions. Purchase of information 71 technology and telecommunications goods and nonprofessional services from a public auction sale shall be permitted by any authority, department, agency, or institution of the Commonwealth if approved by 72 the Chief Information Officer of the Commonwealth. The writing shall document the basis for this 73 74 determination. However, bulk purchases of commodities used in road and highway construction and 75 maintenance, and aggregates shall not be made by online public auctions.

J. The purchase of goods or nonprofessional services, but not construction or professional services,
 may be made by reverse auctioning. However, bulk purchases of commodities used in road and highway
 construction and maintenance, and aggregates shall not be made by reverse auctioning.

79 § 2.2-4308. Design-build or construction management contracts for public bodies other than the
 80 Commonwealth; eligibility requirements; award of contract; records to be kept.

A. While the competitive sealed bid process remains the preferred method of construction 81 procurement for public bodies in the Commonwealth, any public body other than the Commonwealth 82 83 may enter into a contract for construction on a fixed price or not-to-exceed price design-build or construction management basis provided the public body complies with the requirements of this section 84 85 and has obtained the approval of the Design-Build/Construction Management Review Board (the Review 86 Board) pursuant to § 2.2-2406. Provided, however, that projects undertaken (i) pursuant to subdivision D 2 of § 2.2-4303, or (ii) by any local governing body when the contract is not expected to cost more than 87 88 \$2 million shall be exempt from approval of the Review Board.

Prior to making a determination as to the use of design-build or construction management for a specific construction project, the public body shall have in its employ or under contract a licensed architect or engineer with professional competence appropriate to the project who shall advise the public body regarding the use of design-build or construction management for that project and who shall assist the public body with the preparation of the Request for Proposal and the evaluation of such proposals.

94 Prior to issuing a Request for Proposal for any design-build or construction management contract for 95 a specific construction project, the public body shall:

1. Have adopted, by ordinance or resolution, written procedures governing the selection, evaluation 96 97 and award of design-build and construction management contracts. Such procedures shall be consistent 98 with those described in this chapter for the procurement of nonprofessional services through competitive 99 negotiation. Such procedures shall also require Requests for Proposals to include and define the criteria 100 of such construction project in areas such as site plans; floor plans; exterior elevations; basic building 101 envelope materials; fire protection information plans; structural, mechanical (HVAC), and electrical 102 systems; and special telecommunications; and may define such other requirements as the public body 103 determines appropriate for that particular construction project. Except as may otherwise be approved by 104 the Review Board, such procedures for:

a. Design-build construction projects shall include a two-step competitive negotiation processconsistent with the Review Board's regulations.

b. Construction management projects shall include selection procedures and required constructionmanagement contract terms consistent with the Review Board's regulations.

109 2. Have documented in writing that for a specific construction project (i) a design-build or
110 construction management contract is more advantageous than a competitive sealed bid construction
111 contract; (ii) there is a benefit to the public body by using a design-build or construction management
112 contract; and (iii) competitive sealed bidding is not practical or fiscally advantageous.

B. Once approved by the Review Board in accordance with § 2.2-2406, the public body may procure a design-build or construction management contract for the specific construction project presented to the Review Board. Unless otherwise specified in the Request for Proposal, the contract shall be awarded to the fully qualified offeror who submits an acceptable proposal at the lowest cost in response to the Request for Proposal.

118 C. The public body shall provide information as requested by the Review Board to allow post-project119 evaluation by the Review Board.
