6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 38.2-3115 of the Code of Virginia is amended and reenacted as follows:**

8 § 38.2-3115. Interest on life insurance proceeds.

9 A. If an action to recover the proceeds due under a life insurance policy or annuity contract results
10 in a judgment against the insurer, interest on the judgment at the legal rate of interest shall be paid from
11 (i) the date of presentation to the insurer of proof of death on a life insurance policy or annuity contract
12 or (ii) the date of maturity of an endowment policy to the date judgment is entered.

13 B. If no action is brought, interest upon the principal sum paid to the beneficiary or policyowner
14 shall be computed daily at an annual rate of 21/2 percent or at the annual rate currently paid by the
15 insurer on proceeds left under the interest settlement option, whichever is greater, commencing from the
16 date of death on a life insurance policy or annuity contract claim and from the date of maturity of an
17 endowment contract to the date of payment. The interest shall be added to and become a part of the
18 total sum payable.

19 C. No insurer shall be required to pay interest computed under this section if the total interest is less
20 than five dollars.

21 D. This section shall not apply to (i) credit life insurance for which the premium is paid wholly from
22 funds of the creditor with no specific identifiable charge being made to insureds for the insurance and
23 upon which post-death interest on the indebtedness is waived by the creditor in an amount at least equal
24 to the amount of interest that would otherwise be payable under this section; ~~or~~ (ii) *credit life insurance*
25 *payable in whole or in part to a creditor that is an affiliate, as defined in § 13.1-725, of the insurer and*
26 *that does not charge interest on the indebtedness from the date of death of the insured; or (iii) policies*
27 *or contracts issued prior to July 1, 1977, but shall apply to any renewals or reissues of group life*
28 *insurance policies or contracts occurring after that date.*
