HOUSE BILL NO. 362

AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the House Committee on Agriculture, Chesapeake and Natural Resources

on February 1, 2006)

(Patrons Prior to Substitute—Delegates Lingamfelter [HB 362], Abbitt [HB 979], Cline [HB 1130 and HB 1131], and Morgan [HB 938])

A BILL to amend and reenact §§ 29.1-102, 29.1-108, and 29.1-109 of the Code of Virginia, relating to the governance by the Board of Game and Inland Fisheries.

Be it enacted by the General Assembly of Virginia:

10 1. That §§ 29.1-102, 29.1-108, and 29.1-109 of the Code of Virginia are amended and reenacted as 11 follows:

§ 29.1-102. Board of Game and Inland Fisheries; how constituted; meetings.

The Commission of Game and Inland Fisheries is continued and shall hereafter be known as the 13 14 Board of Game and Inland Fisheries.

15 A. The Board shall consist of not more than one member from each congressional district. Each 16 member of the Board shall be appointed by the Governor, subject to confirmation by the General 17 Assembly. Members shall be appointed for terms of one to four years; however, appointments shall be made in a manner whereby no more than three members shall have terms which expire in the same 18 year. An appointment to fill a vacancy shall be made in the same manner, but only for the unexpired 19 20 term. No person shall be eligible to serve more than two consecutive four-year terms. Members may be 21 removed from office during their respective terms by the Governor.

22 B. The Board shall adopt rules and procedures for the conduct of its business that shall be set forth in a Governance Manual. The Board may establish committees to assist it with its duties and 23 24 responsibilities. All decisions by a committee shall be reviewed by the Board, and shall only take effect 25 if approved by the Board.

26 C. The Board shall elect one of its members as its chairman, who shall preside at all regular and 27 called meetings of the Board whose duties shall be limited to (i) presiding at all regular and called 28 meetings of the Board; (ii) serving as the Board liaison to the Director, other Board members, and the 29 Secretary of Natural Resources; and (iii) the other duties set forth in the Governance Manual as 30 approved by a majority of the Board. The Board shall also elect a vice chairman to preside in the absence of the chairman. Any additional duties of the vice chairman shall be set forth in the 31 32 Governance Manual. The Board shall annually elect one of its members as chairman and one of its 33 members as vice chairman. The chairmanship and vice chairmanship shall rotate annually among the 34 members of the Board.

35 D. The Board shall meet at least once every three months beginning July 1 of each quarter of the 36 calendar year for the transaction of business, and other meetings may be called if necessary by the 37 chairman or at the request of any three members. The majority of the members shall constitute a 38 quorum. In the event of unavoidable absence of the chairman, the members present shall designate some 39 other member to act in place of the chairman. Meetings shall be held in Richmond or at such other 40 places within the Commonwealth as may be expedient *necessary*.

§ 29.1-108. Audits and examinations.

42 The minute books and other records of the Board shall be open to examination by the Governor, 43 members of the General Assembly, and Auditor of Public Accounts, or their representatives, at all times. The accounts of the Board shall be audited in the manner provided for the audit of other state agencies. 44

In addition, the Board shall ensure that the Auditor of Public Accounts, or an entity approved by him, 45 conducts an annual audit of a fiscal and compliance nature of the accounts and transactions of the 46 Department. The Board may order such other audits as it deems necessary and desirable. 47 **48**

§ 29.1-109. Department of Game and Inland Fisheries; Director.

49 A. The Department of Game and Inland Fisheries shall exist to provide public, informational and educational services related to this title, and to serve as the agency responsible for the administration 50 51 and enforcement of all rules and regulations of the Board, the statutory provisions of this title, and related legislative acts. The Department shall employ scientific principles and procedures, as developed, 52 53 researched, recognized and accepted within the bounds of comprehensive professional wildlife resource 54 management, in the management of the Commonwealth's wildlife and natural resources.

55 B. The Board shall appoint a Director, subject to confirmation of the General Assembly, to head the Department and to act as principal administrative officer. In addition to the powers designated elsewhere 56 57 in this title, the Director shall have the power to:

1. Enforce or cause to be enforced all laws for the protection, propagation and preservation of game 58 59 birds and game animals of the Commonwealth and all fish in the inland waters thereof. Inland waters

shall include all waters above tidewater and the brackish and freshwater streams, creeks, bays, includingBack Bay, inlets, and ponds in the tidewater counties and cities.

62 2. Initiate prosecution of all persons who violate such laws, and seize and confiscate wild birds, wild63 animals and fish that have been illegally killed, caught, transported or shipped.

64 3. Employ persons necessary for the administrative requirements of the Board and to designate the 65 official position and duties of each. The salaries of all such employees shall be as provided in 66 accordance with law.

4. Perform such acts as may be necessary to the conduct and establishment of cooperative fish andwildlife projects with the federal government as prescribed by acts of Congress and in compliance withrules and regulations promulgated by the Secretary of the Interior.

5. Make and enter into all contracts and agreements necessary or incidental to the performance of his duties and the execution of his powers, including, but not limited to, contracts with the United States, other state agencies and governmental subdivisions of the Commonwealth.

6. When practicable, consult with, and keep informed, wildlife and boating constituent organizationsso as to benefit Virginia's wildlife and natural resources and accomplish the Department's mission.
