AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by the Joint Conference Committee
on March 9, 2006)

(Patron Prior to Substitute—Delegate McQuigg)

A BILL to amend and reenact §§ 20-108.1 and 20-108.2 of the Code of Virginia, relating to child support guidelines; factors used in determining child support.

Be it enacted by the General Assembly of Virginia:

1. That §§ 20-108.1 and 20-108.2 of the Code of Virginia are amended and reenacted as follows:

§ 20-108.1. Determination of child or spousal support.

A. In any proceeding on the issue of determining spousal support, the court shall consider all evidence presented relevant to any issues joined in that proceeding. The court's decision shall be rendered based upon the evidence relevant to each individual case.

B. In any proceeding on the issue of determining child support under this title or Title 16.1 or Title 63.2, the court shall consider all evidence presented relevant to any issues joined in that proceeding. The court's decision in any such proceeding shall be rendered upon the evidence relevant to each individual case. However, there shall be a rebuttable presumption in any judicial or administrative proceeding for child support, including cases involving split custody or shared custody, that the amount of the award which would result from the application of the guidelines set out in § 20-108.2 is the correct amount of child support to be awarded. Liability for support shall be determined retroactively for the period measured from the date that the proceeding was commenced by the filing of an action with any court provided the complainant exercised due diligence in the service of the respondent or, if earlier, the date an order of the Department of Social Services entered pursuant to Title 63.2 and directing payment of support was delivered to the sheriff or process server for service on the obligor.

In order to rebut the presumption, the court shall make written findings in the order, which findings may be incorporated by reference, that the application of such guidelines would be unjust or inappropriate in a particular case. The finding that rebuts the guidelines shall state the amount of support that would have been required under the guidelines, shall give a justification of why the order varies from the guidelines, and shall be determined by relevant evidence pertaining to the following factors affecting the obligation, the ability of each party to provide child support, and the best interests of the child:

1. Actual monetary support for other family members or former family members;
2. Arrangements regarding custody of the children, *including the cost of visitation travel*;
3. Imputed income to a party who is voluntarily unemployed or voluntarily under-employed; provided that income may not be imputed to the custodial parent when a child is not in school, child care services are not available and the cost of such child care services are not included in the computation and provided further, that any consideration of imputed income based on a change in a party's employment shall be evaluated with consideration of the good faith and reasonableness of employment decisions made by the party;

4. Debts of either party arising during the marriage for the benefit of the child;

5. ~~Debts incurred for production of income;~~

65. Direct payments ordered by the court for ~~health care coverage~~ maintaining life insurance coverage pursuant to subsection D, education expenses, or other court-ordered direct payments for the benefit of the child ~~and costs related to the provision of health care coverage pursuant to subdivision 7 of § 20-60.3;~~

76. Extraordinary capital gains such as capital gains resulting from the sale of the marital abode;

8. ~~Age, physical and mental condition of the child or children, including unreimbursed medical or dental expenses, and child-care expenses~~7. Any special needs of a child resulting from any physical, emotional, or medical condition;

98. Independent financial resources, ~~if any,~~ of the child or children;

109. Standard of living for the ~~family~~ child or children established during the marriage;

110. Earning capacity, obligations ~~and needs,~~ and financial resources, *and special needs* of each parent;

12. Education and training of the parties and the ability and opportunity of the parties to secure such education and training;

13. Contributions, monetary and nonmonetary, of each party to the well-being of the family;

111. Provisions made with regard to the marital property under § 20-107.3, *where said property earns income or has an income-earning potential*;

12. Tax consequences to the parties ~~regarding~~ *including* claims for exemptions, child tax credit,

61 ~~1613.~~ A written agreement, *stipulation, consent order, or decree* between the parties which includes
62 the amount of child support;

63 ~~17.~~ A *pendente lite decree*, which includes the amount of child support, agreed to by both parties or
64 by counsel for the parties; and

65 ~~1814.~~ Such other factors, *including tax consequences to each party*, as are necessary to consider the
66 equities for the parents and children.

67 C. In any proceeding under this title or Title 16.1 or Title 63.2 on the issue of determining child
68 support, the court shall have the authority to order a party to provide health care coverage, as defined in
69 § 63.2-1900, for dependent children if reasonable under all the circumstances and health care coverage
70 for a spouse or former spouse.

71 D. In any proceeding under this title, Title 16.1 or Title 63.2 on the issue of determining child
72 support, the court shall have the authority to order a party to (i) maintain any existing life insurance
73 policy on the life of either party provided the party so ordered has the right to designate a beneficiary
74 and (ii) designate a child or children of the parties as the beneficiary of all or a portion of such life
75 insurance for so long as the party so ordered has a statutory obligation to pay child support for the child
76 or children.

77 E. Except when the parties have otherwise agreed, in any proceeding under this title, Title 16.1 or
78 Title 63.2 on the issue of determining child support, the court shall have the authority to and may, in its
79 discretion, order one party to execute all appropriate tax forms or waivers to grant to the other party the
80 right to take the income tax dependency exemption for any tax year or future years, for any child or
81 children of the parties for federal and state income tax purposes.

82 *F. Notwithstanding any other provision of law, any amendments to this section shall not be*
83 *retroactive to a date before the effective date of the amendment, and shall not be the basis for a*
84 *material change in circumstances upon which a modification of child support may be based.*

85 § 20-108.2. Guideline for determination of child support; quadrennial review by Child Support
86 Guidelines Review Panel; executive summary.

87 A. There shall be a rebuttable presumption in any judicial or administrative proceeding for child
88 support under this title or Title 16.1 or 63.2, including cases involving split custody or shared custody,
89 that the amount of the award which would result from the application of the guidelines set forth in this
90 section is the correct amount of child support to be awarded. In order to rebut the presumption, the
91 court shall make written findings in the order as set out in § 20-108.1, which findings may be
92 incorporated by reference, that the application of the guidelines would be unjust or inappropriate in a
93 particular case as determined by relevant evidence pertaining to the factors set out in §§ ~~20-107.2 and~~
94 20-108.1. The Department of Social Services shall set child support at the amount resulting from
95 computations using the guidelines set out in this section pursuant to the authority granted to it in
96 Chapter 19 (§ 63.2-1900 et seq.) of Title 63.2 and subject to the provisions of § 63.2-1918.

97 B. For purposes of application of the guideline, a basic child support obligation shall be computed
98 using the schedule set out below. For combined monthly gross income amounts falling between amounts
99 shown in the schedule, basic child support obligation amounts shall be extrapolated. However, unless
100 one of the following exemptions applies where the sole custody child support obligation as computed
101 pursuant to subdivision G 1 is less than \$65 per month, there shall be a presumptive minimum child
102 support obligation of \$65 per month payable by the payor parent. Exemptions from this presumptive
103 minimum monthly child support obligation shall include: parents unable to pay child support because
104 they lack sufficient assets from which to pay child support and who, in addition, are institutionalized in
105 a psychiatric facility; are imprisoned with no chance of parole; are medically verified to be totally and
106 permanently disabled with no evidence of potential for paying child support, including recipients of
107 Supplemental Security Income (SSI); or are otherwise involuntarily unable to produce income. "Number
108 of children" means the number of children for whom the parents share joint legal responsibility and for
109 whom support is being sought.

320 C. For purposes of this section, "gross income" means all income from all sources, and shall include,
 321 but not be limited to, income from salaries, wages, commissions, royalties, bonuses, dividends, severance
 322 pay, pensions, interest, trust income, annuities, capital gains, social security benefits except as listed
 323 below, workers' compensation benefits, unemployment insurance benefits, disability insurance benefits,
 324 veterans' benefits, spousal support, rental income, gifts, prizes or awards.

325 If a parent's gross income includes disability insurance benefits, it shall also include any amounts
 326 paid to or for the child who is the subject of the order and derived by the child from the parent's
 327 entitlement to disability insurance benefits. To the extent that such derivative benefits are included in a
 328 parent's gross income, that parent shall be entitled to a credit against his or her ongoing basic child
 329 support obligation for any such amounts, and, if the amount of the credit exceeds the parent's basic child
 330 support obligations, the credit may be used to reduce arrearages.

331 Gross income shall be subject to deduction of reasonable business expenses for persons with income
 332 from self-employment, a partnership, or a closely held business. "Gross income" shall not include:

- 333 1. Benefits from public assistance and social services programs as defined in § 63.2-100;
- 334 2. Federal supplemental security income benefits;
- 335 3. Child support received; or
- 336 4. Income received by the payor from secondary employment income not previously included in
 337 "gross income," where the payor obtained the income to discharge a child support arrearage established
 338 by a court or administrative order and the payor is paying the arrearage pursuant to the order.
 339 "Secondary employment income" includes but is not limited to income from an additional job, from
 340 self-employment, or from overtime employment. The cessation of such secondary income upon the
 341 payment of the arrearage shall not be the basis for a material change in circumstances upon which a
 342 modification of child support may be based.

343
 344 For purposes of this subsection: (i) spousal support received shall be included in gross income and
 345 spousal support paid shall be deducted from gross income when paid pursuant to an order or written
 346 agreement and (ii) one-half of any self-employment tax paid shall be deducted from gross income.

347 Where there is an existing court or administrative order or written agreement relating to the child or
 348 children of a party to the proceeding, who are not the child or children who are the subject of the
 349 present proceeding, then there is a presumption that there shall be deducted from the gross income of

the party subject to such order or written agreement, the amount that the party is actually paying for the support of a child or children pursuant to such order or agreement.

Where a party to the proceeding has a natural or adopted child or children in the party's household or primary physical custody, and the child or children are not the subject of the present proceeding, there is a presumption that there shall be deducted from the gross income of that party the amount as shown on the Schedule of Monthly Basic Child Support Obligations contained in subsection B that represents that party's support obligation based solely on that party's income as being the total income available for the natural or adopted child or children in the party's household or primary physical custody, who are not the subject of the present proceeding. Provided, however, that the existence of a party's financial responsibility for such a child or children shall not of itself constitute a material change in circumstances for modifying a previous order of child support in any modification proceeding. Any adjustment to gross income under this subsection shall not create or reduce a support obligation to an amount which seriously impairs the custodial parent's ability to maintain minimal adequate housing and provide other basic necessities for the child, as determined by the court.

In cases in which retroactive liability for support is being determined, the court or administrative agency may use the gross monthly income of the parties averaged over the period of retroactivity.

D. Except for good cause shown or the agreement of the parties, in addition to any other child support obligations established pursuant to this section, any child support order shall provide that the parents pay in proportion to their gross incomes, as used for calculating the monthly support obligation, any reasonable and necessary unreimbursed medical or dental expenses that are in excess of \$250 for any calendar year for each child who is the subject of the obligation. The method of payment of those expenses shall be contained in the support order. Each parent shall pay his respective share of expenses as those expenses are incurred. Any amount paid under this subsection shall not be adjusted by, nor added to, the child support calculated in accordance with subsection G. For the purposes of this section, medical or dental expenses shall include but not be limited to eyeglasses, prescription medication, prosthetics, orthodontics, and mental health or developmental disabilities services, including but not limited to services provided by a social worker, psychologist, psychiatrist, counselor, or therapist.

E. Any costs for healthcare coverage as defined in § 63.2-1900 and dental care coverage, when actually being paid by a parent, to the extent such costs are directly allocable to the child or children, and which are the extra costs of covering the child or children beyond whatever coverage the parent providing the coverage would otherwise have, shall be added to the basic child support obligation.

F. Any child-care costs incurred on behalf of the child or children due to employment of the custodial parent shall be added to the basic child support obligation. Child-care costs shall not exceed the amount required to provide quality care from a licensed source. When requested by the noncustodial parent, the court may require the custodial parent to present documentation to verify the costs incurred for child care under this subsection. Where appropriate, the court shall consider the willingness and availability of the noncustodial parent to provide child care personally in determining whether child-care costs are necessary or excessive. Upon the request of either party, and upon a showing of the tax savings a party derives from child-care cost deductions or credits, the court shall factor actual tax consequences into its calculation of the child-care costs to be added to the basic child support obligation.

G. 1. Sole custody support. The sole custody total monthly child support obligation shall be established by adding (i) the monthly basic child support obligation, as determined from the schedule contained in subsection B, (ii) costs for health care coverage to the extent allowable by subsection E, and (iii) work-related child-care costs and taking into consideration all the factors set forth in subsection B of § 20-108.1. The total monthly child support obligation shall be divided between the parents in the same proportion as their monthly gross incomes bear to their monthly combined gross income. The monthly obligation of each parent shall be computed by multiplying each parent's percentage of the parents' monthly combined gross income by the total monthly child support obligation.

However, the monthly obligation of the noncustodial parent shall be reduced by the cost for health care coverage to the extent allowable by subsection E when paid directly by the noncustodial parent. Unreimbursed medical and dental expenses shall be calculated and allocated in accordance with subsection D.

2. Split custody support. In cases involving split custody, the amount of child support to be paid shall be the difference between the amounts owed by each parent as a noncustodial parent, computed in accordance with subdivision 1, with the noncustodial parent owing the larger amount paying the difference to the other parent. Unreimbursed medical and dental expenses shall be calculated and allocated in accordance with subsection D.

For the purpose of this section and § 20-108.1, split custody shall be limited to those situations where each parent has physical custody of a child or children born of the parents, born of either parent and adopted by the other parent or adopted by both parents. For the purposes of calculating a child support obligation where split custody exists, a separate family unit exists for each parent, and child

411 support for that family unit shall be calculated upon the number of children in that family unit who are
412 born of the parents, born of either parent and adopted by the other parent or adopted by both parents.
413 Where split custody exists, a parent is a custodial parent to the children in that parent's family unit and
414 is a noncustodial parent to the children in the other parent's family unit.

415 3. Shared custody support.

416 (a) Where a party has custody or visitation of a child or children for more than 90 days of the year,
417 as such days are defined in subdivision G 3 (c), a shared custody child support amount based on the
418 ratio in which the parents share the custody and visitation of any child or children shall be calculated in
419 accordance with this subdivision. The presumptive support to be paid shall be the shared custody
420 support amount, unless a party affirmatively shows that the sole custody support amount calculated as
421 provided in subdivision G 1 is less than the shared custody support amount. If so, the lesser amount
422 shall be the support to be paid. For the purposes of this subsection, the following shall apply:

423 (i) Income share. "Income share" means a parent's percentage of the combined monthly gross income
424 of both parents. The income share of a parent is that parent's gross income divided by the combined
425 gross incomes of the parties.

426 (ii) Custody share. "Custody share" means the number of days that a parent has physical custody,
427 whether by sole custody, joint legal or joint residential custody, or visitation, of a shared child per year
428 divided by the number of days in the year. The actual or anticipated "custody share" of the parent who
429 has or will have fewer days of physical custody shall be calculated for a one-year period. The "custody
430 share" of the other parent shall be presumed to be the number of days in the year less the number of
431 days calculated as the first parent's "custody share." For purposes of this calculation, the year may begin
432 on such date as is determined in the discretion of the court, and the day may begin at such time as is
433 determined in the discretion of the court. For purposes of this calculation, a day shall be as defined in
434 subdivision G 3 (c).

435 (iii) Shared support need. "Shared support need" means the presumptive guideline amount of needed
436 support for the shared child or children calculated pursuant to subsection B of this section, for the
437 combined gross income of the parties and the number of shared children, multiplied by 1.4.

438 (iv) Sole custody support. "Sole custody support" means the support amount determined in
439 accordance with subdivision G 1.

440 (b) Support to be paid. The shared support need of the shared child or children shall be calculated
441 pursuant to subdivision G 3 (a) (iii). This amount shall then be multiplied by the other parent's custody
442 share. To that sum for each parent shall be added the other parent's cost of health care coverage to the
443 extent allowable by subsection E, plus the other parent's work-related child-care costs to the extent
444 allowable by subsection F. This total for each parent shall be multiplied by that parent's income share.
445 The support amounts thereby calculated that each parent owes the other shall be subtracted one from the
446 other and the difference shall be the shared custody support one parent owes to the other, with the payor
447 parent being the one whose shared support is the larger. Unreimbursed medical and dental expenses
448 shall be calculated and allocated in accordance with subsection D.

449 (c) Definition of a day. For the purposes of this section, "day" means a period of 24 hours; however,
450 where the parent who has the fewer number of overnight periods during the year has an overnight
451 period with a child, but has physical custody of the shared child for less than 24 hours during such
452 overnight period, there is a presumption that each parent shall be allocated one-half of a day of custody
453 for that period.

454 (d) Minimum standards. Any calculation under this subdivision shall not create or reduce a support
455 obligation to an amount which seriously impairs the custodial parent's ability to maintain minimal
456 adequate housing and provide other basic necessities for the child. If the gross income of either party is
457 equal to or less than 150 percent of the federal poverty level promulgated by the U.S. Department of
458 Health and Human Services from time to time, then the shared custody support calculated pursuant to
459 this subsection shall not be the presumptively correct support and the court may consider whether the
460 sole custody support or the shared custody support is more just and appropriate.

461 (e) Support modification. When there has been an award of child support based on the shared
462 custody formula and one parent consistently fails to exercise custody or visitation in accordance with the
463 parent's custody share upon which the award was based, there shall be a rebuttable presumption that the
464 support award should be modified.

465 (f) In the event that the shared custody support calculation indicates that the net support is to be paid
466 to the parent who would not be the parent receiving support pursuant to the sole custody calculation,
467 then the shared support shall be deemed to be the lesser support.

468 H. The Secretary of Health and Human Resources shall ensure that the guideline set out in this
469 section is reviewed by October 31, 2001, and every four years thereafter, by the Child Support
470 Guidelines Review Panel, consisting of 15 members comprised of four legislative members and 11
471 nonlegislative citizen members. Members shall be appointed as follows: three members of the House
472 Committee for Courts of Justice, upon the recommendation of the chairman of such committee, to be

473 appointed by the Speaker of the House of Delegates in accordance with the principles of proportional
474 representation contained in the Rules of the House of Delegates; one member of the Senate Committee
475 for Courts of Justice, upon the recommendation of the chairman of such committee, to be appointed by
476 the Senate Committee on Rules; and one representative of a juvenile and domestic relations district
477 court, one representative of a circuit court, one representative of the Department of Social Services'
478 Division of Child Support Enforcement, three members of the Virginia State Bar, two custodial parents,
479 two noncustodial parents, and one child advocate, upon the recommendation of the Secretary of Health
480 and Human Resources, to be appointed by the Governor. The Panel shall determine the adequacy of the
481 guideline for the determination of appropriate awards for the support of children by considering current
482 research and data on the cost of and expenditures necessary for rearing children, and any other resources
483 it deems relevant to such review. The Panel shall report its findings to the General Assembly as
484 provided in the procedures of the Division of Legislative Automated Systems for the processing of
485 legislative documents and reports before the General Assembly next convenes following such review.

486 Legislative members shall serve terms coincident with their terms of office. Nonlegislative citizen
487 members shall serve at the pleasure of the Governor. All members may be reappointed. Appointments to
488 fill vacancies, other than by expiration of a term, shall be made for the unexpired terms. Vacancies shall
489 be filled in the same manner as the original appointments.

490 Legislative members shall receive such compensation as provided in § 30-19.12, and nonlegislative
491 citizen members shall receive such compensation for the performance of their duties as provided in
492 § 2.2-2813. All members shall be reimbursed for all reasonable and necessary expenses incurred in the
493 performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the costs of
494 compensation and expenses of the members shall be provided by the Department of Social Services.

495 The Department of Social Services shall provide staff support to the Panel. All agencies of the
496 Commonwealth shall provide assistance to the Panel, upon request.

497 The chairman of the Panel shall submit to the Governor and the General Assembly a quadrennial
498 executive summary of the interim activity and work of the Panel no later than the first day of 2006
499 regular session of the General Assembly and every four years thereafter. The executive summary shall
500 be submitted as provided in the procedures of the Division of Legislative Automated Systems for the
501 processing of legislative documents and reports and shall be posted on the General Assembly's website.
