6	A BILL to amend and reenact § 18.2-46.1 of the Code of Virginia, relating to criminal street gang;
7	definitions; penalty.
8	Be it enacted by the General Assembly of Virginia:
9	1. That § 18.2-46.1 of the Code of Virginia is amended and reenacted as follows:
10	§ 18.2-46.1. Definitions.
11	As used in this article unless the context requires otherwise or it is otherwise provided:
12	"Act of violence" means those felony offenses described in subsection A of § 19.2-297.1.
13	"Criminal street gang" means any ongoing organization, association, or group of three or more
14	persons, whether formal or informal, (i) which has as one of its primary objectives or activities the
15	commission of one or more criminal activities; (ii) which has an identifiable name or identifying sign or
16	symbol; and (iii) whose members individually or collectively have engaged in the commission of,
17	attempt to commit, conspiracy to commit, or solicitation of two or more predicate criminal acts, at least
18	one of which is an act of violence, provided such acts were not part of a common act or transaction.
19 20	"Predicate criminal act" means (i) an act of violence; (ii) any violation of § 18.2-42, 18.2-46.3,
20	18.2-51, 18.2-51.1, 18.2-52, 18.2-53, 18.2-55, 18.2-56.1, 18.2-57, 18.2-57.2, 18.2-59, 18.2-59, 18.2-109, 18.2-121, 18.2, 122, 18.2, 122, 18.2, 122, 18.2, 122, 18.2, 122, 18.2, 122, 18.2, 122, 18.2, 122, 18.2, 122, 18.2, 18.2, 122, 18.2, 18

20 27	2. That the provisions of this act may result in a net increase in periods of imprisonment or
28	commitment. Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation is at

least \$7,073 for periods of imprisonment in state adult correctional facilities and cannot be determined for periods of commitment to the custody of the Department of Juvenile Justice. 29
