VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact § 10.1-1602 of the Code of Virginia, relating to the required quorum for 3 the Virginia Recreational Facilities Authority.

Approved

Be it enacted by the General Assembly of Virginia: 6

7 1. That § 10.1-1602 of the Code of Virginia is amended and reenacted as follows: 8

§ 10.1-1602. Board of directors.

9 The Authority shall be governed by a board of directors consisting of 19 members who shall be 10 appointed as follows: two members of the Senate to be appointed by the Senate Committee on Rules; four members of the House of Delegates to be appointed by the Speaker of the House of Delegates in 11 accordance with the principles of proportional representation contained in the Rules of the House of 12 13 Delegates; and 13 nonlegislative citizen members to be appointed by the Governor, upon consideration of the recommendation of the River Foundation, if any, and subject to confirmation by the General 14 15 Assembly. Nonlegislative citizen members of the Authority shall be citizens of the Commonwealth.

Legislative members shall serve terms coincident with their terms of office. After the initial 16 staggering of terms, nonlegislative citizen members shall be appointed for a term of five years. 17 Vacancies in the membership of the Board shall be filled for the unexpired portion of the term in the 18 19 same manner as original appointments are made. All members may be reappointed.

20 Immediately after appointment, the directors shall enter upon the performance of their duties. The 21 Board shall annually elect a chairman and vice-chairman from its members, and shall also elect annually a secretary, who may or may not be a member of the Board. The Board may also elect other 22 23 subordinate officers who may or may not be members of the Board, as it deems proper. Ten Seven 24 directors shall constitute a quorum for the transaction of the business of the Authority, and no vacancy 25 in the membership of the Board shall impair the right of a quorum to exercise all the rights and perform 26 all the duties of the Authority. The Board may employ an executive director to direct the day-to-day 27 activities of the Authority and carry out the powers and duties delegated to him. The executive director 28 shall serve at the pleasure of the Board. The executive director and employees of the Authority shall be 29 compensated in the manner provided by the Board and shall not be subject to the provisions of the 30 Virginia Personnel Act (§ 2.2-2900 et seq.).

Legislative members of the Authority shall receive such compensation as provided in § 30-19.12, and 31 32 nonlegislative citizen members shall receive such compensation for the performance of their duties as 33 provided in § 2.2-2813. All members shall be reimbursed for all reasonable and necessary expenses 34 incurred in the performance of their duties as provided in §§ 2.2-2813 and 2.2-2825. Funding for the 35 costs of compensation and expenses of the members shall be provided by the Virginia Recreational 36 Facilities Authority.
