WHEREAS, since May 2001, Chip Snead has served with superior skill and assiduity as assistant
 city manager for operations, ably managing numerous city departments including Technology, General
 Services, Civic Facilities, Fire-Emergency Management Services, Public Works, Human Resources,

Environmental and Emergency Management, and Management and Budget; and
 WHEREAS, Chip Snead was an honored 2003 graduate of the Senior Executive Institute at the
 University of Virginia Weldon Cooper Center for Public Service; and
