WHEREAS, committed to improving the quality of life for all of the citizens of Culpeper, Giles Miller generously gave of his time and considerable talents as president of the Culpeper Chamber of Commerce and the Lions Club of Culpeper and he provided steadfast leadership as a revered member of the Culpeper Town Council for over 30 years; and WHEREAS, Giles Miller was widely known by several monikers, "Mr. Culpeper," "Mr. VMI," and

"Mr. Republican" and he took great pride in his notable distinction as VMI's oldest living alumnus; and

WHEREAS, Giles Miller was the only person in the history of VMI to serve as president of the Board of Visitors, the Alumni Association, and the Keydet Club and he was a spirited supporter of all of the VMI athletic teams, being inducted into their Sports Hall of Fame in recognition of his magnanimous service and generosity; and

WHEREAS, Giles Miller will be long remembered for his generosity and devotion to the Culpeper community, and to his cherished alma mater, VMI; and

WHEREAS, Giles Miller was devoted to his family and especially enjoyed time spent with his three granddaughters, five great-grandchildren, and numerous nieces and nephews; and

WHEREAS, Giles Miller will be missed and fondly remembered by his loving family, his countless friends and admirers, and the citizens of the Town of Culpepper; now, therefore, be it
