11	1. That §§ 18.2-181 and 18.2-182 of the Code of Virginia are amended and reenacted as follows:
12	§ 18.2-181. Issuing bad checks, etc., larceny.
13	Any person who, with intent to defraud, shall make or draw or utter or deliver any check, draft, or
14 15	order for the payment of money, upon any bank, banking institution, trust company, or other depository,
13 16	knowing, at the time of such making, drawing, uttering or delivering, that the maker or drawer has not sufficient funds in, or credit with, such bank, banking institution, trust company, or other depository, for
17	the payment of such check, draft or order, although no express representation is made in reference
18	thereto, shall be guilty of larceny; and, if this check, draft, or order has a represented value of \$200 or
19	more, such person shall be guilty of a Class 6 felony. In cases in which such value is less than \$200,
20	the person shall be guilty of a Class 1 misdemeanor.
21	The word "credit" as used herein, shall be construed to mean any arrangement or understanding with
22	the bank, trust company, or other depository for the payment of such check, draft or order.
23 24	Any person making, drawing, uttering or delivering any such check, draft or order for payment of
24 25	child or spousal support owed or owing or in payment as a present consideration for goods or services for the purposes set out in this section shall be guilty as provided herein.

28	Any person who shall make, draw, or utter, or deliver any check, draft, or order for the payment of
29	money, upon any bank, banking institution, trust company or other depository on behalf of any business
30	firm or corporation, for the purpose of paying wages to any employee of such firm or corporation, or
31	for the purpose of paying for any labor performed by any person for such firm or corporation, or for the
