Be it enacted by the General Assembly of Virginia:

8 That the Code of Virginia is amended by adding in Chapter 25 of Title 2.2 an article 1. 9 numbered 7.1, consisting of sections numbered 2.2-2524 through 2.2-2529 as follows: 10

Article 7.1.

Community Integration Advisory Commission.

§ 2.2-2524. The Community Integration Advisory Commission; purpose.

13 The Community Integration Advisory Commission (the Commission) is established as an advisory commission in the executive branch of state government. The purpose of the Commission shall be to 14 15 monitor the progress of all executive branch state agencies toward community integration of Virginians with disabilities in accordance with all applicable state and federal laws in order that persons with 16 17 disabilities may enjoy the benefits of society and the freedoms of daily living. 18

§ 2.2-2525. Membership; terms; quorum; meetings.

The Commission shall have a total membership of 21 nonlegislative citizen members to be appointed 19 20 as follows: four nonlegislative citizen members, of whom two shall be persons with disabilities, one shall 21 be the relative of a citizen of the Commonwealth with a disability, and one shall be a provider of 22 services to citizens of the Commonwealth with disabilities or an advocate for persons with disabilities or 23 for services to such persons to be appointed by the Senate Committee on Rules; six nonlegislative citizen 24 members, of whom three shall be persons with disabilities, one shall be the relative of a citizen of the 25 Commonwealth with a disability, and two shall be providers of services to citizens of the Commonwealth 26 with disabilities or an advocate for persons with disabilities or for services to such persons to be 27 appointed by the Speaker of the House of Delegates; and 11 nonlegislative citizen members, of whom 28 three shall be persons with disabilities, one shall be a resident of a state mental health facility, one 29 shall be a resident of a state mental retardation training facility, one shall be a resident of a nursing 30 facility, two shall be the relatives of citizens of the Commonwealth with disabilities, and three shall be 31 providers of services to citizens of the Commonwealth with disabilities or an advocate for persons with 32 disabilities or for services to such persons to be appointed by the Governor. Nonlegislative citizen 33 members of the Commission shall be citizens of the Commonwealth.

34 Nonlegislative citizen members shall serve a term of four years; however, no nonlegislative citizen 35 member shall serve more than two consecutive four-year terms. Appointments to fill vacancies, other than by expiration of a term, shall be for the unexpired terms. Vacancies shall be filled in the same 36 37 manner as the original appointments. All members may be reappointed. The remainder of any term to 38 which a member is appointed to fill a vacancy shall not constitute a term in determining the member's 39 eligibility for reappointment.

40 The Commission shall elect a chairman and vice-chairman from among its membership. A majority 41 of the members shall constitute a quorum. The Commission shall meet not less than four times each 42 year. The meetings of the Commission shall be held at the call of the chairman or whenever the 43 majority of the members so request.

44 § 2.2-2526. Compensation; expenses.

45 Members shall serve without compensation. However, all members shall be reimbursed for all reasonable and necessary expenses incurred in the performance of their duties as provided in 46 §§ 2.2-2813 and 2.2-2825. Funding for the costs of expenses of the members shall be provided by such 47 48 executive branch agencies as the Governor designates.

49 § 2.2-2527. Powers and duties of the Commission.

50 The Commission shall have the following powers and duties:

51 1. To monitor the implementation of state and federal laws pertaining to community integration of 52 Virginians with disabilities; and

53 2. To make appropriate recommendations to the Governor concerning community integration of 54 Virginians with disabilities.

55 § 2.2-2528. Staffing.

56 The Virginia Board for People with Disabilities, to the extent permitted by federal law, and such REENROLLED
