VIRGINIA ACTS OF ASSEMBLY - CHAPTER

An Act to amend the Code of Virginia by adding a section numbered 6.1-2.27:1, relating to the 3 Consumer Real Estate Settlement Protection Act; confidentiality of documents.

Approved

Be it enacted by the General Assembly of Virginia:

1. That the Code of Virginia is amended by adding a section numbered 6.1-2.27:1 as follows:

§ 6.1-2.27:1. Confidentiality of information obtained by the Commission.

9 A. Any documents, materials, or other information in the control or possession of the Commission 10 that are furnished by a title insurance company or title insurance agent or an employee thereof acting on behalf of the title insurance company or title insurance agent, or obtained by the Commission in an 11 12 investigation pursuant to this chapter shall be confidential by law and privileged, shall not be subject to 13 inspection or review by the general public, shall not be subject to subpoena, and shall not be subject to discovery or admissible in evidence in any private civil action. However, the Commission is authorized 14 15 to use the documents, materials, or other information in the furtherance of any regulatory or legal action brought as a part of the Commission's duties. 16

B. Neither the Commission nor any person who received documents, materials, or other information 17 18 while acting under the authority of the Commission shall be permitted or required to testify in any 19 private civil action concerning any confidential documents, materials, or information subject to 20 subsection A.

21 C. In order to assist in the performance of the Commission's duties under this chapter, the 22 Commission:

23 1. May share documents, material, or other information, including the confidential and privileged 24 documents, materials, or information subject to subsection A, with other state, federal, and international 25 regulatory agencies; with the National Association of Insurance Commissioners, hereafter referred to as 26 the Association, its affiliates or subsidiaries; and with state, federal, and international law enforcement 27 authorities, provided that the recipient agrees to maintain the confidentiality and privileged status of the 28 document, material, or other information; and

29 2. May receive documents, materials, or information, including otherwise confidential and privileged 30 documents, materials, or information, from the Association, its affiliates or subsidiaries and from 31 regulatory and law enforcement officials of other foreign or domestic jurisdictions, and shall maintain 32 as confidential or privileged any document, material, or information received with notice or the understanding that it is confidential or privileged under the laws of the jurisdiction that is the source of 33 34 the document, material, or information.

35 D. No waiver of any applicable privilege or claim of confidentiality in the documents, materials, or 36 information shall occur as a result of disclosure to the Commission under this section or as a result of 37 sharing as authorized in subsection C.

38 E. Nothing in this chapter shall prohibit the Commission from releasing final, adjudicated actions 39 including for-cause terminations that are open to public inspection pursuant to Chapter 4 (§ 12.1-18 et 40 seq.) of Title 12.1 to a database or other clearinghouse service maintained by the Association, its 41 affiliates, or subsidiaries.
