SENATE BILL NO. 330

FLOOR AMENDMENT IN THE NATURE OF A SUBSTITUTE

(Proposed by Senator Quayle

on February 14, 2006)

- (Patron Prior to Substitute—Senator Locke)
- A BILL to amend and reenact §§ 3.1-22.8, 15.2-6501, 62.1-67 of the Code of Virginia, relating to the appointment of legislators serving on the Chippokes Plantation Farm Foundation, the Tourist Train Development Authority, and the Potomac River Basin Commission.

Be it enacted by the General Assembly of Virginia:

1. That §§ 3.1-22.8, 15.2-6501, 62.1-67 of the Code of Virginia are amended and reenacted as 10 11 follows:

§ 3.1-22.8. Administration of Foundation; appointment and terms of board of trustees.

13 A. The Foundation shall be governed and administered by a board of trustees, consisting of 16 members as follows: two members of the House of Delegates, one of whom shall be a member of the 14 15 House Committee on Agriculture, Chesapeake and Natural Resources and one of whom shall represent Surry County, appointed by the Speaker of the House of Delegates; two members of the Senate, one of 16 17 whom shall be a member of the Senate Committee on Agriculture, Conservation and Natural Resources and one of whom shall represent Surry County, appointed by the Senate Committee on Rules; the 18 Commissioner of Agriculture and Consumer Services and the Director of the Department of 19 20 Conservation and Recreation who shall both serve ex officio, without voting privileges; and of fourteen 21 other 10 nonlegislative citizen members appointed by the Governor, subject to confirmation by the 22 General Assembly, as follows: --one member shall be appointed after conferring with the board of 23 supervisors of Surry County, which member may be either a member of said the board of supervisors or 24 from the county at large, for a term of four years; one member shall be appointed after conferring with 25 the dean of the College of Agriculture and Life Sciences at Virginia Polytechnic Institute and State University for a term of four years; and eight members shall be appointed from the Commonwealth 26 at-large for four-year terms. Legislative members, the Commissioner of Agriculture and Consumer 27 28 Services, and the Director of the Department of Conservation and Recreation shall serve terms 29 coincident with their terms of office. Members appointed by the Governor shall serve terms of four 30 years. Vacancies occurring before the expiration of term shall be filled for the unexpired term. All 31 members appointed may be reappointed.

32 B. Trustees of the Foundation shall be reimbursed for all reasonable and necessary expenses incurred 33 by them in the performance of their duties on behalf of the Foundation. Such reimbursement shall be 34 paid from the Chippokes Plantation Farm Foundation Fund.

35 C. The Foundation shall elect from its membership a chairman, vice-chairman, and such other 36 officers as it deems appropriate.

37 D. The chairman of the Board, the treasurer, and any other person designated by the Board to handle 38 the funds of the Foundation, shall give bond, with corporate surety, in such penalty as is fixed by the 39 Governor, conditioned upon the faithful discharge of his duties. The premium on the bonds shall be paid 40 from funds available to the Foundation.

§ 15.2-6501. Board of the Authority; qualifications; terms; quorum; records.

41 42 All powers, rights, and duties conferred by this chapter, or other provisions of law, upon the 43 Authority shall be exercised by the Board of the Tourist Train Development Authority, hereinafter referred to as "the board." Initial appointments to the board shall begin July 1, 2000. The board shall 44 consist of eight nine members appointed by the Governor as follows: seven members appointed by the 45 Governor of whom three shall be representatives from the governing bodies of Tazewell County, the 46 Town of Bluefield, Virginia, and the Town of Pocahontas; and four shall be nonlegislative citizen 47 members, who shall be residents of reside in Tazewell County; and one member of the General **48** 49 Assembly House of Delegates representing Tazewell County, who shall be appointed by the Speaker of the House of Delegates if more than one Delegate represents Tazewell County; and one member of the 50 51 Senate representing Tazewell County, who shall serve as an ex officio, voting member who shall be appointed by the Senate Committee on Rules if more than one Senator represents Tazewell County. All 52 53 members shall serve for a term of four years and may be reappointed for one additional term, except the 54 member appointed from the General Assembly legislative members, who shall serve no more than four years terms coincident with their terms of office and may be reappointed. The term of any member of 55 the board shall immediately terminate if the member no longer meets the eligibility criteria of the initial 56 appointment. Vacancies shall be filled for the unexpired term. For the initial appointments only, three of 57 the members shall be appointed for two-year terms and such initial terms shall not be counted toward 58 59 the term limitation.

The board shall elect from its membership a chairman, a vice-chairman, and from its membership or
not, as they desire, a secretary and a treasurer, or a secretary-treasurer, who shall continue to hold such
office until their respective successors are elected. The members of the board shall receive no salary *compensation.* All members may be reimbursed for reasonable and necessary expenses incurred in the *performance of their duties from such funds as may be available to the Authority.*

65 Four members of the board shall constitute a quorum of the board for the purposes of conducting its 66 business and exercising its powers and for all other purposes. No vacancy in the membership of the board shall impair the right of a quorum to exercise all the powers and perform all the duties of the 67 board. The board shall keep detailed minutes of its proceedings, which shall be open to public **68** inspection at all times. It shall keep suitable records of its financial transactions and, unless exempted by 69 § 30-140, it shall arrange to have the records audited annually. Copies of each such audit shall be 70 71 furnished to the governing bodies of Tazewell County and all adjacent counties and the Auditor of 72 Public Accounts and shall be open to public inspection.

§ 62.1-67. Appointment, terms and qualifications of members; alternate members.

74 If and when the Governor shall have executed such compact, The Commission shall consist of three 75 members of the Commission shall be as follows: one legislative member of the Commission on Intergovernmental Cooperation who resides in the Potomac River drainage basin appointed by the Joint 76 Rules Committee, one nonlegislative citizen member appointed by the Governor and shall hold office for 77 78 terms of four years each, subject to suspension or removal by the Governor who resides in the Potomac 79 River drainage basin, and the executive director of the State Water Control Board. Appointments to fill vacancies shall be made for the respective unexpired terms. Two of the members so appointed shall be 80 residents of the Potomac River drainage basin, one of whom shall be a legislative member of the 81 Commission on Intergovernmental Cooperation, but if either member should cease to be a resident of 82 83 the basin his term of office shall thereupon terminate and his office shall become vacant. The executive director of the State Water Control Board shall serve as the third member. One of the members shall be 84 85 designated by the Governor as chairman. The Governor and the Joint Rules Committee shall appoint 86 alternate members for the members of their appointees to the Commission, and each alternate shall have 87 power to act in the absence of the person for whom he is alternate. The Governor shall appoint the first alternates hereunder on or before July 1, 1962, the The legislative member and executive director of the 88 89 State Water Control Board shall serve terms coincident with their terms of office and the member 90 appointed by the Governor shall serve a term of four years. The terms of each alternate to shall run 91 concurrently with the term of the member for whom he is alternate. All members may be reappointed. 92 2.
