That § 10.1-1142 of the Code of Virginia is amended and reenacted as follows: 11 12 § 10.1-1142. Regulating the burning of woods, brush, etc.; penalties. 13 A. It shall be unlawful for any owner or lessee of land to set fire to, or to procure another to set fire 14 to, any woods, brush, logs, leaves, grass, debris, or other inflammable material upon such land unless he previously has taken all reasonable care and precaution, by having cut and piled the same or carefully 15 16 cleared around the same, to prevent the spread of such fire to lands other than those owned or leased by him. It shall also be unlawful for any employee of any such owner or lessee of land to set fire to or to 17 procure another to set fire to any woods, brush, logs, leaves, grass, debris, or other inflammable 18 19 material, upon such land unless he has taken similar precautions to prevent the spread of such fire to 20 any other land. 21 B. Except as provided in subsection C, during the period February 15 through April 30 of each year, even though the precautions required by the foregoing subsection have been taken, it shall be unlawful, 22 23 in any county or city or portion thereof organized for forest fire control under the direction of the State 24 Forester, for any person to set fire to, or to procure another to set fire to, any brush, leaves, grass, 25 debris or field containing dry grass or other inflammable material capable of spreading fire, located in or within 300 feet of any woodland, brushland, or field containing dry grass or other inflammable material, 26 27 except between the hours of 4:00 p.m. and 12:00 midnight. The provisions of this subsection shall not apply to any fires which may be set on federal lands. 28 29 C. Subsection B shall not apply to any fire set between during the period beginning February 15 and 30 March 1 through April 30 of each year, if: 31 1. The fire is set for "prescribed burning" that is conducted in accordance with a "prescription" and managed by a "certified prescribed burn manager" as those terms are defined in § 10.1-1150.1; 2. The burn is conducted in accordance with § 10.1-1150.4; 32 33 34 3. The State Forester has, prior to February 1, approved the prescription for the burn; and 4. The burn is being conducted for one of the following purposes: (i) control of exotic and invasive 35 36 plant species that cannot be accomplished at other times of the year; (ii) wildlife habitat establishment 37 and maintenance that cannot be accomplished at other times of the year; or (iii) management necessary for natural heritage resources. 38 39 The State Forester may on the day of any burn planned to be conducted pursuant to this subsection 40 revoke his approval of the prescription for the burn if hazardous fire conditions exist. The State Forester may revoke the certification of any certified prescribed burn manager who violates any provision of this 41 42 subsection. 43 D. Any person who builds a fire in the open air, or uses a fire built by another in the open air, within 150 feet of any woodland, brushland or field containing dry grass or other inflammable material, 44 shall totally extinguish the fire before leaving the area and shall not leave the fire unattended. 45 E. Any person violating any provisions of this section shall be guilty of a Class 3 misdemeanor for 46 47 each separate offense. If any forest fire originates as a result of the violation by any person of any provision of this section, such person shall, in addition to the above penalty, be liable to the 48 49 Commonwealth for the full amount of all expenses incurred by the Commonwealth in suppressing such fire. Such amounts shall be recoverable by action brought by the State Forester in the name of the 50 Commonwealth on behalf of the Commonwealth and credited to the Forestry Operations Fund. 51
