That the Code of Virginia is amended by adding a section numbered 18.2-248.8 as follows: 11 12 § 18.2-248.8. Sale of the methamphetamine precursors ephedrine and pseudoephedrine; penalty. 13 A. The sale of any product containing ephedrine, pseudoephedrine, or any of their salts, isomers, or 14 salts of isomers, alone or in a mixture, shall be restricted when provided or sold by a retail distributor 15 or pharmacy as follows: 16 1. Retail sales shall be limited to three individual packages and no more than nine grams total of either ephedrine or pseudoephedrine per transaction. 17 2. Retail personnel shall be instructed in special procedures to be used in the sale of drug products 18 19 containing ephedrine or pseudoephedrine. 20 3. When any substance in which ephedrine or pseudoephedrine is the only active ingredient is 21 provided or sold: 22 a. The product shall only be displayed for sale behind a store counter that is not accessible to 23 consumers, or in a locked case that requires assistance by a store employee for customer access; 24 b. Any person purchasing, receiving, or otherwise acquiring any such substance shall, prior to taking 25 possession, present photo identification issued by a government or an educational institution; 26 c. The seller shall record in a written or electronic log the purchaser's name, quantity sold, and the 27 date of the transaction; and 28 d. The purchaser shall sign the record acknowledging an understanding of the applicable sales limit. 29 4. Records of ephedrine and pseudoephedrine transactions shall be maintained by the establishment 30 for at least one year from the date of each purchase. Using or disclosing the information in the log for 31 any purpose other than to ensure compliance with this section or to facilitate a product recall necessary to protect public health and safety is prohibited. However, disclosure of the information in the log to 32 33 law-enforcement personnel is required upon request. 34 5. When any substance is provided or sold in which ephedrine or pseudoephedrine is one of two or 35 more active ingredients: 36 a. The product may only be displayed for sale behind a store counter that is not accessible to 37 consumers, or in a locked case that requires assistance by a store employee for customer access, or 38 b. The product may be sold from the sales floor if the retailer adopts at least one of the following 39 four options: 40 (1) The product shall be kept within 30 feet and direct line of sight of a cash register or store 41 counter staffed by one or more store employees; (2) Reliable anti-theft devices are used on packages of the product; 42 (3) Restricted access shelving is used so that only one package of the product may be removed by a 43 consumer at a time and a delay of at least 15 seconds occurs between package replacement on the 44 45 shelf: or 46 (4) The product is kept under constant video surveillance. 47 B. This section does not apply to: 1. Any quantity of such substance properly dispensed under a valid prescription; 48 49 2. Liquid, liquid capsule, and gel capsule products containing pseudoephedrine; or 50 3. Pediatric products containing pseudoephedrine or ephedrine, their salts or optical isomers, or 51 salts of optical isomers if the pediatric product: 52 a. Is primarily intended for administration to children under 12 years of age, according to label 53 instructions, and is either in solid dosage form with individual dosage units not exceeding 15 milligrams 54 of ephedrine or pseudoephedrine; or in liquid form and recommended dosage units do not exceed 15 55 milligrams of ephedrine or pseudoephedrine per five milliliters of liquid product; or b. Is in liquid form primarily intended for administration to children under two years of age with a 56 recommended dosage not exceeding two milliliters, and the total package contains not more than one 57 58 fluid ounce.
