SENATE JOINT RESOLUTION NO. 246

Offered February 20, 2006

Commending Bristol, Virginia, on the occasion of its 150th anniversary.

6 WHEREAS, the border town of Bristol, Virginia-Tennessee, was founded in the year 1852 by Joseph
7 Rhea Anderson; and

8 WHEREAS, when Joseph Rhea Anderson realized that the railroad was coming to the area, he
9 bought 100 acres of land where two railroad surveys met and laid out the land for the original town of
10 Bristol; lots were sold and building began in 1853; and

WHEREAS, Bristol, Tennessee, was incorporated on February 22, 1856, and the town of Goodson,
 composed of Bristol, Virginia, and Goodsonville was incorporated on March 5, 1856, in Virginia; and

WHEREAS, the Virginia and Tennessee Railroads reached Bristol in the summer of 1856 and the
 East Tennessee and Virginia Railroad reached Bristol from the southwest in 1858, so for many years
 Bristol was served by two railroad depots; and

WHEREAS, Bristol flourished with the addition of the residential areas of Solar Hill and Virginia
 Hill, and by 1900 the population had grown to 10,000 citizens; and

18 WHEREAS, in 1881, both states claimed State Street at the heart of the city as its border, and 10
19 years later the state line debate was finally settled by an extensive survey by the federal government and
20 a decision by the Supreme Court of Virginia; and

WHEREAS, in 1927, Ralph Peer of the Victor Talking Machine Company came to Bristol to look
 for country music talent on the recommendation of Mountain Music recording artist "Pop" Stoneman;
 and

WHEREAS, the historic "Bristol Sessions" launched the careers of the Carter Family, the Stonemans,
and Jimmie Rodgers, all of whom became the pioneers of modern country music; historians refer to the
artistic explosion resulting from the emergence of these renowned artists in American culture as the "Big
Bang" of country music; and

WHEREAS, Bristol was also home of Country Music Hall of Fame inductee and popular entertainer, Tennessee Ernie Ford; and

WHEREAS, the theme for the 1956 Bristol Centennial was a "Tale of Two Cities," and the celebration was one of the grandest events in the history of the twin cities; and

32 WHEREAS, Bristol residents and visitors enjoyed a festive 10-week celebration from May 26 to 33 August 4 orchestrated by a professional production company, the John Rogers Producing Company; and

WHEREAS, in 1960, two Bristol natives, Larry Carrier and Carl Moore decided to build a stock carrace track in Northeast Tennessee modeled after Charlotte Motor Speedway; and

WHEREAS, what was known as Bristol International Speedway was completed in 1961 and
eventually sold to Bruton Smith, owner of Charlotte Motor Speedway; by 1996, the track's name was
officially changed to Bristol Motor Speedway; and when 15,000 seats were added in August 1996,
seating capacity soared to 86,000, eventually making the speedway one of the most popular events on
the NASCAR circuit; and

WHEREAS, in 1998, the United States Congress named Bristol the "Official Birthplace of Country
 Music," bringing national attention and acclaim to the twin cities; and

WHEREAS, country music and NASCAR are the heart and soul of the City of Bristol, a favoritedestination for countless tourists and fans across the nation; and

WHEREAS, beginning in the 1990s, Bristol began preserving its cherished historic landmarks,
beginning with the beautiful Paramount Theatre and including renovation of the Old Customs House and
the historic Train Station; and

48 WHEREAS, revitalization projects in downtown Bristol and the opening of the new Bristol Public
49 Library have provided new vigor to downtown Bristol, inspiring future growth and prosperity that will
50 extend beyond the sesquicentennial year celebration into the future; and

51 WHEREAS, an array of festivities and commemorative events are planned for both cities with the 52 theme "Celebrating 150 Years of Heritage & Harmony"; now, therefore, be it

53 RESOLVED by the Senate, the House of Delegates concurring, That the General Assembly 54 commend and congratulate Bristol, Virginia, on the occasion of its 150th anniversary; and, be it

55 RESOLVED FURTHER, That the Clerk of the Senate prepare a copy of this resolution for
 56 presentation to representatives of the City of Bristol, Virginia, as an expression of the General
 57 Assembly's best wishes for a joyful anniversary celebration.
