**7. Budget amendment necessary:** Yes. If this bill is approved, the coverage for the affected employees would begin and the Department of Juvenile Justice would be charged the higher VaLORS contribution rate effective July 1, 2006. This bill would require a budget amendment for FY07.

**8. Fiscal implications:** The *Code of Virginia* requires the VRS to set contribution rates every two years. The costs associated with this bill would accrue in FY07 and would be recognized as an increase in the employer contribution rates beginning in FY09.

**9. Specific agency or political subdivisions affected:** VRS and the Department of Juvenile Justice

**10. Technical amendment necessary:** No

**11. Other comments:** In 1999, the General Assembly and Governor approved the establishment of the Virginia Law Officers' Retirement System (VALORS) to provide benefits equivalent to state police officers to certain other law enforcement positions. The law was effective October 1, 1999 and the benefit structure was amended in 2001. There have been multiple bills introduced over the last several General Assembly sessions that proposed adding additional groups to those groups eligible for benefits under the VALORS. VRS continues to recommend that before any other groups of employees are included under VALORS, the General Assembly consider the criteria it will use to determine future eligibility. Failure to have an established and consistent policy for inclusion of members in VALORS may result in employee initiated suits for inclusion that will leave the Commonwealth with no valid defense.
