4. Title Community Integration and Implementation Team; established; purpose.

5. Summary/Purpose:

The bill establishes the Community Integration and Implementation Team to assist in ongoing progress by all executive branch state agencies toward community integration of Virginians with disabilities. Membership of the Team consists of representatives from 24 state agencies. The Team is responsible for developing a comprehensive and cross-governmental strategic plan and annually reporting to the Governor on the status of community integration of Virginians with disabilities. The bill also establishes a position of Special Advisor to the Governor for Community Integration for Virginians with Disabilities who serves as chairman of the Team. In addition, the bill establishes a Community Integration Advisory Board to advise the Team in developing and updating a comprehensive and cross-governmental strategic plan.

8. Fiscal implications: The language requires the creation of an advisor's position and the appropriate support to carry out the directives in the Committee's strategic plan. The estimated cost includes funding for the advisor's salary, a policy analyst and necessary office, equipment, and travel costs associated with the establishment of the community integration team. The House substitute version would require the Virginia Board for People with Disabilities be responsible for compensation of the new board's members. The Governor's introduced bill included \$233,398 in the Department of Mental Health, Mental Retardation and Substance Abuse Services to provide funding for the Committee. The House substitute version of the bill includes a sunset clause effective in Fiscal Year 2010.

- **9. Specific agency or political subdivisions affected:** Department of Mental Health, Mental Retardation and Substance Abuse; Virginia Board for People with Disabilities
- **10. Technical amendment necessary:** An enactment clause should be added to the bill such as: That this act, for which general fund dollars are required, shall not take effect unless a specific appropriation has been included to support the provisions of this act within a general appropriation act taking effect July 1, 2006, that has been approved by the General Assembly and signed by the Governor.
