4.	Title	Creates the Private College Enrollment Grant Program

5. Summary/Purpose: The proposed legislation creates the Private College Enrollment Grant Program for the purpose of providing higher education grants on a per capita basis to private nonprofit institutions of higher education that agree, in the interest of providing access to higher education for Virginia's growing student population and to enroll Virginia domiciles.

The bill establishes a special nonreverting fund on the books of the State Comptroller. Any funds appropriated by the General Assembly or gifts, grants, or donations received from public or private sources will be credited to the Fund. Interest earned on the moneys shall be credited to the Fund. Moneys remaining in the Fund, including interest, at the end of each fiscal year shall not revert to the general fund.

The State Council of Higher Education for Virginia is designated as the administering agency of the program and is authorized to solicit or receive unsolicited grant proposals and enter into contracts with private accredited nonprofit institutions of higher education having their main campus in Virginia to provide grants on a per capita basis to such institutions on behalf of enrolled Virginia domiciles. The Council is also authorized to promulgate necessary and appropriate regulations to administer the program, including measures to ensure the reduction of out-of-pocket tuition costs to Virginia's student population.

- **7. Budget amendment necessary:** Yes. If the legislation is approved, the State Council of Higher Education will need a budget amendment to fund additional staffing costs (Item 145).
- **8. Fiscal implications:** This bill provides another avenue to encourage Virginia students to attend private institutions and help the Commonwealth provide greater access to higher education. As written, the bill creates a second student financial aid program for students attending private colleges and universities. Currently, the Commonwealth provides just over \$45.0 million under the Tuition Assistance Grant program (TAG) which provides grants to Virginia students attending private institutions of higher education in Virginia.

According to the State Council of Higher Education, if the program follows the administrative model of the Tuition Assistance Grant program, then the staffing issues can be kept to a minimum. The State Council estimates it will require additional staff support, from a half-time to a full position, to administer the program. If reviewing applications is included

as part of the program, the State Council estimates two additional staff positions will be required. The resources needed to support the program range from \$35,000 to \$150,000, depending program requirement to administer the new program.

Beyond staffing needs, the bill does not provide specific goals to which an expected expenditure could be estimated, so the cost of the program is equivalent to the amount that the General Assembly appropriates to increase participation of private institutions in reaching state goals for education.
