

1 VIRGINIA ACTS OF ASSEMBLY — CHAPTER

2 An Act to amend and reenact § 2.2-2101 of the Code of Virginia, as it is currently effective and as it  
3 shall become effective, and to amend the Code of Virginia by adding in Chapter 25 of Title 2.2 an  
4 article numbered 8, consisting of sections numbered 2.2-2530 and 2.2-2531, relating to the creation  
5 of the Commission on Immigration.

8 Be it enacted by the General Assembly of Virginia:

9 1. That § 2.2-2101 of the Code of Virginia, as it is currently effective and as it shall become  
10 effective, is amended and reenacted and that the Code of Virginia is amended by adding in  
11 Chapter 25 of Title 2.2 an article numbered 8, consisting of sections numbered 2.2-2530 and  
12 2.2-2531, as follows:

13 § 2.2-2101. (Effective until July 1, 2008) Prohibition against service by legislators on boards,  
14 commissions, and councils within the executive branch; exceptions.

15 Members of the General Assembly shall be ineligible to serve on boards, commissions, and councils  
16 within the executive branch of state government who are responsible for administering programs  
17 established by the General Assembly. Such prohibition shall not extend to boards, commissions, and  
18 councils engaged solely in policy studies or commemorative activities. If any law directs the  
19 appointment of any member of the General Assembly to a board, commission, or council in the  
20 executive branch of state government that is responsible for administering programs established by the  
21 General Assembly, such portion of such law shall be void, and the Governor shall appoint another  
22 person from the Commonwealth at large to fill such a position.

23 The provisions of this section shall not apply to members of the Board for Branch Pilots, who shall  
24 be appointed as provided for in § 54.1-901; to members of the Council on Indians, who shall be

48 § 2.2-2101. (Effective July 1, 2008) Prohibition against service by legislators on boards,

83 Virginia Commission on Immigration.

84 § 2.2-2530. Virginia Commission on Immigration; purpose; membership, terms, compensation; staff.

85 A. *The Virginia Commission on Immigration (the Commission) is established as an advisory*  
86 *commission within the meaning of § 2.2-2100 in the executive branch of state government. The purpose*  
87 *of the Commission is to study, report, and make recommendations to address the costs and benefits of*  
88 *immigration on the Commonwealth, including the impact on education, health care, law enforcement,*  
89 *local demands for services and the economy, and the effect on the Commonwealth of federal*  
90 *immigration and funding policies. The Commission may make recommendations and coordinate the*  
91 *proposals of all commissions and agencies related to this purpose.*

92 B. *The Commission shall consist of 20 members as follows: five members of the House of Delegates*  
93 *to be appointed by the Speaker of the House of Delegates in accordance with the rules of proportional*  
94 *representation contained in the Rules of the House of Delegates; three members of the Senate to be*  
95 *appointed by the Senate Committee on Rules; one nonlegislative citizen member to be appointed by the*  
96 *Speaker of the House of Delegates and one nonlegislative citizen member to be appointed by the Senate*  
97 *Committee on Rules who each may be, but are not required to be, a person with business, education,*  
98 *health care or law enforcement experience; and 10 nonlegislative citizen members to be appointed by*  
99 *the Governor to include the following: (i) one naturalized citizen who is a resident of the*  
100 *Commonwealth; (ii) one resident of the Commonwealth who holds a permanent resident visa issued by*  
101 *the United States Department of State; (iii) one representative of a faith-based organization providing*  
102 *services to immigrants; (iv) one small business owner; (v) one representative of a local school division*  
103 *with a significant enrollment in English as a Second Language programs; (vi) one health care provider;*  
104 *(vii) one representative of local law enforcement; (viii) one person with knowledge and expertise in*  
105 *immigration law; (ix) one current or former member of a federal law-enforcement agency with*  
106 *jurisdiction over terrorism or homeland security issues; and (x) one representative of a local social*  
107 *services agency or health department. In its deliberations, the Commission shall provide for the*  
108 *contributions and participation of the Superintendent of State Police, the Commissioner of the*  
109 *Department of Motor Vehicles, the Director of the Department of Corrections, the Superintendent of*  
110 *Public Instruction, the Commissioner of the Department of Social Services and the Commissioner of the*  
111 *Department of Health, or their designees. These persons shall contribute and participate in the manner*  
112 *deemed appropriate by the Commission in the furtherance of its work.*

113 C. *Nonlegislative members of the Commission shall serve two-year terms. Legislative members shall*  
114 *serve terms coincident with their terms of office, and any vacancy shall be filled in the original manner*  
115 *of appointment. Vacancies for unexpired terms shall be filled in the same manner as the original*  
116 *appointments.*

117 D. *The members of the Commission shall elect a chairman and vice-chairman from among its*

118 members. A majority of the members shall constitute a quorum.

119 E. Legislative members of the Commission shall receive compensation as provided in § 30-19.12, and  
120 all members shall be reimbursed for all reasonable and necessary expenses incurred in the discharge of  
121 their duties as provided in §§ 2.2-2813 and 2.2-2825. All reimbursable expenses shall be paid from  
122 existing appropriations to the Commission.

123 F. Staff to the Commission shall be provided by the office of the Secretary of Health and Human  
124 Resources. Technical assistance shall be provided by the Joint Legislative Audit and Review  
125 Commission, and the Department of Planning and Budget. All agencies of the Commonwealth shall  
126 provide assistance to the Commission, upon request.

127 G. As used in this article:

128 "Immigrant" means any individual not a citizen or national of the United States, whether or not  
129 lawfully admitted for permanent residence in the United States.

130 "Lawfully admitted for permanent residence" means the status of having been lawfully accorded the  
131 privilege of residing permanently in the United States as an immigrant in accordance with the  
132 immigration laws, such status not having changed.

133 § 2.2-2531. Powers and duties of the Commission.

134 A. The Commission shall have the power and duty to gather and analyze information and data to  
135 accomplish its purpose as set forth in § 2.2-2530.

136 B. The Commission shall submit to the Governor and the General Assembly an annual report for  
137 publication as a report document as provided in the procedures of the Division of Legislative Automated  
138 Systems for the processing of legislative documents and reports. The Commission shall also make such  
139 interim reports as it deems advisable. The chairman shall submit to the Governor and the General  
140 Assembly an annual executive summary of the interim activity and work of the Commission no later than  
141 the first day of each regular session of the General Assembly. The executive summary shall be submitted  
142 for publication as a report document as provided in the procedures of the Division of Legislative  
143 Automated Systems for the processing of legislative documents and reports and shall be posted on the  
144 General Assembly's website.

145 **2. For its first year of existence, if the Commission is not funded by a separate appropriation in**  
146 **the Appropriation Act, compensation and reimbursement of expenses for legislative members of**  
147 **the Commission may be funded from the operating budgets of the Clerk of the House of Delegates**  
148 **and the Clerk of the Senate upon the approval of the Joint Rules Committee. If the Commission**  
149 **is not funded by a separate appropriation in the Appropriation Act for any year thereafter, this**  
150 **chapter shall expire on July 1 of the fiscal year that the Commission fails to receive such funding.**

151 **3. That the provisions of this act shall expire on August 1, 2009.**
