4 5 6 A BILL to amend and reenact § 2.2-2101 of the Code of Virginia, as it is currently effective and as it 7 shall become effective, and to amend the Code of Virginia by adding in Chapter 25 of Title 2.2 an 8 article numbered 8, consisting of sections numbered 2.2-2530 and 2.2-2531, relating to the creation 9 of the Commission on Immigration. 10

Be it enacted by the General Assembly of Virginia:

11 1. That § 2.2-2101 of the Code of Virginia, as it is currently effective and as it shall become effective, is amended and reenacted and that the Code of Virginia is amended by adding in 12 Chapter 25 of Title 2.2 an article numbered 8, consisting of sections numbered 2.2-2530 and 13 2.2-2531, as follows: 14

15 § 2.2-2101. (Effective until July 1, 2008) Prohibition against service by legislators on boards, 16 commissions, and councils within the executive branch; exceptions.

17 Members of the General Assembly shall be ineligible to serve on boards, commissions, and councils within the executive branch of state government who are responsible for administering programs 18 established by the General Assembly. Such prohibition shall not extend to boards, commissions, and 19 20 councils engaged solely in policy studies or commemorative activities. If any law directs the appointment of any member of the General Assembly to a board, commission, or council in the 21 22 executive branch of state government that is responsible for administering programs established by the 23 General Assembly, such portion of such law shall be void, and the Governor shall appoint another 24 person from the Commonwealth at large to fill such a position.

Virginia Commission on Immigration.

§ 2.2-2530. Virginia Commission on Immigration; purpose; membership, terms, compensation; staff.

87 A. The Virginia Commission on Immigration (the Commission) is established as an advisory 88 commission within the meaning of § 2.2-2100 in the executive branch of state government. The purpose 89 of the Commission is to study, report, and make recommendations to address the costs and benefits of 90 immigration on the Commonwealth, including the impact on education, health care, law enforcement, 91 local demands for services and the economy, and the effect on the Commonwealth of federal 92 immigration and funding policies. The Commission may make recommendations and coordinate the 93 proposals of all commissions and agencies related to this purpose.

94 B. The Commission shall consist of 20 members as follows: five members of the House of Delegates 95 to be appointed by the Speaker of the House of Delegates in accordance with the rules of proportional 96 representation contained in the Rules of the House; three members of the Senate to be appointed by the 97 Senate Committee on Rules; and 12 members to be appointed by the Governor to include the following: 98 (i) a naturalized citizen who is a resident of the Commonwealth; (ii) a resident of the Commonwealth 99 who holds a permanent resident visa issued by the United States Department of State; (iii) a 100 representative of a faith-based organization providing services to immigrants; (iv) a health care provider; (v) a small business owner; (vi) a representative of a large Virginia employer; (vii) a 101 102 representative of a local school division with a significant enrollment in English as a Second Language 103 programs; (viii) a representative of the Virginia State Police; (ix) a representative of local law enforcement; (x) a person with knowledge and expertise in immigration law; (xi) a current or former 104 member of a federal law-enforcement agency with jurisdiction over terrorism or homeland security 105 issues; and (xii) a representative of a local social services agency or health department. In its 106 deliberations, the Commission shall provide for the contributions and participation of the Commissioner 107 108 of the Department of Motor Vehicles, the Director of the Department of Corrections, the Superintendent 109 of Public Instruction, the Commissioner of the Department of Social Services and the Commissioner of the Department of Health, or their designees. These persons shall contribute and participate in the 110 111 manner deemed appropriate by the Commission in the furtherance of its work.

112 C. Nonlegislative members of the Commission shall serve two-year terms. Legislative members shall 113 serve terms coincident with their terms of office, and any vacancy shall be filled in the original manner 114 of appointment. Vacancies for unexpired terms shall be filled in the same manner as the original appointments. 115

D. The members of the Commission shall elect a chairman and vice-chairman from among its 116 117 members. A majority of the members shall constitute a quorum.

118 E. Legislative members of the Commission shall receive compensation as provided in § 30-19.12, and 119 all members shall be reimbursed for all reasonable and necessary expenses incurred in the discharge of 120 their duties as provided in § 2.2-2825. All reimbursable expenses shall be paid from existing appropriations to the Commission. 121

126 *G. As used in this article:*

127 "Immigrant" means any individual not a citizen or national of the United States, whether or not 128 lawfully admitted for permanent residence in the United States.

129 "Lawfully admitted for permanent residence" means the status of having been lawfully accorded the
130 privilege of residing permanently in the United States as an immigrant in accordance with the
131 immigration laws, such status not having changed.

132 § 2.2-2531. Powers and duties of the Commission.

A. The Commission shall have the power and duty to gather and analyze information and data to accomplish its purpose as set forth in § 2.2-2530.

135 B. The Commission shall submit to the Governor and the General Assembly an annual report for 136 publication as a report document as provided in the procedures of the Division of Legislative Automated Systems for the processing of legislative documents and reports. The Commission shall also make such 137 138 interim reports as it deems advisable. The chairman shall submit to the Governor and the General 139 Assembly an annual executive summary of the interim activity and work of the Commission no later than 140 the first day of each regular session of the General Assembly. The executive summary shall be submitted 141 for publication as a report document as provided in the procedures of the Division of Legislative 142 Automated Systems for the processing of legislative documents and reports and shall be posted on the 143 General Assembly's website.

144 2. For its first year of existence, if the Commission is not funded by a separate appropriation in 145 the Appropriation Act, compensation and reimbursement of expenses for legislative members of 146 the Commission may be funded from the operating budgets of the Clerk of the House of Delegates 147 and the Clerk of the Senate upon the approval of the Joint Rules Committee. If the Commission

148 is not funded by a separate appropriation in the Appropriation Act for any year thereafter, this

149 chapter shall expire on July 1 of the fiscal year that the Commission fails to receive such funding.

150 3. That the provisions of this act shall expire on August 1, 2009.
