11	1. That § 33.1-391.5 of the Code of Virginia is amended and reenacted as follows:
12	§ 33.1-391.5. Responsibilities of Department.
13	The Department shall have the following responsibilities:
14	1. Determine present and future needs for, and economic feasibility of providing, public
15	transportation, transportation demand management, and ridesharing facilities and services and the
16	retention, improvement, and addition of passenger and freight rail transportation in the Commonwealth;
17	2. Formulate and implement plans and programs for the establishment, improvement, development
18	and coordination of public transportation, transportation demand management, and ridesharing facilities
19 20	and services, and the retention and improvement of passenger and freight rail transportation services and corridors in the Commonwealth, and coordinate transportation demand management and innovative
20 21	technological transportation initiatives with the Department of Transportation;

26	4. Develop uniform financial and operating data on and criteria for evaluating all public
