13	A. For the several judicial circuits there shall be judges, the number as hereinafter set forth, who
14	shall during their service reside within their respective circuits and whose compensation and powers
15	shall be the same as now and hereafter prescribed for circuit judges. <i>However, this residency</i>
16	requirement shall not apply to any sitting judge who resides within the Commonwealth of Virginia upon
17	property that is located contiguous to his respective circuit.
