| 18                       | As used in this chapter:   |
| 19<br>20                 | 1. "Accredited institution" means any institution approved to confer degrees pursuant to Chapter 21.1 (§ 23-276.1 et seq.) of this title.  |

| 48                       | A. Under this program, grants shall be made to or on behalf of eligible Virginia domiciles entitled to   |
| <b>49</b>                | in-state tuition charges pursuant to the provisions of § 23-7.4 who have received an undergraduate   |
| 50                       | degree within three years from an institution of higher education in the Commonwealth and are enrolled   |
| 51                       | in a graduate program identified by the Council to prepare students for careers in professions having  |
| 52<br>52                 | workforce shortages. Grants shall be disbursed to eligible students, or on their behalf to the institution   |
| 53<br>54                 | in which they are enrolled, for the academic year for which they enroll and are obligated to pay tuition<br>as a full-time or part-time graduate student.  |
| 54<br>55                 | B. Before any grant is awarded in accordance with the provisions of this chapter, the grant recipient  |
| 56                       | shall sign a promissory note under which he agrees (i) to begin employment in the Commonwealth   |
| 57                       | within six months of receiving a graduate degree and (ii) to continue such employment in the   |
| 58                       | Commonwealth for at least three years. Any grant amounts disbursed to recipients who fail to honor the   |

59 obligation under this section, and any interest thereon, shall be used only for the purposes of this
60 chapter and shall not revert to the general fund. The State Council of Higher Education for Virginia
61 shall collect all repayments by grant recipients who fail to honor the obligations under this section.

62 C. Only students who maintained a cumulative grade point average of at least 3.0 on a scale of 4.0
63 or its equivalent while enrolled as an undergraduate at a Virginia institution of higher education shall
64 be eligible to receive a grant under this program.

**65** D. Eligibility for a grant under this program shall be limited to two academic years or the equivalent number of credit hours and shall be used only for graduate studies.

67 E. Individuals who have failed to meet the federal requirement to register for the Selective Service
68 shall not be eligible to receive grants pursuant to this chapter. However, a person who has failed to
69 register for the Selective Service shall not be denied a right, privilege, or benefit under this section if (i)
70 the requirement to so register has terminated or become inapplicable to the person and (ii) the person
71 shows by a preponderance of the evidence that the failure to register was not a knowing and willful

72 failure to register.

73 § 23-38.53:29. Determination of domicile.

For the purposes of determining the eligibility of a student for an Early Graduation Incentive Grant,
domicile shall be determined by the enrolling institution, as provided in § 23-7.4, and the State Council
of Higher Education's guidelines for domiciliary status determinations.
