072559554 1 **HOUSE BILL NO. 1868** 2 AMENDMENT IN THE NATURE OF A SUBSTITUTE (Proposed by the House Committee on Agriculture, Conservation and Natural Resources on January 24, 2007) (Patron Prior to Substitute—Delegate Wittman) A BILL to amend and reenact §§ 28.2-302.2, 28.2-302.2:1, and 28.2-302.7:1 of the Code of Virginia, relating to license agent's fee for sale of saltwater recreational fishing licenses. Be it enacted by the General Assembly of Virginia: 1. That §§ 28.2-302.2, 28.2-302.2:1, and 28.2-302.7:1 of the Code of Virginia are amended and 10 reenacted as follows: 11 § 28.2-302.2. Recreational license fee; cooperative program. 12 A. The annual fee for the saltwater recreational fishing license shall be seven dollars and fifty cents. Agents of the Commission shall retain fifty cents the agent's fee established by the Board of Game and 13 Inland Fisheries pursuant to subsection B of § 29.1-327, except that the agent's fee shall be deducted 14 from the license fee established by the Commission pursuant to subdivision 4 of § 28.2-201, as 15 16 compensation for issuing each license. 17 B. All funds collected under this section shall be paid into the state treasury to the credit of the 18 Virginia Saltwater Recreational Fishing Development Fund, as established in § 28.2-302.3. 19 C. The Commission shall enter into cooperative programs with the Department of Game and Inland 20 Fisheries as are necessary to carry out the provisions of this section. 21 D. The Commission shall also have the power necessary to conduct and establish cooperative fish projects with the federal government as prescribed by Congress and in compliance with rules and 22 regulations promulgated by the United States Secretary of the Interior. 23 24 E. Upon implementation of an automated point-of-sale licensing system, licenses issued under this 25 section shall be valid for one year from their date of purchase. § 28.2-302.2:1. Special combined individual sportfishing licenses. 26 27 A. Residents and nonresidents of the Commonwealth may obtain a special combined sportfishing 28 license to fish in all inland waters and the tidal waters of the Commonwealth during the open season. 29 For residents, this license shall be in lieu of the state resident fishing license required by subdivision A 30 2 of § 29.1-310, and the saltwater recreational license required by § 28.2-302.1. The cost of this license for residents shall be \$19.50. For nonresidents, this license shall be in lieu of the state nonresident 31 fishing license required by subdivision A 3 of § 29.1-310 and the saltwater recreational license required 32 33 by § 28.2-302.1. The cost of this license for nonresidents shall be \$37.50. 34 Agents of the Commission shall retain \$.50 the agent's fee established by the Board of Game and 35 Inland Fisheries pursuant to subsection B of § 29.1-327, except that the agent's fee shall be deducted 36 from the license fee established by the Commission pursuant to subdivision 4 of § 28.2-201, as 37 compensation for issuing each license. Of the funds collected under this subsection, (i) \$7 per license 38 sold shall be paid into the state treasury to the credit of the Virginia Saltwater Recreational Fishing 39 Development Fund, as established in § 28.2-302.3 and (ii) \$12 per resident license sold and \$30 per 40 nonresident sold shall be paid into the state treasury to the credit of the Game Protection Fund, as 41 established in § 29.1-101. 42 B. Residents and nonresidents of the Commonwealth may obtain a special combined sportfishing trip 43 license to fish in all inland waters and tidal waters of the Commonwealth during the open season. This license shall be in lieu of the trip fishing license specified in subsection A of § 29.1-311 and the 44 saltwater recreational license required by § 28.2-302.1. The cost of the license shall be \$10.50 for 45 residents and \$15.50 for nonresidents. The license shall be valid for five successive days as specified on 46 the face of the license. Agents of the Commission shall retain \$.50 the agent's fee established pursuant to subsection B of § 29.1-327, except that the agent's fee shall be deducted from the license fee established by the Commission pursuant to subdivision 4 of § 28.2-201, as compensation for issuing each 47 **48** 49 50 license. Of the funds collected under this subsection, (i) \$5 per license sold shall be paid into the state 51 treasury to the credit of the Virginia Saltwater Recreational Fishing Development Fund and (ii) \$5 per 52 resident license sold and \$10 per nonresident license sold shall be paid into the state treasury to the 53 credit of the Game Protection Fund. 54 § 28.2-302.7:1. Reissuance of licenses for recreational boats.

55 The Commission shall provide for the reissuance of a saltwater recreational fishing license to a person who holds a valid license for a recreational boat issued pursuant to § 28.2-302.7 and who owns 56 or operates another recreational boat. In order to obtain a reissued license for the other recreational boat, 57 the holder of the license shall furnish to the Commission the license and accompanying decal issued for 58 59 the boat, and shall provide any additional information required by the Commission of an applicant for a

- new recreational boat license. If the complete decal cannot be produced intact, the license holder shall furnish the portion of the decal containing the license number. The cost of reissuing a license shall be five dollars. A reissued license shall be valid for the balance of the term of the original license. 61
