That § 24.2-952.7 of the Code of Virginia is amended and reenacted as follows: 11 § 24.2-952.7. Final report requirement; disbursement of surplus funds. 12 13 A. Any inaugural committee that, after having filed a statement of organization, disbands shall so 14 notify the State Board. A final report shall be filed by the committee that sets forth (i) all receipts and disbursements not previously reported, (ii) an accounting of the retirement of all debts, and (iii) the 15 16 disposition of the committee's surplus funds. This final report shall include a termination statement, 17 signed by the treasurer or other principal officer listed on the statement of organization, that all reporting 18 for the committee is complete and final. B. It shall be unlawful for any person to disburse any funds or receipts of an inaugural committee 19 20 which are in excess of the amount necessary to defray expenditures for inaugural activities other than by 21 [one or any combination of the following: (i) transferring the excess to a campaign committee for the 22 inaugurated official for use in a subsequent election or to retire the deficit in a preceding election; (ii) 23 returning the excess to a contributor in an amount not to exceed the contributor's original contribution;

one or any combination of the following: (i) returning the excess to a contributor in an amount not to

28 or to any political committee that has filed a statement of organization pursuant to this chapter; (v)

29 contributing the excess to any political party committee; and (vi) defraying any ordinary, nonreimbursed expense of the inaugurated official related to his elective office.
