HOUSE BILL NO. 2307

House Amendments in [] - January 30, 2007

A BILL to amend and reenact § 2.2-2329 of the Code of Virginia, relating to the Virginia National Defense Industrial Authority; board of directors; membership.

Be it enacted by the General Assembly of Virginia:

10 1. That § 2.2-2329 of the Code of Virginia is amended and reenacted as follows: 11

§ 2.2-2329. Board of directors; members and officers; executive director.

A. The Authority shall be governed by a board of directors consisting of 16 17 nonlegislative 12 13 members appointed as follows: four members to be appointed by the Speaker of the House of Delegates; 14 two members to be appointed by the Senate Committee on Rules; and [10 11] members to be 15 appointed by the Governor as follows: (i) three persons who are retired General Officers or Department 16 of Defense Senior Executive Service members representing the United States Armed Forces or the Department of Defense, (ii) four persons representing civic interests in the regions of Central Virginia, 17 Southwestern Virginia, Northern Virginia, and Hampton Roads, (iii) one person representing higher 18 education, and (iv) two persons with experience in commercial real estate and public financing, and (v)19 the Adjutant General of Virginia. 20

21 B. With the exception of initial staggered terms and the appointment of the Adjutant General of 22 Virginia, who shall serve a term coincident with his term of office, all appointments shall be for six 23 years. Any appointment to fill a vacancy on the Board shall be made for the unexpired term of the 24 member whose death, resignation or removal created the vacancy.

25 C. The Board shall annually elect one of its members as chairman and another as vice-chairman. The 26 chairman or, in his absence, the vice-chairman shall preside at all meetings of the Board. Meetings of 27 the Board shall be held at the call of the chairman or of any seven members. [Seven Eight] members 28 shall constitute a quorum for the transaction of the Authority's business, and no vacancy in the 29 membership shall impair the right of a quorum to exercise all the rights and perform all the duties of 30 the Authority.

31 D. The members of the Board shall be entitled to reimbursement for their reasonable travel, meal, and lodging expenses incurred in attending the meetings of the Board or while otherwise engaged in the 32 33 discharge of their duties. Such expenses shall be paid out of the treasury of the Authority upon vouchers 34 signed by the chairman of the Board or by such other person designated by the Board for this purpose.

35 E. The Board may employ an Executive Director of the Authority, who shall serve at the pleasure of 36 the Board, to direct the day-to-day operations and activities of the Authority and carry out the powers 37 and duties conferred upon him by the Board. The Executive Director and employees of the Authority 38 shall be compensated in the manner provided by the Board and shall not be subject to the provisions of 39 the Virginia Personnel Act (§ 2.2-2900 et seq.).
