10	Be it enacted by the General Assembly of Virginia:
11	1. That § 18.2-152.4 of the Code of Virginia is amended and reenacted as follows:
12	§ 18.2-152.4. Computer trespass; penalty.
13	A. It shall be unlawful for any person, with malicious intent, to:
14	1. Temporarily or permanently remove, halt, or otherwise disable any computer data, computer
15	programs or computer software from a computer or computer network;
16 17	2. Cause a computer to malfunction, regardless of how long the malfunction persists;
18	 Alter, disable, or erase any computer data, computer programs or computer software; Effect the creation or alteration of a financial instrument or of an electronic transfer of funds;
10 19	5. Use a computer or computer network to cause physical injury to the property of another; or
20	6. Use a computer or computer network to make or cause to be made an unauthorized copy, in any
2 1	form, including, but not limited to, any printed or electronic form of computer data, computer programs
22	or computer software residing in, communicated by, or produced by a computer or computer network-;

24	8. Install or cause to be installed, or collect information through, computer software that records all
25	or a majority of the keystrokes made on the computer of another without the computer owner's
26	authorization; or
27	9. Install or cause to be installed on the computer of another, computer software for the purpose of
28	(i) taking control of that computer so that it can cause damage to another computer or (ii) disabling or
29 20	disrupting the ability of the computer to share or transmit instructions or data to other computers or to
30 31	any related computer equipment or devices, including but not limited to printers, scanners, or fax
31 32	<i>machines.</i> B. Any person who violates this section shall be <i>is</i> guilty of computer trespass, which offense shall
32 33	be punishable as a Class 1 misdemeanor. If there is damage to the property of another valued at \$1,000
34	\$500 or more caused by such person's act in violation of this section, the offense shall be punishable as
35	a Class 6 felony. If a person installs or causes to be installed computer software in violation of this
36	section on more than five computers of another, the offense shall be a Class 6 felony. If a person
37	violates subdivision A 8, the offense shall be a Class 6 felony.
38	C. Nothing in this section shall be construed to interfere with or prohibit terms or conditions in a
39	contract or license related to computers, computer data, computer networks, computer operations,
40	computer programs, computer services, or computer software or to create any liability by reason of
41	terms or conditions adopted by, or technical measures implemented by, a Virginia-based electronic mail
42	service provider to prevent the transmission of unsolicited electronic mail in violation of this article.
43 44	Nothing in this section shall be construed to prohibit the monitoring of computer usage of, the otherwise
44 45	lawful copying of data of, or the denial of computer or Internet access to a minor by a parent or legal guardian of the minor.
45 46	2. That the provisions of this act may result in a net increase in periods of imprisonment or
40 47	commitment. Pursuant to § 30-19.1:4, the estimated amount of the necessary appropriation cannot
48	be determined for periods of imprisonment in state adult correctional facilities and cannot be
49	determined for periods of commitment to the custody of the Department of Juvenile Justice.
