A BILL to amend and reenact § 56-265.2 of the Code of Virginia, relating to the approval of overhead electrical transmission lines.

10 Be it enacted by the General Assembly of Virginia:

11 1. That § 56-265.2 of the Code of Virginia is amended and reenacted as follows:

12 § 56-265.2. Certificate of convenience and necessity required for acquisition, etc., of new facilities.

A. It shall be unlawful for any public utility to construct, enlarge or acquire, by lease or otherwise, any facilities for use in public utility service, except ordinary extensions or improvements in the usual course of business, without first having obtained a certificate from the Commission that the public convenience and necessity require the exercise of such right or privilege. Any certificate required by this section shall be issued by the Commission only after opportunity for a hearing and after due notice to interested parties. The certificate for overhead electrical transmission lines of 150 kilovolts or more shall be issued by the Commission only after compliance with the provisions of § 56-46.1.

20 B. In exercising its authority under this section, the Commission, notwithstanding the provisions of 21 § 56-265.4, may permit the construction and operation of electrical generating facilities, which shall not 22 be included in the rate base of any regulated utility whose rates are established pursuant to Chapter 10 23 (§ 56-232 et seq.) of this title, upon a finding that such generating facility and associated facilities 24 including transmission lines and equipment (i) will have no material adverse effect upon the rates paid 25 by customers of any regulated public utility in the Commonwealth; (ii) will have no material adverse effect upon reliability of electric service provided by any such regulated public utility; and (iii) are not 26 27 otherwise contrary to the public interest. In review of its petition for a certificate to construct and 28 operate a generating facility described in this subsection, the Commission shall give consideration to the 29 effect of the facility and associated facilities, including transmission lines and equipment, on the 30 environment and establish such conditions as may be desirable or necessary to minimize adverse 31 environmental impact as provided in § 56-46.1. Facilities authorized by a certificate issued pursuant to this subsection may be exempted by the Commission from the provisions of Chapter 10 (§ 56-232 et 32 33 seq.) of Title 56.

34 C. A map showing the location of any proposed ordinary extension or improvement outside of the 35 territory in which the public utility is lawfully authorized to operate shall be filed with the Commission, 36 and prior notice of such ordinary extension shall be given to the public utility or other entity authorized 37 to provide the same utility service within said territory. Ordinary extensions outside the service territory 38 of a public utility shall be undertaken only for use in providing its public utility service and shall be 39 constructed and operated so as not to interfere with the service or facilities of any public utility or other 40 entity authorized to provide utility service within any other territory. If, upon objection of the affected 41 utility or entity filed within thirty days of the aforesaid notice and after investigation and opportunity for a hearing the Commission finds an ordinary extension would not comply with this section, it may alter 42 or amend the plan for such activity or prohibit its construction. 43

D. Whenever a certificate is required under this section for a pipeline for the transmission or distribution of natural or manufactured gas, the Commission may issue such a certificate only after compliance with the provisions of § 56-265.2:1. As used in this section and § 56-265.2:1, "pipeline for the transmission or distribution of manufactured or natural gas" shall include the pipeline and any related facilities incidental or necessary to the operation of the pipeline.

49 E. Whenever a certificate is required under this section for electrical transmission line or lines with an expected capacity of approximately 500 kilovolts that are proposed to be located in portions of the 50 51 Lord Fairfax, Northern Virginia, or Rappahannock-Rapidan Planning Districts, by an electric utility that 52 was, as of July 1, 1999, bound by a rate case settlement adopted by the Commission that extended in its 53 application beyond January 1, 2002, by an electric utility that divested its generation assets with approval of the Commission pursuant to § 56-590 prior to January 1, 2002, or both, the utility or 54 55 utilities proposing the transmission line shall submit, to the Commission and to the members of the General Assembly whose legislative districts include any portion of such planning districts, a plan that 56 identifies alternatives to the erection of new towers for the proposed line or lines, including reinforcing 57 existing towers and lines within current utility right-of-way. The alternative plan shall identify, in such 58

59 detail as the Commission deems appropriate, measures to increase the capacity of existing facilities to

60 the extent necessary to serve the affected regions of the Commonwealth without building new towers or 61 acquiring additional right-of-way. The Commission shall not conduct hearings on an application for

62 approval of the construction of such line or lines until completion of its review of the alternative plan.

63 The Commission shall be authorized to condition its approval of an application for such line or lines

64 upon the utility's agreement to adopt those measures identified in the alternative plan that the 65 Commission finds are in the public interest.

66 F. This section shall be subject to the requirements of § 56-265.3, if any, and nothing herein shall be construed to supersede § 56-265.3.
