A BILL to amend and reenact § 16.1-253.4 of the Code of Virginia, relating to preliminary protective orders.

10 Be it enacted by the General Assembly of Virginia: 11 1. That § 16.1-253.4 of the Code of Virginia is amended

1. That § 16.1-253.4 of the Code of Virginia is amended and reenacted as follows:

§ 16.1-253.4. Emergency protective orders authorized in certain cases; penalty.

A. Any judge of a circuit court, general district court, juvenile and domestic relations district court or
magistrate may issue a written or oral ex parte emergency protective order pursuant to this section in
order to protect the health or safety of any person.

B. When a law-enforcement officer or an allegedly abused person asserts under oath to a judge or 16 magistrate, and on that assertion or other evidence the judge or magistrate finds that (i) a warrant for a 17 18 violation of § 18.2-57.2 has been issued and there is probable danger of further acts of family abuse against a family or household member by the respondent or (ii) reasonable grounds exist to believe that 19 20 the respondent has committed family abuse and there is probable danger of a further such offense 21 against a family or household member by the respondent, the judge or magistrate shall issue an ex parte 22 emergency protective order, except if the respondent is a minor, an emergency protective order shall not 23 be required, imposing one or more of the following conditions on the respondent:

1. Prohibiting acts of family abuse;

2. Prohibiting such contacts by the respondent with family or household members of the respondent as the judge or magistrate deems necessary to protect the safety of such persons; and

3. Granting the family or household member possession of the premises occupied by the parties tothe exclusion of the respondent; however, no such grant of possession shall affect title to any real orpersonal property.

30 C. An emergency protective order issued pursuant to this section shall expire seventy-two hours after 31 issuance. If the expiration of the seventy-two-hour period occurs at a time that the court is not in session, the emergency protective order shall be extended until 5 p.m. of the next business day that the 32 33 juvenile and domestic relations district court is in session. The issuance of an emergency protective 34 order pursuant to this section shall be considered a petition for a preliminary protective order pursuant 35 to § 16.1-253 and shall be docketed by the court accordingly. The respondent may at any time file a 36 motion with the court requesting a hearing to dissolve or modify the order. The hearing on the motion 37 shall be given precedence on the docket of the court.

38 D. A law-enforcement officer may request an emergency protective order pursuant to this section 39 and, if the person in need of protection is physically or mentally incapable of filing a petition pursuant 40 to § 16.1-253.1 or § 16.1-279.1, may request the extension of an emergency protective order for an additional period of time not to exceed seventy-two hours after expiration of the original order. The 41 42 request for an emergency protective order or extension of an order may be made orally, in person or by electronic means, and the judge of a circuit court, general district court, or juvenile and domestic 43 44 relations district court or a magistrate may issue an oral emergency protective order. An oral emergency 45 protective order issued pursuant to this section shall be reduced to writing, by the law-enforcement 46 officer requesting the order or the magistrate on a preprinted form approved and provided by the 47 Supreme Court of Virginia. The completed form shall include a statement of the grounds for the order 48 asserted by the officer or the allegedly abused person.

49 E. Upon receipt of the order by a local law-enforcement agency for service, the agency shall enter 50 the name of the person subject to the order and other appropriate information required by the 51 Department of State Police into the Virginia Criminal Information Network system established and 52 maintained by the Department pursuant to Chapter 2 (§ 52-12 et seq.) of Title 52. Where practical, the 53 court or magistrate may transfer information electronically to the Virginia Criminal Information Network system. A copy of an emergency protective order issued pursuant to this section shall be served upon 54 55 the respondent as soon as possible, and upon service, the agency making service shall enter the date and time of service into the Virginia Criminal Information Network system. One copy of the order shall be 56 57 given to the allegedly abused person when it is issued, and one copy shall be filed with the written 58 report required by § 19.2-81.3 C. The judge or magistrate who issues an oral order pursuant to an

electronic request by a law-enforcement officer shall verify the written order to determine whether the 59 officer who reduced it to writing accurately transcribed the contents of the oral order. The original copy 60

61 shall be filed with the clerk of the juvenile and domestic relations district court within five business 62 days of the issuance of the order. If the order is later dissolved or modified, a copy of the dissolution or 63 modification order shall be forwarded and entered in the system as described above. Upon request, the 64 clerk shall provide the allegedly abused person with information regarding the date and time of service.

F. The availability of an emergency protective order shall not be affected by the fact that the family 65 or household member left the premises to avoid the danger of family abuse by the respondent. 66

G. The issuance of an emergency protective order shall not be considered evidence of any 67 68 wrongdoing by the respondent.

H. As used in this section, a "law-enforcement officer" means any (i) full-time or part-time employee of a police department or sheriff's office which is part of or administered by the Commonwealth or any 69 70 71 political subdivision thereof and who is responsible for the prevention and detection of crime and the enforcement of the penal, traffic or highway laws of the Commonwealth and (ii) member of an auxiliary 72 police force established pursuant to subsection B of § 15.2-1731. Part-time employees are compensated 73 74 officers who are not full-time employees as defined by the employing police department or sheriff's 75 office.

76 I. Neither a law-enforcement agency, the attorney for the Commonwealth, a court nor the clerk's 77 office, nor any employee of them, may disclose, except among themselves, the residential address, 78 telephone number, or place of employment of the person protected by the order or that of the family of 79 such person, except to the extent that disclosure is (i) required by law or the Rules of the Supreme 80 Court, (ii) necessary for law-enforcement purposes, or (iii) permitted by the court for good cause.

J. As used in this section, "copy" includes a facsimile copy. K. No fee shall be charged for filing or serving any petition or order pursuant to this section. 82
