## VIRGINIA ACTS OF ASSEMBLY - CHAPTER

2 An Act to amend and reenact §§ 62.1-198 and 62.1-199 of the Code of Virginia, relating to projects 3 financed by the Virginia Resources Authority.

#### 6 Be it enacted by the General Assembly of Virginia:

7 1. That §§ 62.1-198 and 62.1-199 of the Code of Virginia are amended and reenacted as follows: 8 § 62.1-198. Legislative findings and purposes.

9 The General Assembly finds that there exists in the Commonwealth a critical need for additional 10 sources of funding to finance the present and future needs of the Commonwealth for water supply; land conservation or land preservation; wastewater treatment facilities; drainage facilities; solid waste 11 treatment, disposal and management facilities; recycling facilities; resource recovery facilities; 12 13 professional sports facilities; certain heavy rail transportation facilities; public safety facilities; airport facilities; the remediation of brownfields and contaminated properties; the design and construction of 14 15 roads, public parking garages and other public transportation facilities, and facilities for public 16 transportation by commuter rail; and the location or retention of federal facilities in the Commonwealth 17 and the support of the transition of former federal facilities from use by the federal government to other uses. This need can be alleviated in part through the creation of a resources authority. Its purpose is to 18 encourage the investment of both public and private funds and to make loans, grants, and credit 19 20 enhancements available to local governments to finance water and sewer projects, land conservation or 21 land preservation programs or projects, drainage projects, solid waste treatment, disposal and management projects, recycling projects, professional sports facilities, resource recovery projects, public 22 23 safety facilities, airport facilities, the remediation of brownfields and contaminated properties, the design 24 and construction of roads, public parking garages and other public transportation facilities, and facilities 25 for public transportation by commuter rail, and federal facilities or former federal facilities. The General 26 Assembly determines that the creation of an authority for this purpose is in the public interest, serves a 27 public purpose and will promote the health, safety, welfare, convenience or prosperity of the people of 28 the Commonwealth.

#### 29 § 62.1-199. Definitions.

- 30 As used in this chapter, unless a different meaning clearly appears from the context:
- "Authority" means the Virginia Resources Authority created by this chapter. 31
- 32 "Board of Directors" means the Board of Directors of the Authority.

33 "Bonds" means any bonds, notes, debentures, interim certificates, bond, grant or revenue anticipation 34 notes, lease and sale-leaseback transactions or any other evidences of indebtedness of the Authority.

"Capital Reserve Fund" means the reserve fund created and established by the Authority in 35 36 accordance with § 62.1-215.

37 "Cost," as applied to any project financed under the provisions of this chapter, means the total of all 38 costs incurred by the local government as reasonable and necessary for carrying out all works and 39 undertakings necessary or incident to the accomplishment of any project. It includes, without limitation, 40 all necessary developmental, planning and feasibility studies, surveys, plans and specifications, 41 architectural, engineering, financial, legal or other special services, the cost of acquisition of land and 42 any buildings and improvements thereon, including the discharge of any obligations of the sellers of 43 such land, buildings or improvements, real estate appraisals, site preparation and development, including 44 demolition or removal of existing structures, construction and reconstruction, labor, materials, machinery 45 and equipment, the reasonable costs of financing incurred by the local government in the course of the development of the project, including the cost of any credit enhancements, carrying charges incurred 46 47 before placing the project in service, interest on local obligations issued to finance the project to a date subsequent to the estimated date the project is to be placed in service, necessary expenses incurred in 48 49 connection with placing the project in service, the funding of accounts and reserves which the Authority 50 may require and the cost of other items which the Authority determines to be reasonable and necessary. It also includes the amount of any contribution, grant or aid which a local government may make or 51 give to any adjoining state, the District of Columbia or any department, agency or instrumentality 52 53 thereof to pay the costs incident and necessary to the accomplishment of any project, including, without 54 limitation, the items set forth above. The term also includes interest and principal payments pursuant to 55 any installment purchase agreement.

58 "Federal facility" means any building or infrastructure used or to be used by the federal government,59 including any building or infrastructure located on lands owned by the federal government.

60 "Federal government" means the United States of America, or any department, agency or 61 instrumentality, corporate or otherwise, of the United States of America.

62 "Former federal facility" means any federal facility formerly used by the federal government or in
63 transition from use by the federal government to a facility all or part of which is to serve any local
64 government.

<sup>65</sup> "Local government" means any county, city, town, municipal corporation, authority, district,
<sup>66</sup> commission or political subdivision created by the General Assembly or pursuant to the Constitution and
<sup>67</sup> laws of the Commonwealth or any combination of any two or more of the foregoing.

68 "Local obligations" means any bonds, notes, debentures, interim certificates, bond, grant or revenue69 anticipation notes, leases or any other evidences of indebtedness of a local government.

"Minimum capital reserve fund requirement" means, as of any particular date of computation, the
amount of money designated as the minimum capital reserve fund requirement which may be established
in the resolution of the Authority authorizing the issuance of, or the trust indenture securing, any
outstanding issue of bonds or credit enhancement.

74 "Project" means (i) any water supply or wastewater treatment facility including a facility for 75 receiving and stabilizing septage or a soil drainage management facility and any solid waste treatment, 76 disposal, or management facility, recycling facility, federal facility or former federal facility, or resource 77 recovery facility located or to be located in the Commonwealth, the District of Columbia or any 78 adjoining state, all or part of which facility serves or is to serve any local government; and (ii) any 79 federal facility located or to be located in the Commonwealth, provided that both the Board of Directors 80 of the Authority and the governing body of the local government receiving the benefit of the loan, grant, or credit enhancement from the Authority make a determination or finding to be embodied in a 81 resolution or ordinance that the undertaking and financing of such facility is necessary for the location 82 or retention of such facility and the related use by the federal government in the Commonwealth. The 83 term includes, without limitation, water supply and intake facilities; water treatment and filtration 84 facilities; water storage facilities; water distribution facilities; sewage and wastewater (including surface 85 and ground water) collection, treatment and disposal facilities; drainage facilities and projects; solid 86 waste treatment, disposal or management facilities; recycling facilities; resource recovery facilities; 87 88 related office, administrative, storage, maintenance and laboratory facilities; and interests in land related 89 thereto. The term also means any heavy rail transportation facilities operated by a transportation district, 90 created under the Transportation District Act of 1964 (§ 15.2-4500 et seq.), which operates heavy rail 91 freight service, including rolling stock, barge loading facilities, and any related marine or rail equipment. 92 The term also means, without limitation, the design and construction of roads, public parking garages and other public transportation facilities, and facilities for public transportation by commuter rail. In addition, the term means any project as defined in § 5.1-30.1 and any professional sports facility, 93 94 including a major league baseball stadium as defined in § 15.2-5800, provided that the specific professional sports facility projects have been designated by the General Assembly as eligible for 95 96 97 assistance from the Authority. The term also means facilities supporting, related to, or otherwise used 98 for public safety including, but not limited to, law-enforcement training facilities and emergency 99 response, fire, rescue and police stations. The term also means the remediation, redevelopment and 100 rehabilitation of property contaminated by the release of hazardous substances, hazardous wastes, solid 101 wastes or petroleum where such remediation has not clearly been mandated by the United States 102 Environmental Protection Agency, the Department of Environmental Quality, or a court pursuant to the Comprehensive Environmental Response, Compensation and Liability Act (42 U.S.C. § 9601 et seq.), the 103 Resource Conservation and Recovery Act (42 U.S.C. § 6901 et seq.), the Virginia Waste Management 104 Act (§ 10.1-1400 et seq.), the State Water Control Law (§ 62.1-44.2 et seq.), or other applicable 105 106 statutory or common law or where jurisdiction of those statutes has been waived. The term also means 107 any program or project for land conservation or land preservation, including but not limited to any 108 program or project involving the acquisition of rights or interests in land for the conservation or 109 preservation of such land.
