2 *An Act to amend and reenact § 38.2-1825 of the Code of Virginia, relating to the termination of*
3 *insurance agent licenses.*

6 **Be it enacted by the General Assembly of Virginia:**7 **1. That § 38.2-1825 of the Code of Virginia is amended and reenacted as follows:**

8 § 38.2-1825. Duration and termination of licenses and appointments.

9 A. A license issued to:

10 1. An individual agent shall authorize him to act as an agent until his license is otherwise terminated,
11 suspended or revoked.12 2. A business entity shall authorize such business entity to act as an agent until such license is
13 otherwise terminated, suspended, or revoked. The dissolution or discontinuance of a partnership, whether
14 by intent or by operation of law, shall automatically terminate all licenses issued to such partnership.
15 The Bureau shall automatically terminate all insurance licenses within ninety calendar days of receiving
16 notification from the clerk of the Commission that the certificate of organization or charter of a
17 domestic limited liability company or corporation, respectively, whether by intent or by operation of
18 law, has been terminated or that the certificate of registration or certificate of authority of a foreign
19 limited liability company or corporation, respectively, has been revoked.20 B. An agent's license shall automatically terminate after a period of 183 calendar days during which
21 no appointment of such agent under such license was in effect. The Commission may, upon a showing
22 of good cause and upon payment of any prescribed fee, waive or extend this requirement. As used
23 herein, the term "good cause" shall not include negligence, clerical error, or administrative oversight by
24 the licensee or the appointing insurer.25 C. The license issued to a variable contracts agent pursuant to this chapter shall terminate
26 immediately upon the termination of the licensee's life and annuities insurance agent license, and may
27 not be applied for again until the person has been issued a new life and annuities insurance agent
28 license.29 D. The license issued to a surplus lines broker pursuant to this title shall terminate immediately
30 upon the termination of the licensee's property and casualty insurance agent license, and may not be
31 applied for again until the person has been issued a new property and casualty insurance agent license.32 E. Immediately upon termination of a settlement agent's last appointment under his title insurance
33 agent license, the Bureau shall notify the Virginia State Bar to terminate the settlement agent's
34 registration and the person shall not be permitted to act as a settlement agent under his title insurance
35 agent's license until a new appointment has taken effect.36 F. An appointment issued to an agent by an insurer, unless terminated, suspended or revoked, shall
37 authorize the appointee to act as an agent for that insurer and to be compensated therefor
38 notwithstanding the provisions of §§ 38.2-1812 and 38.2-1823.
