11 Be it enacted by the General Assembly of Virginia:

12 1. That §§ 46.2-819.1 and 46.2-819.3 of the Code of Virginia are amended and reenacted as 13 follows:

\$ 46.2-819.1. Installation and use of photo-monitoring system or automatic vehicle identificationsystem in conjunction with certain toll facilities; penalty.

A. The operator of any toll facility or the locality within which such toll facility is located may install and operate or cause to be installed and operated a photo-monitoring system or automatic vehicle identification system, or both, at locations where tolls are collected for the use of such toll facility. The operator of a toll facility shall send an invoice or bill for unpaid tolls to the registered owner of a vehicle as part of an electronic or manual toll collection process, prior to seeking remedies under this section.

22 B. Information collected by a photo-monitoring system or automatic vehicle identification system 23 installed and operated pursuant to subsection A shall be limited exclusively to that information that is 24 necessary for the collection of unpaid tolls. Notwithstanding any other provision of law, all photographs, 25 microphotographs, electronic images, or other data collected by a photo-monitoring system or automatic vehicle identification system shall be used exclusively for the collection of unpaid tolls and shall not (i) 26 27 be open to the public; (ii) be sold and/or used for sales, solicitation, or marketing purposes; (iii) be 28 disclosed to any other entity except as may be necessary for the collection of unpaid tolls or to a vehicle 29 owner or operator as part of a challenge to the imposition of a toll; and (iv) be used in a court in a 30 pending action or proceeding unless the action or proceeding relates to a violation of this section or upon order from a court of competent jurisdiction. Information collected under this section shall be 31 purged and not retained later than 30 days after the collection and reconciliation of any unpaid tolls, 32 33 administrative fees, and/or civil penalties. Any entity operating a photo-monitoring system or automatic 34 vehicle identification system shall annually certify compliance with this section and make all records 35 pertaining to such system available for inspection and audit by the Commonwealth Transportation 36 Commissioner or the Commissioner of the Department of Motor Vehicles or their designee. Any 37 violation of this subsection shall constitute a Class 1 misdemeanor. In addition to any fines or other 38 penalties provided for by law, any money or other thing of value obtained as a result of a violation of 39 this section shall be forfeited to the Commonwealth.

The toll facility operator may impose and collect an administrative fee in addition to the unpaid toll so as to recover the expenses of collecting the unpaid toll, which administrative fee shall be reasonably related to the actual cost of collecting the unpaid toll and not exceed \$100 per violation. Such fee shall not be levied upon the operator of the vehicle until the second unpaid toll has been documented. The operator of the vehicle shall pay the unpaid tolls and any administrative fee detailed in an invoice or bill issued by a toll facility operator. If paid within 30 days of notification, the administrative fee shall not exceed \$25.

47 C. If the matter proceeds to court, the registered owner or operator of a vehicle shall be liable for a civil penalty as follows: for a first offense, \$50; for a second offense within one year from the first 48 49 offense, \$100; for a third offense within two years from the second offense, \$250; and for a fourth and any subsequent offense within three years from the second offense, \$500 plus, in each case, the unpaid 50 51 toll, all accrued administrative fees imposed by the toll facility operator, and applicable court costs if the 52 vehicle is found, as evidenced by information obtained from a photo-monitoring system or automatic 53 vehicle identification system as provided in this section, to have used such a toll facility without 54 payment of the required toll.

55 D. Any action under this section shall be brought in the General District Court of the city or county 56 in which the toll facility is located.

57 E. Proof of a violation of this section shall be evidenced by information obtained from a 58 photo-monitoring system or automatic vehicle identification system as provided in this section. A **SB110C**

59 certificate, sworn to or affirmed by a technician employed or authorized by the operator of a toll facility 60 or by the locality wherein the toll facility is located, or a facsimile of such a certificate, based on inspection of photographs, microphotographs, videotapes, or other recorded images produced by a 61 photo-monitoring system, or of electronic data collected by an automatic vehicle identification system, 62 63 shall be prima facie evidence of the facts contained therein. Any photographs, microphotographs, 64 videotape, or other recorded images or electronic data evidencing such a violation shall be available for 65 inspection in any proceeding to adjudicate the liability for such violation under this section. A record of communication by an automatic vehicle identification device with the automatic vehicle identification 66 system at the time of a violation of this section shall be prima facie evidence that the automatic vehicle 67 identification device was located in the vehicle registered to use such device in the records of the 68 69 Virginia Department of Transportation.

F. It shall be prima facie evidence that the vehicle described in the summons issued pursuant to subsection K of this section was operated in violation of this section.

72 Upon a finding by a court of competent jurisdiction that the vehicle described in the summons issued 73 pursuant to subsection K of this section was in violation of this section, the court shall impose a civil 74 penalty upon the registered owner or operator of such vehicle in accordance with the amounts specified in subsection C of this section, together with applicable court costs, the operator's administrative fee and 75 the toll due. Penalties assessed as the result of action initiated by the Virginia Department of 76 77 Transportation shall be remanded by the clerk of the court which adjudicated the action to the Virginia 78 Department of Transportation's Toll Facilities Revolving Fund. Penalties assessed as the result of action initiated by an operator of a toll facility other than the Virginia Department of Transportation shall be 79 80 remanded by the clerk of the court which adjudicated the action to the treasurer or director of finance of 81 the county or city in which the violation occurred for payment to the toll facility operator.

The registered owner of such vehicle shall be given reasonable notice by way of a summons as provided in subsection K of this section that his vehicle had been used in violation of this section and such owner shall be given notice of the time and place of the hearing as well as the civil penalty and costs for such offense.

86 Upon the filing of an affidavit with the court at least 14 days prior to the hearing date by the registered owner of the vehicle stating that he was not the driver of the vehicle on the date of the violation and providing the legal name and address of the operator of the vehicle at the time of the violation, a summons will also be issued to the alleged operator of the vehicle at the time of the offense. In any action against a vehicle operator, an affidavit made by the registered owner providing the name and address of the vehicle operator at the time of the violation shall constitute prima facie evidence that the person named in the affidavit was operating the vehicle at all the relevant times

93 relating to the matter named in the affidavit.

94 If the registered owner of the vehicle produces a certified copy of a police report showing that the 95 vehicle had been reported to the police as stolen prior to the time of the alleged offense and remained 96 stolen at the time of the alleged offense, then the court shall dismiss the summons issued to the 97 registered owner of the vehicle.

98 G. Upon a finding by a court that a person has three or more unpaid tolls and such person fails to 99 pay the required penalties, fees, and unpaid tolls, the court shall notify the Commissioner of the 100 Department of Motor Vehicles, who shall refuse to issue or renew any vehicle registration certificate of 101 any applicant or the license plate issued for the vehicle driven in the commission of the offense until the 102 court has notified the Commissioner that such penalties, fees, and unpaid tolls have been paid. If it is 103 proven that the vehicle owner was not the operator at the time of the offense and upon a finding by a 104 court that the person identified in an affidavit pursuant to subsection F as the operator violated this 105 section and such person fails to pay the required penalties, fees, and unpaid tolls, the court shall notify the Commissioner, who shall refuse to issue or renew any vehicle registration certificate of any applicant 106 107 or the license plate issued for any vehicle owned or co-owned by such person until the court has 108 notified the Commissioner that such penalties, fees, and unpaid tolls have been paid. Such funds 109 representing payment of unpaid tolls and all administrative fees of the toll facility operator shall be transferred from the court to the Virginia Department of Transportation's Toll Facilities Revolving Fund 110 or, in the case of an action initiated by an operator of a toll facility other than the Virginia Department 111 of Transportation, to the treasurer or director of finance of the county or city in which the violation 112 113 occurred for payment to the toll facility operator. The Commissioner shall collect a \$40 administrative fee from the registered owner or operator of the vehicle to defray the cost of processing and removing 114 115 an order to deny registration or registration renewal.

H. For purposes of this section, "operator of a toll facility other than the Virginia Department of
Transportation" means any agency, political subdivision, authority, or other entity authorized by the
Code of Virginia to operate such toll facility that operates a toll facility; "owner" means the registered
owner of a vehicle on record with the Department of Motor Vehicles. For purposes of this section,
"owner" does not mean a vehicle rental or vehicle leasing company; "photo-monitoring system" means a

121 vehicle sensor installed to work in conjunction with a toll collection device that automatically produces 122 one or more photographs, one or more microphotographs, a videotape, or other recorded images of each 123 vehicle at the time it is used or operated in violation of this section; "automatic vehicle identification 124 system" means an electronic vehicle identification system installed to work in conjunction with a toll 125 collection device that automatically produces an electronic record of each vehicle equipped with an 126 automatic vehicle identification device that uses a toll facility; and "automatic vehicle identification 127 device" means an electronic device that communicates by wireless transmission with an automatic 128 vehicle identification system.

129 I. Any vehicle rental or vehicle leasing company, if named in a summons, shall be released as a 130 party to the action if it provides the operator of the toll facility a copy of the vehicle rental agreement 131 or lease or an affidavit identifying the renter or lessee prior to the date of hearing set forth in the 132 summons. Upon receipt of such rental agreement, lease, or affidavit, a notice shall be mailed to the 133 renter or lessee identified therein. Release of this information shall not be deemed a violation of any 134 provision of the Government Data Collection and Dissemination Practices Act (§ 2.2-3800 et seq.) or the 135 Insurance Information and Privacy Protection Act (§ 38.2-600 et seq.). The toll facility operator shall 136 allow at least 30 days from the date of such mailing before pursuing other remedies under this section. 137 In any action against the vehicle operator, a copy of the vehicle rental agreement, lease, or affidavit 138 identifying the renter or lessee of the vehicle at the time of the violation is prima facie evidence that the 139 person named in the rental agreement, lease, or affidavit was operating the vehicle at all the relevant 140 times relating to the matter named in the summons.

J. Imposition of a civil penalty pursuant to this section shall not be deemed a conviction as an operator and shall not be made part of the driving record of the person upon whom such civil penalty is imposed nor shall it be used for insurance purposes in the provision of motor vehicle insurance coverage. *The provisions of § 46.2-395 shall not be applicable to any civil penalty, fee, unpaid toll, fine or cost imposed or ordered paid under this section for a violation of this section.*

146 K. On a form prescribed by the Supreme Court, a summons for a violation of this section may be 147 executed pursuant to § 19.2-76.2. Toll facility personnel or their agents mailing such summons shall be 148 considered conservators of the peace for the sole and limited purpose of mailing such summons. 149 Notwithstanding the provisions of § 19.2-76, a summons for a violation of this section may be executed 150 by mailing by first-class mail a copy thereof to the address of the owner of the vehicle as shown on the 151 records of the Department of Motor Vehicles or, if the registered owner has named and provided a valid 152 address for the operator of the vehicle at the time of the violation in an affidavit executed pursuant to 153 subsection F, such named operator of the vehicle. If the summoned person fails to appear on the date of 154 return set out in the summons mailed pursuant to this section, the summons shall be executed in the 155 manner set out in § 19.2-76.3.

156 L. The operator of a toll facility may enter into an agreement with the Department of Motor 157 Vehicles, in accordance with the provisions of subdivision 21 of subsection B of § 46.2-208, to obtain 158 vehicle owner information regarding the registered owners of vehicles that fail to pay tolls required for 159 the use of toll facilities and with the Virginia Department of Transportation to obtain any information 160 that is necessary to conduct electronic toll collection. Information provided to the operator of a toll 161 facility shall only be used for the collection of unpaid tolls and the operator of the toll facility shall be 162 subject to the same conditions and penalties regarding release of the information as contained in 163 subsection B.

- 164 M. No person shall be subject to both the provisions of this section and to prosecution under 165 § 46.2-819 for actions arising out of the same transaction or occurrence.
- 166 § 46.2-819.3. Use of toll facility without payment of toll; enforcement; penalty.

A. The toll facility operator may impose and collect an administrative fee in addition to the unpaid toll so as to recover the expenses of collecting the unpaid toll, which administrative fee shall be reasonably related to the actual cost of collecting the unpaid toll and not exceed \$100 per violation. Such fee shall not be levied upon the operator of the vehicle until the second unpaid toll has been documented. The owner or operator of the vehicle shall pay the unpaid tolls and any administrative fee detailed in an invoice or bill issued by a toll facility operator. If paid within 30 days of notification, the administrative fee shall not exceed \$25.

B. If the matter proceeds to court, the owner or operator of the vehicle shall be liable for a civil penalty as follows: for a first offense, \$50; for a second offense within one year from the first offense, \$100; for a third offense within two years from the second offense, \$250; and for a fourth and any subsequent offense within three years from the second offense, \$500 plus, in each case, the unpaid toll, all accrued administrative fees imposed by the toll facility operator and applicable court costs if the vehicle operator is found, as evidenced by information obtained from the toll facility operator, to have used such a toll facility without payment of the required toll.

181 C. A written promise to pay an unpaid toll within a specified period of time executed by the driver

182 of a motor vehicle, accompanied by a certificate sworn to or affirmed by an authorized agent of the toll183 facility that the unpaid toll was not paid within such specified period, shall be prima facie evidence of184 the facts contained therein.

185 D. The operator of a toll facility may send an invoice or bill to the driver of a motor vehicle using a
186 toll facility without payment of the specified toll as part of an electronic or manual toll collection
187 process prior to seeking remedies under this section. Any action under this section shall be brought in
188 the general district court of the city or county in which the toll facility is located.

189 E. Upon a finding by a court of competent jurisdiction that the driver of a motor vehicle identified in 190 the summons issued pursuant to subsection I was in violation of this section, the court shall impose a 191 civil penalty upon the driver of a motor vehicle in accordance with the amounts specified in subsection B, together with applicable court costs, the operator's administrative fee, and the toll due. Penalties 192 assessed as the result of action initiated by the Virginia Department of Transportation shall be remanded 193 194 by the clerk of the court which adjudicated the action to the Virginia Department of Transportation's Toll Facilities Revolving Fund. Penalties assessed as the result of action initiated by an operator of a toll 195 196 facility other than the Virginia Department of Transportation shall be remanded by the clerk of the court 197 which adjudicated the action to the treasurer or director of finance of the county or city in which the 198 violation occurred for payment to the toll facility operator.

F. Upon a finding by a court that a person has three or more unpaid tolls and such person fails to pay the required penalties, fees, and unpaid tolls, the court shall notify the Commissioner of the Department of Motor Vehicles, who shall refuse to issue or renew any vehicle registration certificate of any applicant or the license plate issued for any vehicle owned or co-owned by the offender. The Commissioner shall collect a \$40 administrative fee from the owner or operator of the vehicle to defray the cost of processing and removing an order to deny registration or registration renewal.

G. For purposes of this section, "operator of a toll facility other than the Virginia Department of
Transportation" means any agency, political subdivision, authority, or other entity authorized by the
Code of Virginia to operate such toll facility that operates a toll facility.

H. Imposition of a civil penalty pursuant to this section shall not be deemed a conviction as an operator and shall not be made part of the driving record of the person upon whom such civil penalty is imposed nor shall it be used for insurance purposes in the provision of motor vehicle insurance coverage. The provisions of § 46.2-395 shall not be applicable to any civil penalty, fee, unpaid toll, fine or cost imposed or ordered paid under this section for a violation of this section.

I. A summons for a violation of this section may be executed pursuant to § 19.2-76.2. Toll facility personnel or their agents mailing such summons shall be considered conservators of the peace for the sole and limited purpose of mailing such summons. Notwithstanding the provisions of § 19.2-76, a summons for a violation of this section may be executed by mailing by first-class mail a copy thereof to the address of the driver of a motor vehicle as shown on the records of the Department of Motor Vehicles. If the summoned person fails to appear on the date of return set out in the summons mailed pursuant to this section, the summons shall be executed in the manner set out in § 19.2-76.3.

J. No person shall be subject to both the provisions of this section and to prosecution under \$46.2-819 for actions arising out of the same transaction or occurrence.
