10	Be it enacted by the General Assembly of Virginia:
11	1. That § 23-9.2:3 of the Code of Virginia is amended and reenacted as follows:
12	§ 23-9.2:3. Power of governing body of educational institution to establish rules and regulations;
13	offenses occurring on property of institution; state direct student financial assistance.
14	A. In addition to the powers now enjoyed by it, the board of visitors or other governing body of
15	every educational institution shall have the power:
16	1. To establish rules and regulations for the acceptance and assistance of students except that (i)
17	individuals who have failed to meet the federal requirement to register for the selective service shall not
18	be eligible to receive any state direct student assistance; (ii) individuals who are not citizens or nationals
19 20	of the United States or are unlawfully present in the United States or do not possess a valid visa issued
20	by the Department of Homeland Security to permit study in the United States shall not be eligible for
21 22	in-state tuition rates at any public institution of higher education in the Commonwealth; (iii) the
$\frac{22}{23}$	accreditation status of a Virginia public high school shall not be considered in making admissions determinations for students who have aeroad a diploma pursuant to the requirements established by the
23 24	determinations for students who have earned a diploma pursuant to the requirements established by the Board of Education; and (iii) (iv) the governing boards of the four-year institutions shall establish
2 4 25	policies providing for the admission of certain graduates of Virginia community colleges as set forth in
23 26	§ 23-9.2:3.02.
27 27	2. To establish rules and regulations for the conduct of students while attending such institution.
28	3. To establish programs, in cooperation with the State Council of Higher Education and the Office
29	of the Attorney General, to promote compliance among students with the Commonwealth's laws relating
30	to the use of alcoholic beverages.
31	4. To establish rules and regulations for the rescission or restriction of financial aid, within the
32	discretionary authority provided to the institution by federal or state law and regulations, and the
33	suspension and dismissal of students who fail or refuse to abide by such rules and regulations for the
34	conduct of students.
35	5. To establish rules and regulations for the employment of professors, teachers, instructors and all
36	other employees and provide for their dismissal for failure to abide by such rules and regulations.
37	6. To provide parking and traffic rules and regulations on property owned by such institution.
38	7. To establish guidelines for the initiation or induction into any social fraternity or sorority in
39	accordance with § 18.2-56.
40	8. To establish programs, in cooperation with the State Council of Higher Education for Virginia and
41	the Office of the Attorney General, to promote the awareness and prevention of sexual crimes
42	committed upon students.
43	B. Upon receipt of an appropriate resolution of the board of visitors or other governing body of an advantigue the source of a political subdivision which is continuous to the
44 45	educational institution, the governing body of a political subdivision which is contiguous to the institution shall enforce state statutes and local ordinances with respect to offenses occurring on the

47	The governing bodies of the public institutions of higher education shall assist the State Council of
48	Higher Education in enforcing the provisions related to eligibility for financial aid.
49	C. In order to improve the quality of the Commonwealth's work force and educational programs, the
5 0	governing bodies of the public institutions of higher education shall establish programs to seek to ensure
51	that all graduates have the technology skills necessary to compete in the 21st Century and, particularly,
52	that all students matriculating in teacher-training programs receive instruction in the effective use of
53	educational technology.
54	D. Notwithstanding the provisions of subsection A, any person shall be eligible for in-state tuition
55	who:
56	1. Has resided with his parent, guardian, or other person standing in loco parentis while attending a
57	public or private high school in this state;

58 2. Has graduated from a public or private high school in Virginia;

59 *3.* Has resided in the Commonwealth for at least three years as of the date the individual graduated 60 from high school;

61 4. Has registered as an entering student in an institution of higher education;

62 5. Has provided an affidavit to the institution stating that he has filed an application to become a
63 permanent resident of the United States and is actively pursuing such permanent residency or will do so
64 as soon as he is eligible; and

65 6. Has submitted evidence that he, or in the case of a dependent student, at least one parent, 66 guardian, or person standing in loco parentis, has filed, unless exempted by state law, Virginia income

67 tax returns for at least three years prior to the date of enrollment.
