That §§ 46.2-100, 46.2-808, 46.2-905, 46.2-906, 46.2-906.1, 46.2-908.1, and 46.2-932 of the Code 10 of Virginia are amended and reenacted as follows: 11 § 46.2-100. Definitions. 12 13 The following words and phrases when used in this title shall, for the purpose of this title, have the 14 meanings respectively ascribed to them in this section except in those instances where the context 15 clearly indicates a different meaning: "All-terrain vehicle" means a three-wheeled or four-wheeled motor vehicle powered by a gasoline or 16 diesel engine and generally characterized by large, low-pressure tires, a seat designed to be straddled by 17 18 the operator, and handlebars for steering that is intended for off-road use by an individual rider on various types of unpaved terrain. The term does not include four-wheeled vehicles, commonly known as 19 "go-carts," that have low centers of gravity and are typically used in racing on relatively level surfaces, 20 nor does the term include any "utility vehicle" as defined in this section or any "farm utility vehicle" as 21 22 defined in this section. 23 "Antique motor vehicle" means every motor vehicle, as defined in this section, which was actually 24 manufactured or designated by the manufacturer as a model manufactured in a calendar year not less 25 than 25 years prior to January 1 of each calendar year and is owned solely as a collector's item. 26 "Antique trailer" means every trailer or semitrailer, as defined in this section, that was actually 27 manufactured or designated by the manufacturer as a model manufactured in a calendar year not less 28 than 25 years prior to January 1 of each calendar year and is owned solely as a collector's item. 29 "Automobile or watercraft transporters" means any tractor truck, lowboy, vehicle, or combination, 30 including vehicles or combinations that transport motor vehicles or watercraft on their power unit, 31 designed and used exclusively for the transportation of motor vehicles or watercraft. "Bicycle" means a device propelled solely by human power, upon which a person may ride either on 32 33 or astride a regular seat attached thereto, having two or more wheels in tandem, including children's 34 bicycles, except a toy vehicle intended for use by young children. For purposes of Chapter 8 (§ 46.2-800 et seq.) of this title, a bicycle shall be a vehicle while operated on the highway. 35 36 "Bicycle lane" means that portion of a roadway designated by signs and/or pavement markings for 37 the preferential use of bicycles, electric power-assisted bicycles, and mopeds. 38 Business district" means the territory contiguous to a highway where 75 percent or more of the 39 property contiguous to a highway, on either side of the highway, for a distance of 300 feet or more 40 along the highway, is occupied by land and buildings actually in use for business purposes. 41 'Camping trailer" means every vehicle that has collapsible sides and contains sleeping quarters but may or may not contain bathing and cooking facilities and is designed to be drawn by a motor vehicle. 42 'Cancel" or "cancellation" means that the document or privilege cancelled has been annulled or 43 terminated because of some error, defect, or ineligibility, but the cancellation is without prejudice and 44 45 reapplication may be made at any time after cancellation. 46 'Chauffeur" means every person employed for the principal purpose of driving a motor vehicle and 47 every person who drives a motor vehicle while in use as a public or common carrier of persons or 48 property. 49 "Commission" means the State Corporation Commission. 50 "Commissioner" means the Commissioner of the Department of Motor Vehicles of the 51 Commonwealth. 52 "Crosswalk" means that part of a roadway at an intersection included within the connections of the 53 lateral lines of the sidewalks on opposite sides of the highway measured from the curbs or, in the 54 absence of curbs, from the edges of the traversable roadway; or any portion of a roadway at an 55 intersection or elsewhere distinctly indicated for pedestrian crossing by lines or other markings on the 56 surface. 57 "Decal" means a device to be attached to a license plate that validates the license plate for a 58 predetermined registration period.

**59** "Department" means the Department of Motor Vehicles of the Commonwealth.

60 "Disabled parking license plate" means a license plate that displays the international symbol of access61 in the same size as the numbers and letters on the plate and in a color that contrasts with the62 background.

"Disabled veteran" means a veteran who (i) has either lost, or lost the use of, a leg, arm, or hand;
(ii) is blind; or (iii) is permanently and totally disabled as certified by the U.S. Veterans Administration.
A veteran shall be considered blind if he has a permanent impairment of both eyes to the following
extent: (i) central visual acuity of 20/200 or less in the better eye, with corrective lenses, or central
visual acuity of more than 20/200, if there is a field defect in which the peripheral field has contracted
to such an extent that the widest diameter of visual field subtends an angular distance no greater than 20
degrees in the better eye.

"Driver's license" means any license, including a commercial driver's license as defined in the
Virginia Commercial Driver's License Act (§ 46.2-341.1 et seq.), issued under the laws of the
Commonwealth authorizing the operation of a motor vehicle.

"Electric personal assistive mobility device" means a self-balancing two-nontandem-wheeled device
that is designed to transport only one person and powered by an electric propulsion system that limits
the device's maximum speed to 15 miles per hour or less. For purposes of Chapter 8 of this title, an
electric personal assistive mobility device shall be a vehicle when operated on a highway.

"Electric power-assisted bicycle" means a vehicle that travels on not more than three wheels in contact with the ground and is equipped with (i) pedals that allow propulsion by human power and (ii) an electric motor with an input of no more than 1,000 watts that reduces the pedal effort required of the rider. For the purposes of Chapter 8 of this title, an electric power-assisted bicycle shall be a vehicle
when operated on a highway.

82 "Essential parts" means all integral parts and body parts, the removal, alteration, or substitution of
83 which will tend to conceal the identity of a vehicle.

84 "Farm tractor" means every motor vehicle designed and used as a farm, agricultural, or horticultural implement for drawing plows, mowing machines, and other farm, agricultural, or horticultural machinery and implements including self-propelled mowers designed and used for mowing lawns.

87 "Farm utility vehicle" means a vehicle that is designed for off-road use and is used as a farm,
88 agricultural, or horticultural service vehicle, generally having a gasoline or diesel engine, four or more
89 wheels, bench seating for the operator and a passenger, a steering wheel for control, and a cargo bed.
90 "Farm utility vehicle" does not include pickup or panel trucks, golf carts, low-speed vehicles, riding
91 lawn mowers, or all-terrain vehicles.

92 "Federal safety requirements" means applicable provisions of 49 U.S.C. § 30101 et seq. and all
93 administrative regulations and policies adopted pursuant thereto.

94 "Financial responsibility" means the ability to respond in damages for liability thereafter incurred
95 arising out of the ownership, maintenance, use, or operation of a motor vehicle, in the amounts provided
96 for in § 46.2-472.

97 "Foreign market vehicle" means any motor vehicle originally manufactured outside the United States,
98 which was not manufactured in accordance with 49 U.S.C. § 30101 et seq. and the policies and
99 regulations adopted pursuant to that Act, and for which a Virginia title or registration is sought.

"Foreign vehicle" means every motor vehicle, trailer, or semitrailer that is brought into the
 Commonwealth otherwise than in the ordinary course of business by or through a manufacturer or dealer
 and that has not been registered in the Commonwealth.

103 "Golf cart" means a self-propelled vehicle that is designed to transport persons playing golf and their 104 equipment on a golf course.

105 "Governing body" means the board of supervisors of a county, council of a city, or council of a 106 town, as context may require.

107 "Gross weight" means the aggregate weight of a vehicle or combination of vehicles and the load108 thereon.

109 "Highway" means the entire width between the boundary lines of every way or place open to the use of the public for purposes of vehicular travel in the Commonwealth, including the streets and alleys, 110 111 and, for law-enforcement purposes, (i) the entire width between the boundary lines of all private roads or private streets that have been specifically designated "highways" by an ordinance adopted by the 112 113 governing body of the county, city, or town in which such private roads or streets are located and (ii) the entire width between the boundary lines of every way or place used for purposes of vehicular travel 114 on any property owned, leased, or controlled by the United States government and located in the 115 116 Commonwealth.

"Intersection" means (i) the area embraced within the prolongation or connection of the lateral
curblines or, if none, then the lateral boundary lines of the roadways of two highways that join one
another at, or approximately at, right angles, or the area within which vehicles traveling on different
highways joining at any other angle may come in conflict; (ii) where a highway includes two roadways

121 30 feet or more apart, then every crossing of each roadway of such divided highway by an intersecting 122 highway shall be regarded as a separate intersection, in the event such intersecting highway also 123 includes two roadways 30 feet or more apart, then every crossing of two roadways of such highways 124 shall be regarded as a separate intersection; or (iii) for purposes only of authorizing installation of 125 traffic-control devices, every crossing of a highway or street at grade by a pedestrian crosswalk.

126 "Law-enforcement officer" means any officer authorized to direct or regulate traffic or to make 127 arrests for violations of this title or local ordinances authorized by law. For the purposes of access to 128 law-enforcement databases regarding motor vehicle registration and ownership only, this term shall also 129 include city and county commissioners of the revenue and treasurers, together with their duly designated 130 deputies and employees, when such officials are actually engaged in the enforcement of §§ 46.2-752, 131 46.2-753 and 46.2-754 and local ordinances enacted thereunder.

132 "License plate" means a device containing letters, numerals, or a combination of both, attached to a motor vehicle, trailer, or semitrailer to indicate that the vehicle is properly registered with the 133 134 Department. 135

"Light" means a device for producing illumination or the illumination produced by the device.

136 "Low-speed vehicle" means any four-wheeled electrically-powered vehicle, except a motor vehicle or 137 low-speed vehicle that is used exclusively for agricultural or horticultural purposes or a golf cart, whose 138 maximum speed is greater than 20 miles per hour but not greater than 25 miles per hour and is 139 manufactured to comply with safety standards contained in Title 49 of the Code of Federal Regulations, **140** § 571.500.

141 "Manufactured home" means a structure subject to federal regulation, transportable in one or more 142 sections, which in the traveling mode is eight body feet or more in width or 40 body feet or more in 143 length, or, when erected on site, is 320 or more square feet, and which is built on a permanent chassis 144 and designed to be used as a dwelling with or without a permanent foundation when connected to the 145 required utilities, and includes the plumbing, heating, air conditioning, and electrical systems contained 146 therein.

147 "Moped" means every vehicle that travels on not more than three wheels in contact with the ground 148 that has (i) a seat that is no less than 24 inches in height, measured from the middle of the seat 149 perpendicular to the ground and (ii) a gasoline, electric, or hybrid motor that displaces less than 50 150 cubic centimeters. For purposes of Chapter 8 (§ 46.2-800 et seq.) of this title, a moped shall be a vehicle 151 while operated on a highway.

152 "Motor-driven cycle" means every motorcycle that has a gasoline engine that (i) displaces less than 153 150 cubic centimeters; (ii) has a seat less than 24 inches in height, measured from the middle of the seat 154 perpendicular to the ground; and (iii) has no manufacturer-issued vehicle identification number.

155 "Motor home" means every private motor vehicle with a normal seating capacity of not more than 10 156 persons, including the driver, designed primarily for use as living quarters for human beings.

157 "Motor vehicle" means every vehicle as defined in this section that is self-propelled or designed for 158 self-propulsion except as otherwise provided in this title. Any structure designed, used, or maintained 159 primarily to be loaded on or affixed to a motor vehicle to provide a mobile dwelling, sleeping place, 160 office, or commercial space shall be considered a part of a motor vehicle. For the purposes of this title, 161 any device herein defined as a bicycle, electric personal assistive mobility device, electric power-assisted 162 bicycle, or moped shall be deemed not to be a motor vehicle.

163 "Motorcycle" means every motor vehicle designed to travel on not more than three wheels in contact 164 with the ground and is capable of traveling at speeds in excess of 35 miles per hour. The term 165 "motorcycle" does not include any "electric personal assistive mobility device," "electric power-assisted bicycle," "farm tractor," "golf cart," "moped," "motorized skateboard or scooter," "utility vehicle" or 166 "wheelchair or wheelchair conveyance" as defined in this section. 167

168 "Motorized skateboard or scooter" means every vehicle, regardless of the number of its wheels in 169 contact with the ground, that (i) has no seat, but is designed to be stood upon by the operator, (ii) has 170 no manufacturer-issued vehicle identification number, and (iii) is powered by an electric motor having an input of no more than 1,000 watts or a gasoline engine that displaces less than 36 cubic centimeters. The term "motorized skateboard or scooter" includes vehicles with or without handlebars, but does not 171 172 173 include "electric personal assistive mobility devices."

174 "Nonresident" means every person who is not domiciled in the Commonwealth, except: (i) any 175 foreign corporation that is authorized to do business in the Commonwealth by the State Corporation 176 Commission shall be a resident of the Commonwealth for the purpose of this title; in the case of 177 corporations incorporated in the Commonwealth but doing business outside the Commonwealth, only 178 such principal place of business or branches located within the Commonwealth shall be dealt with as 179 residents of the Commonwealth; (ii) a person who becomes engaged in a gainful occupation in the Commonwealth for a period exceeding 60 days shall be a resident for the purposes of this title except 180 for the purposes of Chapter 3 (§ 46.2-300 et seq.) of this title; (iii) a person, other than a nonresident 181

student as defined in this section, who has actually resided in the Commonwealth for a period of six
months, whether employed or not, or who has registered a motor vehicle, listing an address in the
Commonwealth in the application for registration shall be deemed a resident for the purposes of this
title, except for the purposes of the Virginia Commercial Driver's License Act (§ 46.2-341.1 et seq.).

186 "Nonresident student" means every nonresident person who is enrolled as a full-time student in an187 accredited institution of learning in the Commonwealth and who is not gainfully employed.

"Off-road motorcycle" means every motorcycle designed exclusively for off-road use by an individual
rider with not more than two wheels in contact with the ground. Except as otherwise provided in this
chapter, for the purposes of this chapter off-road motorcycles shall be deemed to be "motorcycles."

191 Operation or use for rent or for hire, for the transportation of passengers, or as a property carrier for compensation," and "business of transporting persons or property" mean any owner or operator of any motor vehicle, trailer, or semitrailer operating over the highways in the Commonwealth who accepts or 192 193 194 receives compensation for the service, directly or indirectly; but these terms do not mean a "truck 195 lessor" as defined in this section and do not include persons or businesses that receive compensation for 196 delivering a product that they themselves sell or produce, where a separate charge is made for delivery 197 of the product or the cost of delivery is included in the sale price of the product, but where the person 198 or business does not derive all or a substantial portion of its income from the transportation of persons 199 or property except as part of a sales transaction.

"Operator" or "driver" means every person who either (i) drives or is in actual physical control of a
 motor vehicle on a highway or (ii) is exercising control over or steering a vehicle being towed by a
 motor vehicle.

203 "Owner" means a person who holds the legal title to a vehicle; however, if a vehicle is the subject of 204 an agreement for its conditional sale or lease with the right of purchase on performance of the 205 conditions stated in the agreement and with an immediate right of possession vested in the conditional 206 vendee or lessee or if a mortgagor of a vehicle is entitled to possession, then the conditional vendee or lessee or mortgagor shall be the owner for the purpose of this title. In all such instances when the rent 207 208 paid by the lessee includes charges for services of any nature or when the lease does not provide that 209 title shall pass to the lessee on payment of the rent stipulated, the lessor shall be regarded as the owner 210 of the vehicle, and the vehicle shall be subject to such requirements of this title as are applicable to vehicles operated for compensation. A "truck lessor" as defined in this section shall be regarded as the 211 212 owner, and his vehicles shall be subject to such requirements of this title as are applicable to vehicles of 213 private carriers.

214 "Passenger car" means every motor vehicle other than a motorcycle designed and used primarily for215 the transportation of no more than 10 persons including the driver.

216 "Payment device" means any credit card as defined in 15 U.S.C. § 1602(k) or any "accepted card or other means of access" set forth in 15 U.S.C. § 1693a(1). For the purposes of this title, this definition shall also include a card that enables a person to pay for transactions through the use of value stored on the card itself.

220 "Pickup or panel truck" means every motor vehicle designed for the transportation of property and221 having a registered gross weight of 7,500 pounds or less.

222 "Private road or driveway" means every way in private ownership and used for vehicular travel by223 the owner and those having express or implied permission from the owner, but not by other persons.

"Reconstructed vehicle" means every vehicle of a type required to be registered under this title
 materially altered from its original construction by the removal, addition, or substitution of new or used
 essential parts.

"Residence district" means the territory contiguous to a highway, not comprising a business district,
where 75 percent or more of the property abutting such highway, on either side of the highway, for a
distance of 300 feet or more along the highway consists of land improved for dwelling purposes, or is
occupied by dwellings, or consists of land or buildings in use for business purposes, or consists of
territory zoned residential or territory in residential subdivisions created under Chapter 22 (§ 15.2-2200
et seq.) of Title 15.2.

"Revoke" or "revocation" means that the document or privilege revoked is not subject to renewal or
 restoration except through reapplication after the expiration of the period of revocation.

235 "Roadway" means that portion of a highway improved, designed, or ordinarily used for vehicular
236 travel, exclusive of the shoulder. A highway may include two or more roadways if divided by a physical
237 barrier or barriers or an unpaved area.

238 "Safety zone" means the area officially set apart within a roadway for the exclusive use of239 pedestrians and that is protected or is so marked or indicated by plainly visible signs.

"School bus" means any motor vehicle, other than a station wagon, automobile, truck, or commercial
bus, which is: (i) designed and used primarily for the transportation of pupils to and from public, private
or religious schools, or used for the transportation of the mentally or physically handicapped to and
from a sheltered workshop; (ii) painted yellow and bears the words "School Bus" in black letters of a

specified size on front and rear; and (iii) is equipped with warning devices prescribed in § 46.2-1090. A
yellow school bus may have a white roof provided such vehicle is painted in accordance with
regulations promulgated by the Department of Education.

247 "Semitrailer" means every vehicle of the trailer type so designed and used in conjunction with a
248 motor vehicle that some part of its own weight and that of its own load rests on or is carried by another
249 vehicle.

"Shared-use path" means a bikeway that is physically separated from motorized vehicular traffic by
an open space or barrier and is located either within the highway right-of-way or within a separate
right-of-way. Shared-use paths may also be used by pedestrians, skaters, users of wheel chairs or wheel
chair conveyances, joggers, and other nonmotorized users.

254 "Shoulder" means that part of a highway between the portion regularly traveled by vehicular traffic255 and the lateral curbline or ditch.

256 "Sidewalk" means the portion of a street between the curb lines, or the lateral lines of a roadway,257 and the adjacent property lines, intended for use by pedestrians.

"Snowmobile" means a self-propelled vehicle designed to travel on snow or ice, steered by skis or runners, and supported in whole or in part by one or more skis, belts, or cleats.

"Specially constructed vehicle" means any vehicle that was not originally constructed under a
 distinctive name, make, model, or type by a generally recognized manufacturer of vehicles and not a
 reconstructed vehicle as herein defined.

263 "Stinger-steered automobile or watercraft transporter" means an automobile or watercraft transporter
264 configured as a semitrailer combination wherein the fifth wheel is located on a drop frame behind and
265 below the rearmost axle of the power unit.

"Superintendent" means the Superintendent of the Department of State Police of the Commonwealth.
"Suspend" or "suspension" means that the document or privilege suspended has been temporarily
withdrawn, but may be reinstated following the period of suspension unless it has expired prior to the
end of the period of suspension.

"Tow truck" means a motor vehicle for hire (i) designed to lift, pull, or carry another vehicle by
means of a hoist or other mechanical apparatus and (ii) having a manufacturer's gross vehicle weight
rating of at least 10,000 pounds. "Tow truck" also includes vehicles designed with a ramp on wheels
and a hydraulic lift with a capacity to haul or tow another vehicle, commonly referred to as "rollbacks."
"Tow truck" does not include any "automobile or watercraft transporter," "stinger-steered automobile or
watercraft transporter," or "tractor truck" as those terms are defined in this section.

"Towing and recovery operator" means a person engaged in the business of (i) removing disabled
vehicles, parts of vehicles, their cargoes, and other objects to facilities for repair or safekeeping and (ii)
restoring to the highway or other location where they either can be operated or removed to other
locations for repair or safekeeping vehicles that have come to rest in places where they cannot be
operated.

281 "Toy vehicle" means any motorized or propellant-driven device that has no manufacturer-issued
282 vehicle identification number, that is designed or used to carry any person or persons, on any number
283 of wheels, bearings, glides, blades, runners, or a cushion of air. The term does not include, electric
284 personal assistive mobility devices, electric power-assisted bicycles, mopeds, or motorcycles, nor does it
285 include any nonmotorized or nonpropellant-driven devices such as bicycles, roller skates, or
286 skateboards.

287 "Tractor truck" means every motor vehicle designed and used primarily for drawing other vehicles288 and not so constructed as to carry a load other than a part of the load and weight of the vehicle attached289 thereto.

290 "Traffic infraction" means a violation of law punishable as provided in § 46.2-113, which is neither a291 felony nor a misdemeanor.

292 "Traffic lane" or "lane" means that portion of a roadway designed or designated to accommodate the293 forward movement of a single line of vehicles.

294 "Trailer" means every vehicle without motive power designed for carrying property or passengers295 wholly on its own structure and for being drawn by a motor vehicle, including manufactured homes.

296 "Truck" means every motor vehicle designed to transport property on its own structure independent297 of any other vehicle and having a registered gross weight in excess of 7,500 pounds.

298 "Truck lessor" means a person who holds the legal title to any motor vehicle, trailer, or semitrailer 299 that is the subject of a bona fide written lease for a term of one year or more to another person, 300 provided that: (i) neither the lessor nor the lessee is a common carrier by motor vehicle or restricted 301 common carrier by motor vehicle or contract carrier by motor vehicle as defined in § 46.2-2000; (ii) the 302 leased motor vehicle, trailer, or semitrailer is used exclusively for the transportation of property of the 303 lessee; (iii) the lessor is not employed in any capacity by the lessee; (iv) the operator of the leased 304 motor vehicle is a bona fide employee of the lessee and is not employed in any capacity by the lessor; 305 and (v) a true copy of the lease, verified by affidavit of the lessor, is filed with the Commissioner.

306 "Utility vehicle" means a motor vehicle that is (i) designed for off-road use, (ii) powered by an 307 engine of no more than 25 horsepower, and (iii) used for general maintenance, security, agricultural, or 308 horticultural purposes. "Utility vehicle" does not include all-terrain vehicles as defined in this section, 309 riding lawn mowers, or any other vehicle whose definition is included in this section.

310 "Vehicle" means every device in, on or by which any person or property is or may be transported or 311 drawn on a highway, except devices moved by human power or used exclusively on stationary rails or tracks. For the purposes of Chapter 8 (§ 46.2-800 et seq.) of this title, bicycles, electric personal 312 assistive mobility devices, electric power-assisted bicycles, and mopeds shall be vehicles while operated 313 314 on a highway.

315 "Wheel chair or wheel chair conveyance" means a chair or seat equipped with wheels, typically used to provide mobility for persons who, by reason of physical disability, are otherwise unable to move 316 317 about as pedestrians. The term includes both three-wheeled and four-wheeled devices. So long as it is operated only as provided in § 46.2-677, a self-propelled wheel chair or self-propelled wheel chair 318 319 conveyance shall not be considered a motor vehicle.

320 § 46.2-808. Commonwealth Transportation Board may prohibit certain uses of controlled access 321 highways; penalty.

A. The Commonwealth Transportation Board may, when necessary to promote safety, prohibit the 322 323 use of controlled access highways or any part thereof by any or all of the following:

324 1. Pedestrians.

325 2. Persons riding bicycles, electric power-assisted bicycles, motorized skateboards or scooters, electric 326 personal assistive mobility devices, or mopeds,

327 3. Animal-drawn vehicles,

4. Self-propelled machinery or equipment, and 328

5. Animals led, ridden or driven on the hoof.

330 B. The termini of any section of controlled access highways, use of which is restricted under the 331 provisions of this section, shall be clearly indicated by a conspicuous marker.

332 C. This section shall not apply to any vehicle or equipment owned or controlled by the Virginia 333 Department of Transportation, while actually engaged in the construction, reconstruction, or maintenance 334 of highways or to any vehicle or equipment for which a permit has been obtained for operation on such 335 highway.

336 Any person violating a restriction or prohibition imposed pursuant to this section shall be guilty of a 337 traffic infraction.

338 § 46.2-905. Riding bicycles, electric personal assistive mobility devices, electric power-assisted 339 bicycles, motor-driven cycles, and mopeds on roadways and bicycle paths.

340 Any person operating a bicycle, electric personal assistive mobility device, electric power-assisted 341 bicycle, motorized skateboard or scooter, or moped on a roadway at less than the normal speed of traffic 342 at the time and place under conditions then existing shall ride as close as safely practicable to the right curb or edge of the roadway, except under any of the following circumstances: 343 344

1. When overtaking and passing another vehicle proceeding in the same direction;

2. When preparing for a left turn at an intersection or into a private road or driveway;

3. When reasonably necessary to avoid conditions including, but not limited to, fixed or moving 346 347 objects, parked or moving vehicles, pedestrians, animals, surface hazards, or substandard width lanes that 348 make it unsafe to continue along the right curb or edge; 349

4. When avoiding riding in a lane that must turn or diverge to the right; and

350 5. When riding upon a one-way road or highway, a person may also ride as near the left-hand curb 351 or edge of such roadway as safely practicable.

For purposes of this section, a "substandard width lane" is a lane too narrow for a bicycle, electric 352 353 personal assistive mobility device, electric power-assisted bicycle, motorized skateboard or scooter, or 354 moped and another vehicle to pass safely side by side within the lane.

355 Persons riding bicycles, electric personal assistive mobility devices, motorized skateboards or scooters, or electric power-assisted bicycles on a highway shall not ride more than two abreast. Persons 356 357 riding two abreast shall not impede the normal and reasonable movement of traffic, shall move into a 358 single file formation as quickly as is practicable when being overtaken from the rear by a faster moving 359 vehicle, and, on a laned roadway, shall ride in a single lane.

Notwithstanding any other provision of law to the contrary, the Department of Conservation and 360 Recreation shall permit the operation of electric personal assistive mobility devices on any bicycle path 361 or trail designated by the Department for such use. 362

§ 46.2-906. Carrying articles or passengers on bicycles, electric personal assistive mobility devices, 363 electric power-assisted bicycles, and mopeds. 364

365 No person operating a bicycle, electric personal assistive mobility device, electric power-assisted bicycle, motorized skateboard or scooter, or moped on a highway shall carry any package, bundle, or 366

**367** article that prevents the driver from keeping at least one hand on the handlebars.

No bicycle, or moped, or motorized skateboard or scooter shall be used to carry more persons at one time than the number of persons for which it was designed or is equipped, except that an adult bicycle rider may carry a child less than six years old if such child is securely attached to the bicycle in a seat or trailer designed for carrying children.

§ 46.2-906.1. Local ordinances may require riders of bicycles, electric personal assistive mobility
 devices, and electric power-assisted bicycles to wear helmets.

The governing body of any county, city or town may, by ordinance, provide that every person 14 years of age or younger shall wear a protective helmet that at least meets the Consumer Product Safety Commission standard whenever riding or being carried on a bicycle, an electric personal assistive mobility device, a motorized skateboard or scooter toy vehicle, or an electric power-assisted bicycle on any highway as defined in § 46.2-100, sidewalk, or public bicycle path.

379 Violation of any such ordinance shall be punishable by a fine of \$25. However, such fine shall be suspended (i) for first-time violators and (ii) for violators who, subsequent to the violation but prior to imposition of the fine, purchase helmets of the type required by the ordinance.

Violation of any such ordinance shall not constitute negligence, or assumption of risk, be considered
in mitigation of damages of whatever nature, be admissible in evidence, or be the subject of comment
by counsel in any action for the recovery of damages arising out of the operation of any bicycle, electric
personal assistive mobility device, motorized skateboard or scooter toy vehicle, or electric power-assisted
bicycle, nor shall anything in this section change any existing law, rule, or procedure pertaining to any
civil action.

388 § 46.2-908.1. Electric personal assistive mobility devices, electrically powered toy vehicle, and389 electric power-assisted bicycles.

All electric personal assistive mobility devices, motorized skateboards or scooters electrically powered toy vehicles, and electric power-assisted bicycles shall be equipped with spill-proof, sealed, or gel batteries. No person shall at any time or at any location drive an electric personal assistive mobility device, a motorized skateboard or scooter, or an electric power-assisted bicycle faster than twenty-five miles per hour. No person less than fourteen years old shall drive any electric personal assistive mobility device, motorized skateboard or scooter, or electric power-assisted bicycle unless under the immediate supervision of a person who is at least eighteen years old.

397 An electric personal assistive mobility device or motorized skateboard or scooter may be operated on 398 any highway with a maximum speed limit of twenty-five miles per hour or less. An electric personal 399 assistive mobility device or motorized skateboard or scooter shall only operate on any highway 400 authorized by this section if a sidewalk is not provided along such highway or if operation of the 401 electric personal assistive mobility device or motorized skateboard or scooter on such sidewalk is 402 prohibited pursuant to § 46.2-904. Nothing in this section shall prohibit the operation of an electric 403 personal assistive mobility device or motorized skateboard or scooter in the crosswalk of any highway 404 where the use of such crosswalk is authorized for pedestrians, bicycles, or electric power-assisted 405 bicycles.

406 § 46.2-932. Playing on highways; use of toy vehicle on highways, persons riding bicycles, electric
407 personal assistive mobility devices, electric power-assisted bicycles, mopeds, etc., not to attach to
408 vehicles; exception.

409 A. No person shall play on a highway, other than on the sidewalks thereof, within a city or town or **410** on any part of a highway outside the limits of a city or town designated by the Commonwealth 411 Transportation Commissioner exclusively for vehicular travel. [No person shall use] roller skates, 412 skateboards, toys, or other devices on wheels or runners, except bicycles, electric personal assistive mobility devices, electric power-assisted bicycles, motorized skateboards or scooters, mopeds, and 413 motorcycles, any toy vehicle on highways within any city or town or on any other highway where play 414 415 is prohibited by this section. No person shall use any toy vehicle on the roadway of any highway that (i)416 has a speed limit greater than 25 miles per hour, (ii) has more than two travel lanes, or (iii) is located outside a residence district as defined in § 46.2-100. ] The governing bodies of counties, cities, and 417 418 towns may designate areas on highways under their control where play is permitted and may impose reasonable restrictions on play on such highways. [ If the highways have only two traffic lanes, persons 419 420 Persons ] using such devices, except bicycles, electric personal assistive mobility devices, electric power-assisted bicycles, mopeds, and motorcycles, shall keep as near as safely practicable to the far 421 422 right side or edge of the right traffic lane so that they will be proceeding in the same direction as other 423 traffic.

424 No person riding on any bicycle, electric personal assistive mobility device, electric power-assisted
425 bicycle, moped, roller skates, skateboards, motorized skateboards or scooters, toys, or other devices on
426 wheels or runners, shall attach the same or himself to any vehicle on a roadway highway.

427 B. Notwithstanding the provisions of subsection A of this section, the governing body of any county

- having a population of at least 170,000 but less than 200,000 may by ordinance permit the use of devices on wheels or runners on highways under such county's control, subject to such limitations and conditions as the governing body may deem necessary and reasonable. 428 429
